ALEXANDER JEMISON OF KENT COUNTY, MARYLAND

[20900-21399]

20900-1 ALEXANDER JEMISON, was born about the year 1700. He died February of 1756 in Kent co., MD. Mr. Jamison married circa 1728-30, in Maryland to Jennett _____, who died December of 1760 in Kent county, Delaware. They resided in Kent co., Maryland until Alexander's death and Mrs. Jamison removed with her family to Kent county, Delaware.

Notes:

A lack of records make comprehension of the Jamesons along the western shores of the Chesapeake a variable playground of speculation. While discussion of Alexander Jemmeson of Somerset co. goes forth, no actual connection can be established between him and Alexander Jamison of Kent co., MD. Since this means anything but easy in genealogy, the onus is on research and the ever widening backward push into fewer and fewer documents. No emigration records thus far viewed record Alexander coming to the colonies between 1725 to the time of his death. In fact no records have been located to place him before the time of his death. These two important statements provide a confused state of affairs: on the one hand the former permits

speculation that Alexander “might” have sailed to American shores; and the latter tells us that he may have been born here. One other possibility provides a thought: could Alexander have been the son of Alexander of Somerset county, MD?

Why records have not been found for him prior to his death and the probating of the will makes the chase difficult. Alexander’s son, Andrew is listed in the 1766-68 rent rolls for Kent co., MD after his father’s death, which makes their migration to Kent co., Delaware considerably after Alexander’s death? Yet shortly after the administration of his estate March 17, 1756, Jennett and her son, Andrew Jemmeson, purchased September 4, 1756 from Howell and Mercy (**Green**) **Buckingham** for 200 pounds a 275 acre tract in Duck Creek Hundred, a part of the Foxhall Tract in Kent co., DE. Oddly enough, it adjoins lands to John **Rees** and Owen **David** on Gravelly Run. John Rees may be the grandfather of Jehu Reese whose daughter, Rebecca, married Samuel Jameson(35012). Samuel Jameson’s father, Benjamin Jameson(35000) was from Loudon county, Virginia, and he may have been related to Robert Jameson of that same county. Could Robert have been related to Rev. Robert Jemson of Duck Creek Hundred? A hundred questions and proportionately a thousand different answers.

When Alexander died his administration bond was in common formed by Jennatt and Andrew Jamison with Nathaniel **Rodding** and John **Ware** of Kent co., DE, their suroths in the sum of 500 pounds sterling, 3/17/1756.

Mrs. Jamison’s will was executed August 28, 1759 and probated on January 9, 1761 in Kent co., DE. Andrew was appointed executor of her will and left with the main bulk of the estate while brothers, Joseph and Joshua, each received 25 pounds, Thomas 30 pounds, and Alexander, one cow, with sisters Rebecca Hull receiving a dress, and Jennett, a daughter of Alexander, receiving 10 pounds, and to Ann Hutson, one dress and quilt.

- Joshua Jemison was a saddler*([1](#)) in Smyrna, DE., near the New Castle border; he’d purchased land there on July 25, 1769; he later sold these 32 square perches at the crossroads of Smyrna to his brother, Thomas Jemison, yeoman for 250 pounds; in the militia from New Castle co., a member of the Christena Company under Capt. **Reed**, Lower district, Clay Creek 100 on October 31, 1778 to October 24, 1779; he married Ann **Caldwell** in New Town Castle, DE.

20920-2 ANDREW JEMISON [Alexander], was born 1728 probably in Kent co., MD. the son and first child of Alexander and Jannet Jamison(20900). He died in October of 1789 in Kent co., DE. Mr. Jamison married first, circa 1763-68, Mary **Little**, b.c. 1730s, died circa 1776/7 in Kent co., DE., the daughter of Robert Little. Mr. Jamison married second, circa 1778, Kent co., DE., Mrs. Jane (**Farson**) **Spruance**, daughter of Henry and Mary (**Hale**) Farson, and widow of Mr. John Spruance, son of John and Mary (**Barratt**) Spruance. Andrew Jamison and his family resided in Kent co., Maryland and in Duck Creek Hundred, Kent co., Delaware.

Notes:

Not much is known of Andrew's stay in Kent co., MD., though on January 5, 1752 he had a farm of 150 acres called according to the reference, "His Lordship's Manor". This may in fact actually be a rented property from His Lordships Manor as described in later rent rolls for 1766-68. In 1766 in Ann Arundel Manor, land held in Kent co., by William **Maxwell**, age 47, a son of Robert Maxwell, and Andrew Jemeson, age 30. This lot was left by a will from Anthony **Camron** to John Maxwell in a Lease issued June 5, 1742 as tenant in possession of 130 acres (lot #41). Annual rent was listed at 0.13.0. Why this relationship existed in 1766, when he and his mother had purchased the lot in Duck Creek Hundred in late 1756 after his father's death is unknown, unless Jennett was related to Camron. Since the lot was left by will from Camron to Maxwell, it is possible that Andrew and William Maxwell actually owned the land in partnership, Maxwell having procured the lot from his father, Robert, and Andrew, in some way having been sold or given, perhaps by will, also, from Robert Maxwell, half ownership in the land.

With the death of his father, Alexander, Andrew and his mother left Kent co., Maryland for Duck Creek Hundred, Kent county, Delaware. He became a wealthy planter with nearly a thousand acres of land which he bequeath to his children upon his death. One lot he sold August 10, 1773, mentions his wife, Mary. On May 13, 1775 he signed the Articles of Association then in effect to display his legal loyalty to the United States of America. He enlisted into Captain Charles **Pope***⁽²⁾ of the militia. On August 10, 1781, he purchased the 243 acre farm of his father-in-law, Robert Little, which Andrew conveyed to his three sons along with 957 additional acres on August 7, 1786, the land situated in Duck Creek Hundred. On September 6, 1787 Andrew and his wife, Jane, conveyed land which reverted back to them on the following day as part of Henry Farson's estate to Jane Spruance, his daughter.

Letters of Administration were granted November 2, 1789 to Dr. Robert Jamison of Dover, his son, and Henry Farson, his brother-in-law. Mr. Farson was appointed the guardian of Ann Jamison, his niece; Robert Jamison became the guardian of George and Thomas, minors, November 23, 1790.

- Thomas Jamison (20951), was born circa 1774, Kent co., DE., and died in June of 1812. His will was dated April 28, 1812, and probated June 18, 1812. He died without issue devising his property to his brother's, Robert's, son, Thomas, and to his sister's Ann's, children.

- George Little Jamison (20952), was born circa 1786 and died before his majority. His estate was administered by his father and equally divided between his brothers, Thomas and Robert.

20921-2 THOMAS JEMISON [Alexander], was born circa 1729, possibly in Kent co., MD., the son and second child of Alexander and Jennett Jamison(20900). He died probably in St. George's Hundred, Kent co., DE. prior to 1820. Mr. Jamison married circa 1750, Kent co., DE. to Catherine **Anderson**, b.c. 1733 in Delaware. They resided and died in Duck Creek Hundred, Kent co., Delaware.

Notes:

Mr. Jamison was a farmer in Duck Creek Hundred. He married Catherine Anderson, a sister of James Anderson whose will was dated September 1, 1777, in New Castle county and probated August 19, 1785 in New Castle co. He names brother, Samuel, sister, Catherine Jameson, Mary, Hester, and brothers Matthew and Joseph. Executor was brother-in-law, Thomas Jameson. On January 25, 1773 Thomas, Yeoman, purchased a lot near Smyrna from his brother, Joshua, Saddler. This land was later sold February 16, 1775 situated at the Crossroads. Some of Mr. Jemison's children may be the ones listed under the Gendexes, 22800 and 23000. He died in January of 1786 in Duck Creek Hundred, Kent co., DE. Mr. Jamison married circa 1757, Kent co., DE., Mary _____. They resided in Duck Creek co.

Notes:

Mr. Jemison was a farmer who made his home in Duck Creek Hundred, Kent co., DE. He died relatively young leaving his wife a widow with six children. Mrs. Jemison and her son, Alexander Jemison Jr., administered January 25, 1786 the estate and she later, May 13, 1796, sold her rights of Dower in her husband's farm and went with her youngest son and his family to Fayette co., PA. Joshua later removed to Wayne co., OH. where he died in 1826, but of his mother, Mrs. Mary Jemison, her death and burial are unknown currently. In 1796, John **Farson**, a brother Mrs. Andrew (Ann) Farson Jemison, was appointed Alexander Jemison Jr.'s legal guardian. David **Kennedy**, William **Denny**, and George **Cummings**, freeholders, were appointed to inventory Alexander Jemison's 107 acre estate. On July 26 they appeared at Orphan's court with a value of 309 pounds. It appears from court papers in the case that John Farson refused the court's evaluation and subsequently Robert Jemison(20950) and a friend, James **Tibbett**, as security for Joshua Jemison, Alexander Jemison Sr.'s other son, paid a total of 999 pounds and 7 pence for the property on July 29, 1796. Some time between May and July of that year Joshua, his family, and his mother removed to Fayette co., PA. and Robert Little Jemison acted on Joshua's behalf.

During the Revolutionary War, Mr. Jemison served from the end of November 1779 to the end of February the following year in the Continental Wagon Brigade commanded by Colonel Francis **Wade** to transport food and supplies and horses to the army regulars.

- Janett Jemison, (21000) was mentioned in her grandmother's will;

- Mary Jemison Edenfield conveyed part of her father's estate she received to her brother, Joshua October 25, 1787.

20950-3 ROBERT LITTLE JEMISON [Andrew, Alexander], was born circa 1770, in Duck Creek Hundred, Kent co., DE., the son and first child of Andrew and Mary (Little) Jemison(20920). He died in 1821. Mr. Jemison married Mary **Hale**, born about 1765 in Symrna, Delaware, died prior to June 1811, Duck Creek Hundred, DE., the daughter of Thomas and Sarah Hale.

Notes:

Mr. Jemison led an active, full life. He was a member of the Delaware State Medical Society in 1790 and spent much of his career as a physician in and around Little Creek Hundred, Kent co., DE. Dr. Jemison died intestate and his son, Thomas, was given letters of administration March 28, 1821. His plantation consisted of 280 acres in Little Creek Hundred, 675 acres in Murderkill Hundred, and some 400 acres in Duck Creek Hundred. When his father died, Robert became the guardian of his brothers, Thomas, and George Little Jemison, appointed November 23, 1790. A humanitarian of sorts, Dr. Jemison freed his only slave, George **Hull** on December 29, 1800.

Mrs. Mary Jemison was the daughter of Thomas(d. 1811/12, Murderkill, Kent co., DE.) and Sarah () (d. prior to 1811, Kent co., DE.) Hale of Symrna, Kent co., DE. Little is known of Thomas Hale and his ancestry, though accounts as shown in ref. 1 point to a Baltimore, Maryland heritage. Henry **Haile** married September 10, 1741, Baltimore, MD., Mary **Bradley**. They had the son, Thomas Haile, born October 19, 1742, who may or may not be the one who married Sarah and resided in Kent co., DE. Henry Haile(b. 3/25/1721, Baltimore, MD.) was the son of Nicholas and Frances Haile. Henry Haile removed to Harford co., MD. and it can only be surmised that his son, Thomas, may be the one who met the Jemisons in nearby Cecil and Kent counties, MD. and migrated to Kent co., Delaware. Notes:

Mr. Jamison migrated from Delaware to Maryland, where he was a slave driver for three months, between 1790 to 1795 and settled first in Georges, Fayette co., PA. where he was an owner of an inn and tavern. Mr. & Mrs. Jamison attended the Tent Presbyterian Church in Georges where her father was buried in the church graveyard. In 1817, Joshua Jamison, going ahead of the family, took a bot out of Pittsburgh and sailing down the Ohio made for Marietta, Wayne co., OH. Shortly after this, Mrs. Jamison secured a horse and set off with another party, leaving the children at home, and arriving in Wayne co., OH with \$400.00 in gold strapped around her waist. This wealth was procured from the sale of their homestead in Georges, PA and was used in the purchased from the Government land agent in Ohio for the north half of section 31 in Sugar Creek of 320 acres. With the land deal completed Mrs. Jamison returned to Georges where two months later she gave birth to her son, Isaac. In 1818, the entire family left Fayette co., PA. and settled permantently in Wayne co., Ohio. When they first arrived they settled in with Emanuel **Brown** until their new home was completed.

The Mackays were in Georges, Fayette co., PA. as early as 1787, when Rebecca's father, Stephen, was a property owner at that time. They were originally from Montgomery, Franklin co., PA and came to Pennsylvania in 1785.

Notes:

Mr. Jamison was a physician and with his family migrated between 1828 to 1830 to Franklin co., IN. where he took up farming. Later, he settled circa 1839 in Richmond, Wayne co., IN. where presumably he died some time after 1848 and before 1870.

Rebecca B. Green comes from a prominent line of the family that descends from Thomas **Green** the first Proprietary Governor of that state and friend of Leonard **Calvert** who appointed him. When Calvert's will was probated in 1644 mentioned was his godson, Leonard Green. Thomas Green was Governor from 1647-49, and had four sons: Thomas, Robert, Leonard, and Francis, the latter three having patented a large tract of land in Charles co., MD. known as "Green's Inheritance". Francis Green had the son, Leonard(d. 1733), who married Mary **Sewell**, a sister of Cuthbert Sewell who died in 1723. Leonard and Mary Green had five known children: Leonard(d. 1755), Cuthbert, John, Francis, and Robert. Leonard Green Jr. had Leonard III, Robert, Martha, and Mary Ann Sewell Green. From this line Ann and Dr. Cuthbert Sewell Green were born, they being siblings. Ann married John **Rees** (of Little Creek Hundred, Kent co., DE.) and had the son, Thomas who married Elizabeth S. _____; C. S. Green (b.1759, d. 1833DE) married Ann **Massey**(d. 1830), daughter of Joseph and Rebecca Massey. From the latter marriage were born Rebecca(d. 1839, m. Thomas Jamison), Ann(b. 1789, d. 1866), and Cuthbert Sewell Green.

Thomas and Rebecca Jamison petitioned the court for a division in her father's estate which contained 350 acres in Appoquinimink Hundred and concluded in giving them the tract as called for. Cuthbert Green Jr. was

a physician, died in 1843. He married Natalie **Boden** (b. 1819; d. 1854) and they resided in St. George's Hundred, New Castle co., DE.
