**21400-1 UNKNOWN JAMESON**, born, probably in England in nearby Lancashire. Married.

#### Notes:

All these Jamesons with the exception of John Jameson tie in via Maryland wills which state the relationships among them. How they may tie in with the other Jamesons as earlier mentioned\*(1) is not established at this point. The Jameson family appears to have its genealogy and history based in England.

- Anne Jameson, born about 1668, probably in England appears never to have married. Will dated March 1, 1724, probated March 1, 1724 in St. Mary's county, Maryland.
- "In the name of God Amen the 3rd day of February in the year of our Lord God 1724 I Anne Jameson of Chapticoe Forest in St. Mary's county in the province of Maryland being very sick and weake in body but of perfect mind and memory.....I devise and dispose of the same in this following manner and forme...."
- To Margaret and Susannah, daughters of brother William Jameson, executor, to wife of brother, William Jameson, to Anne **Buckmon**, to Elizabeth **Simms**, to Elizabeth **Donell**, to Thomas **Chamberlain**, to Henry Jameson, to Charles **Matinglee**, to Giles **Leill**, to Robert **Whitely**, and to brother, Thomas Jameson, personalty.

- John Jameson, d. 1717 in St. Mary's co., MD. His household goods were valued at 26 pounds, 5 Shillings, the inventoried testated by Thomas Jameson and Benjamin **Eden**, March 18, 1717. Additionally, Thomas Jameson was the administrator of John Jameson's estate with payment going to William Jameson October 29, 1717. Thomas Jameson made an extra account May 9, 1719 on the Goods and Chattels of John Jameson. Mr. Jameson could have been one of three possibilities: a son, a brother, or possibly Thomas' father. No other records have come to light to clear the identity of this man.

**21405-2 THOMAS JAMESON** [Unknown], was born circa 1665, possibly in Lancashire, England. He died in March of 1734, Charles county, Maryland. Mr. Jameson married about 1700, Charles co., MD. Mary **Doyne**, died 1755[7], Charles co., MD., the daughter of Joshua and Barbara[7] Doyne.

#### Notes:

Thomas Jameson's origins are decidedly confused. His earliest appearance may have been September 14, 1684 in the proprietery of St. Denis als Edmondsbury, which lays upon the northern section of Baltimore county. On the rent rolls for this period this Thomas Jamison rented 500 acres from Edmond **Dennis**, possessor of the land, at Sargents Hall. Annual rent amounted to one (1) pound. The farm land was/is situated at the headwaters of Gunpowder Run on the south side of the south west branch "at a bounded popular tree" south of York county, PA. some miles. Possible that this man may be related to any number of Jamisons then in residence in York county, PA. or even to William Jameson who emigrated to the American colonies in 1679 and may be the one in Talbot co., Md. At about the same time.

Did he emigrate? Maybe. Research conducted by Mrs. Donald **Toso**\*(2) indicates that Mr. Jameson was from

Lancashire, England, the eldest and heir apparent of the family fortune which "consisted of extensive coal mines and landed property"\*(3). Dispositions made by Mrs. Jameson's sister, Jane **Wharton** \*(4), apparently provide evidence of his travels to and from England in his quest for this legacy\*(5)\*(6)

(copy of written disposition[7]). No such emigration documents discovered so far prove this. Additional legalities by his sister also supposedly shows that Thomas' grandson, Henry Joshua Jameson,\*(7) also went to England to make a claim, but apparently died there failing to resolve the long standing conflicts.

Just when Thomas Jameson, Gentleman, migrated to Charles county is unknown. The earliest surviving record shows he was there in 1697, a testator for the will of James **Pattison**, dated September 23, 1697, and proved April 1, 1698. A 1699 document reads, "Thomas Jamieson, whose wife was widow and executrix of Ignatius Matthews, Charles county, 1699". An earlier item states, "Ignatius **Matthews** married Mary Doyne, daughter of Joshua Doyne of Charles county". One further document reads in part, "...Estate of Thomas Ignatius Matthews, late of Charles County, deceased, by Thomas Jameson, who married the widow of the deceased[7]." Mr. Matthews died in 1698, Charles co., MD.

#### Other records:

Purchased a rebel servant from the ship, Goodspeed, October 26, 1716[7c].

Will of John Jameson dated March 18, 1716-17, St. Mary's county witnessed by Benjamin **Eden** and Thomas Jameson. No relationship mentioned.

Will of Winifred **Lee**(nunc), dated December 7, 1719, Charles county, "Child.(unnamed) to care of Thomas Jameson, who is to receive personal estate of testator and her husband and retain same until children are of age to receive their portions. Children are to be brought up Roman Catholic(courts allowing). Testator-Ann **Heatheof**.

Testator for Oswald **Haskins** of Charles county was Thomas Jameson. Haskin's will was dated January 14, 1720 and probated September 6, 1721.

Will of Anne Jameson of Chapticoe Forest, St. Mary's county, MD. dated February 3, 1724 and probated March 1, 1724. Mentions brothers Thomas and William. She names Henry Jameson, but does not include the word, brother, leaving us to determine just who he was.

Deed of October 2, 1724, Charles co., Md., from Thomas Jameson to Marsham Queen, 300 acres for 36 £ land around Mile Dam; witn. Geo. Dent, Chas. Somrsett Smith.

Mr. Jameson owned a sprawling tobacco plantation called Spring Run. A mill was built on it later and the property is situated along Mill Run which empties into the Potomac. He also purchased from Thomas **Mudd** Halls's Place, 450 acres, dated September 26, 1703. Mudd acquired from William **Boarman** through his daughter, Sarah (Boarman) Mudd, mother of Thomas Mudd, a gift of land called Hall's Place. No records to date provide any date of death for Mrs. Jameson though it was after Thomas' death. Mr. Jameson's will was dated November 17, 1733 and probated April 6, 1734 in Charles county and reads as follows:

"To son Thomas, during life, all those parts of the several tracts following, viz.: "Hall's Place", "The Addition", "Jarvis", "Preston", and "Queen Mary", not heretofore sold and hereafter mentioned to young. sons to whom it is disposed of, and after decease of sd. son Thomas all afsd. lands (300 A.) to be divided between his two sons John and Thomas and their hrs.; and 20 s.

To wife of son Thomas (unnamed), and every one of her child., personalty; and to child. of son Thomas 25 s.

each to pay for 1 yr.'s schooling.

To son Benjamin and hrs., all those parts of tracts following, viz.: "Hall's Lot", "Hall's Place", "Jarvis", and "The Addition" lying between dwelling house, Spring branch and the land formerly given to deceased son Henry Joshua Jameson(abt. 300 acres).

To son Joseph and hrs. all those parts of the tracts following, viz.: "Hall's Lot", "Indian Fields", on both sides of Mill Run, "Hall's Place", "The Addition", and "Jarvis", being of the Mannor contents which lieth between Mill Run and dwelling house, "Spring Run".

To Henry and Richard, sons of deceased son Henry Joshua, personalty, including 25 s. for one yr.'s schooling.

To daughter Mary **Queen** and to each of her child., son-in-law Marsham Queen, daughter Martha **Matthews** and to each of her child., son-in-law Luke Matthews, daughters Elizabeth and Ann, personalty.

To wife Mary and four child. now with testator, viz.: Benjamin, Joseph, Elizabeth, and Ann, entire personal estate.

Executors: Marsham Queen and Luke Matthews.

Testators: Thomas Leckonby, Samuel Chunn, Martha Matthews.

On April 6, 1734, widow claims her thirds.

Mrs. Jameson made her will May 28, 1755, Charles co., MD., which was probated December 20, 1755[7d]. To son, Thomas, 3500 lbs of tobacco; mentions sons, Joseph and Benjamin, and daughters Mary Queen, Elizabeth Jameson, Martha Matthews, Ann Spalding; grand daughters, Mary Spalding and Mary Jameson and grandson Henry Spalding. The plantation went to daughter Mary Queen. Her executors were Marsham Queen and Benjamin Jameson. Mrs, Jameson's brother, Edward Doyne, made out his will July 6, 1748 which was probated August of 1748. The following are mentioned: brother, Ignatious Doyne, Ignatious **Spalding**, Thomas Jameson, Robert **Brent**, sisters, Mary <u>Jameson</u>, Sophia Doyne. Mrs. Jameson also had sister's, Jane Wharton, and Mary **Matthews**[7].

- Elizabeth Jameson, made her will September 22, 1765, proved July 12, 1766, Charles co., MD.[7e]; mentions sisters, Mary Queen, Martha Matthews, and Ann Spalding, borthers Joseph and Benjamin Jameson; William **Queen**, nephew, a horse; niece, Elizabeth Jameson, dau. of Joseph, a cow; to brother, Thomas Jameson's five children, personalty; to Eleanor, dau. of Thomas Jameson, brother, personalty; executors, brother, Benjamin Jameson and William Queen.

**21406-2 MARY JAMESON** [Unknown], was born about 1666, Lancashire, England? the daughter of a wealthy planter and industrialist. She died February 12, 1741-2 in St. Mary's county, Maryland. Miss Jameson married Mr. **Barber**. They resided in St. Mary's county.

Mrs. Barber's will was dated February 12, 1741-2 and proved June 2, 1742 in St. Mary's County. She mentions: "To son Thomas Barber and hrs.(heirs), land testator bought from Benjamin **Sally**. To grandson Bennett **Taylor**, personalty. To sons Thomas and John Barber, executors., residue of estate with the exception of 6 shilling to rest of children. Test: Edward Aloylius **Doyne**, Thomas **Milton**, Thomas **Price**."

**21408-2 WILLIAM JAMESON** [Unknown], was born circa 1670, possibly in England. He was married and resided in Talbot and St. Mary's counties in Maryland.

#### Notes:

Mr. Jameson was sole executor of his sister, Anne's, will dated February 3, 1724 and proved in the following month. His daughters benefited from their aunt's will receiving several negroe girl slaves while William's wife, no name given, received a "piece of cordet, Dimety, Cloaths, and a cotton Quilt, and a Huckaback". Mr. Jameson's name does not appear often in the records, but of one note for November 3, 1711 indicates that he came to court voluntarily indentured to Thomas **Sympson**{Simpson} "for 3 years in consideration that the said Simpson will pay the doctor for caring, having distemper(yaws) in which he, William, lanquished".


## Notes:

Thomas Jameson Jr. rec'd from father's will in 1733: "Hall's Place", "The Addition", "Jarvis", "Preston", and "Queen Mary", or about 300 acres in all and the preceding going to son, Thomas' children, John and Thomas, upon Thomas' Jr. death. He also gave to Frances Jameson and also 25 shillings to each of her children for 1 year's schooling.\*(8) Mr. Jameson's will was probated June 15, 1759, Charles co., MD. On June 10, 1755[3a], Mr. Jameson requests for a "rebound" of Hall's Place and part of George's Rest which his father, Thomas Sr. purchased from Thomas **Mudd** of Charles co., MD, March 2, 1710[4].

His will was dated September 9, 1758 and proved June 15, 1759. He mentions sons, Thomas, Henry Joshua, and William Jameson in which he leaves his land to-Hall's Place and The Addition; wife, Frances, daughters, Eleanor and Elizabeth; executors: Henry Joshua Jameson, Frances Jameson.

- Thomas III was bequeathed Hall's Place and the Addition consisting of 150 acres plus. He left this to his brother, William Jameson, in 1786. He bequeathed to brother, Henry Joshua Jameson, 150 acres of Hall's Place, along with parts of Jarvis and the Addition, lands which were equally divided by their father[3b].
- William died 10/4/1795 leaving to his only surviving brother the legacy of England in the coal mines and landed estates there[3].
- Henry Joshua was the legitimate heir through Thomas II and Thomas I. In a disposition by Ann **Burch**, age 78[3c], states she's known Henry from birth and he is the only surviving male son of Thomas and Frances Jameson. She mentions also that Henry sailed to England to claim these lands and that he died there. William **Queen**, age 70, \*(9) states also that he knew Henry from infancy, knew him as the surviving heir, and had sailed in 1758 to England to obtain the estates there. Henry J. Jameson in his disposition of 1796 names his friend, Francis **Newman**, attorney at law to obtain the estates in Lancashire and the coal mines in Wigan, Lancashire county, England. The lands were leased to John **Hayes** by Thomas Jameson I. Mr. Jameson d. in 1807, leaving sisters only and Hall's Place which was deeded to Raphael Jameson, son of Benjamin, by his

**21421-3 HENRY JOSHUA JAMESON** [Thomas, \_\_\_\_\_], was born 1702, Charles co., MD. the son and second child of Thomas and Mary (Doyne) Jameson(21405). He died in the latter part of 1733 in Charles co., MD. Mr. Jameson married in Charles co., MD. Elizabeth \_\_\_\_\_, who died prior to 1790, Charles co., MD.

#### Notes:

Having died before his father, Henry's two sons, Henry Joshua and Richard Jameson, rec'd their rightful inheritance from their grandfather. Some of the estate personalty was passed on to the boys as well as 25 shillings each for one year's schooling. This fairly well documents that they were quite young at the time and probably the only two children Henry and Elizabeth Jameson gave life to. The will of Thomas Jameson also provides support that Henry's son, Henry Joshua Jameson, was born not in 1743 as the gravestone suggests, but rather ten years earlier and just before his father's death.

Mr. Jameson's will was dated August 30, 1733 and probated November 6, 1733 in Charles county. He names wife, Elizabeth, as executrix, and sons, Henry and Richard, who received the plantation which consisted of parts of Hall's Lott and Hall's Place. Witnesses were: Alexander **Adair**{Adear}, Marsham **Queen**, and John **Boone**. Mr. Jameson was mentioned in the will of Anne Jameson February 3, 1724.

**21422-3 MARY JAMESON** [Thomas, \_\_\_\_\_], was born circa 1705, Charles co., MD. the daughter and third child of Thomas and Mary (Doyne) Jameson(21405). Miss Jameson married about 1728/9, Charles co., MD., Marsham **Queen**, who died in 1771 Charles co., MD, and was the son of Samuel and Katherine (**Marsham**) Queen. They had eleven children.

Mr. and Mrs. Queen resided in Charles co., MD. Marsham was co-executor of his father-in-law's will, dated November 17, 1733, and probated April 6, 1734. Each of their children received some personalty from Thomas Jameson. Mr. Queen was a witness to Henry Joshua Jameson's will dated August 30, 1733 and probated November 6 of that year. Mr. Queen was a private during the Revolutionary War and issued his pension March 13, 1832 #106, West shore of Charles co., MD. during his life, half yearly, half pay.

The Queen ancestry dates to Samuel Queen who emigrated to Maryland circa 1685. He died in St. Mary's County, Md. In 1711. He married Katherine Marsham a daughter of Richard. Their children were: Samuel, d. 1734; m. Sarah **Edelin**; Marsham; William; Katherine; and Margaret. His son, Marsham Queen married Mary Jameson about 1730. Richard Queen (1) married and his son, Charles Jenningham Queen had two children, Ellen and Henry Queen. The Marsham's were founded by Richard Marsham who came to the colonies in 1658. He died in Prince George co., Md. In 1713. He married, first, Katherine **Brent**, and second, Ann **Calvert**, dau. Of Gov. Leonard Calvert. They had two children: Sarah, who married 1) Basil **Waring**, 2) William **Barton**, and 3) Rev. James **Haddock**; and Katherine, m1) Baker **Brooke**, and 2) Samuel Queen, above.

Mr. Queen made his will August 8, 1771 and probated October 28, 1771. He provides for his daughters use of the house and land as long as they remain single. To son, William Queen, all the land his father owned in Charles co., incld. Bolling Reserve, Boarmans Manner, and Muds Deed (from Thomas Jameson); to son Richard Queen, 150 acres in Prince William co., part of Bells inclosure; to daughter Mary Queen, one Negro woman, Negro boy, and the case of "drares" and a looking glass; to daughter Margret Queen, one Negro woman, and one Negro boy; to daughter Clementana, Negro woman and boy; to daughter Eliz Queen Negro woman and boy; to son Samuel Queen, 1000 £ of tobacco; to daughter Ann Simms, Negro girl; to daughter Catherine Bowling Negro woman; to son Frances Queen, remainder of Bells Inclosure, Negro man and girl; to daughter Sarah Queen, Negro man and girl; remainder of furniture, stock, etc. equally divided between William Queen, Mary Queen, Clementana Queen, Frances Queen, Eliz Queen and Sarah Queen; son William

Queen, executor; witnesses: Paul Parker, William Boarman Jr., John Jameson.

On December 15, 1753, Marsham **Queen** sold to Benjamin Jameson a tract called Hall's Lott for 5 shillings.

Joseph Jameson was residing in Bryan Town Hundred in Charles county between 1775-1778[1]. He received

from his share of his father's will, Hall's Lot and Indian Fields on both sides of Mill Run, Hall's Place, The Addition, and Jarvis, "being of the manor contents which lieth between Mill Run and dwelling house, Spring Run. On August 26, 1767, he sold part of Hall's Lot to Edward **Edelin**[3a]. In a 1755 disposition he claims his father was Thomas Jameson[3b] and that he was then 64 years of age in a 1777 disposition[3c]. In the following year he and his family removed to Prince George's County where he took the Oath of Allegiance.

His will was dated March 26, 1774 and proved February 6, 1781[2,3] in Charles county. He mentions son John, leaving the plantation, daughters Mary Smallwood, Margaret Swann, Elizabeth Jameson, Ann Jameson, Martha Jameson, and Henrietta Jameson; sons-Benjamin, Leonard, Henry, and Monachie; wife, Ann Jameson. Witnesses were Ignatious **Boarman**, William Jameson, and William **McPherson**.

#### Notes:

Mr. Jameson was a farmer. He received from his father portions of Halls Lott and Halls Place which came originally from his grandfather, Thomas Jameson. These lands divided between himself and brother, Richard, were passed to him in 1754 when he turned 21. However, it appears that Henry in 1774 had purchased a portion of the "Merryland Tract", 575 acres, and may have removed there some time in that year(see next paragraph for more details). Yet the 1790 Maryland census shows him to be in Bryan Town Hundred in

Charles co., and in 1800 in Urbana, Frederick county. Because of this discrepancy it is difficult to determine whether Baker, Ignatius, and Samuel were born in either Charles county or Frederick county.

Mr. Jameson's death provides another difficulty as well. His gravestone lists October 24, 1815, age 72. Subtracting the age, the year of birth is 1743. Yet, Mr. Jameson could not have been born then if his father had died in 1734. Either the stone was mistakenly carved wrong, or Mr. Jameson was actually 82 years of age, instead, or Henry was born in 1743, making him some other man's son. The will of Henry Joshua states a son Henry, 1733 & probated 1734. Too, Thomas Jameson lists grandsons, Henry and Richard, heirs to Henry Jameson of Charles co., MD. Henry is also listed in the 1800 census. \*(12) This seems to confirm that an error in the gravestone engraving resulted.

In the 1790 census, Henry's son, Benedict, is in Frederick co., MD, but he appears to be the only one to have settled there at that time. It isn't until the 1800 census that Henry and some of his other children, Ignatius, Leonard, and Oswald seem finally settled in Frederick county. It would seem that while Henry purchased land in the "Merryland Tract" or Frederick county, he had not intended to move there until later, yet providing some incentive for his son, Benedict, to move north earlier, and possibly so to "prepare the way", perhaps. The land in question lay along the Frederick and Knoxville road, occupying 5,000 acres (two years later it was increased to 6300 acres) granted by Governor Benedict Leonard Calvert to Capt. John Colvill, November 5, 1731. When Covill died, his son, Thomas, inherited the estate, and upon his death, his son, Francis Colvill became the owner and executor of the grant. Residing in Virginia, Colvill, along with George Washington and John West Jr. administered the tract of land. It remained intact until 1774 when Henry Jameson purchased the 575 acres in the "Merryland Tract". In subsequent years the area was settled by English speaking people from the eastern counties of Maryland, Virginia, and Great Britain.

# Notes:

Little is known of this side of the family other than the meager information that some records have provided. The listing of the children may even be incorrect, though the data from the source, Maryland Historical Magazine shows Sarah Jameson, widow, b. 1710, d. 1795, \*(13) and lists the following children: Thomas, Nancy, Harriet, George, Raphael, Sally, and Maria. The balance comes with some trepedation on my part from the Bucy file, a home grown family tree with mixed lineages.

Mr. Jameson was listed in the 1775-1778 census for Charles county, residing at Bryan Town Hundred along with James and Joseph Jameson. The 1783 County assessment shows Benjamin Jameson having 620 acres, parts of "Timberwell", "Boarman's Manor", and "Queen Mary", the latter he purchased from brother, Henry[5], and the former heired to sons Samuel, Thomas, and Raphael.

Is this the Jameson who died in 1787 and whose will was probated September 24, 1787, Charles co., MD? In the will he bequeaths to his children after his wife's death all estate, real and personal, "first reserving to William Queen all land his father bought of my father" [8]. He names the following people: wife, Sarah; children-Walter, Samuel, Thomas, Raphael, Jesse, Catherine, Teresa, Sarah. In one comment Benjamin states according to Toso, "To son Walter he left a clock he heired from estate of his uncle, Joseph Jameson, and a mahogany desk". Was this Bernjamin's uncle or Walter's? Inventory of the estate was taken April 8, 1788 which consisted of 36 slaves. His son, Jesse, became the guardian of his brother, Walter December 1, 1788[8], and his daughter, Sarah, was appointed the ward of her mother, Sarah at the same time.

His wife was listed in the 1790 Census for Maryland showing 1 male over 16, 3 females, and 26 slaves. She left a will[5b] March 13, 1792, proved April 6, 1795 leaving children Walter, Samuel, Thomas, Raphael, Jesse, Elizabeth, Sarah **Boarman**, and Leonard.

Mr. Jameson, born in Charles co., MD., seems to have settled at an early time in Frederick co., MD, possibly as early as the 1780s to help oversee some of his father's earlier properties acquired back in 1774. He was a Colonel in the militia provides a death as March 23, 1804, age 44 years. In 1793 & 1794, Benedict Jameson was a member of the House of Delegates from Frederick county.

Mrs. Jamison married after Benedict's death, Tobias **Belt** on April 15, 1811, in Frederick co., MD., the son of Jeremiah and Ann (**West**) Belt. Alexius **Boone** on October 17, 1820, deeded to his son-in-laws, Oswald Jamison, and Tobias Belt, for the sum of \$3000.00 25 slaves, "...along with the wheat, rye and corn, now on the lot I live on" with his stock of horses, cattle, hogs, sheets, household and kitchen furniture, wagons, carts, and miscellaneous farming utilities which "I purchased at the sale of Benedict Jamison's personal Estate...". Mr. T. Belt was evidently an influencial man in his time. He was a friend of Governor Thomas Sim **Lee** and like the Governor, instrumental in the erection of St. Mary's Church in Petersville, MD. While Lee gave a \$1000.00, Belt gave an acre of land. Belt was related to the Lees through marriage(see accompanying diagram). Mr. Belt devised to his friend John Lee, Esquire, the right to one acre on which St. Mary's Church was built near Petersville. He also deeded six additional lots located in Georgetown which were bequeathed to him through the executors of Thomas S. Lee, Sr., deceased. Mr. Belt's will was dated February 9, 1828 and probated April 1828, Frederick co., MD.

Mr. Jameson's will was dated 9/11/1821, Frederick co., MD., and probated ten days later. Mentioned was: wife, Mary, co-executor, dau. Jane, son, Francis, dau. Catherine, son John as executor, and dau, Elizabeth Smith, witnesses were John and Samuel **Wenkle**, and Jonathan **Kearsley.** Mrs. Jameson's will was dated 8/3/1834, executor, son, John; witnesses were John **McCaffrey**, David **Whalen**, and Jacob **Gillenger**; the estate was divided equally in 1/5ths for each of her children.

Mr. Jameson was a farmer and resided in Frederick co., MD. until after 1818 where he and Priscilla settled in Blooming Rose, Allegany co., MD where they both died. Jameson raised tobacco and soon the family thrived and grew. He purchased from Daniel **Murray** of Anne Arundel county, MD. on June 4, 1829, on the "Blooming Rose Tract" Lot #6 for \$875.00. In the following year he bought from Murray 128 acres of Lot #5.

In his will, dated June 9, 1831, Samuel left his estate in the hands of his wife, Priscilla, along with the 15 or so slaves needed for cultivating the tobacco and attending the needs of the family. He donated \$50.00 for the erection of the new church and bequeathed \$100.00 to Rev. Marshall for some purpose already known from previous business. Priscilla and son, Richard Jameson, were co-executors of the will probated June 30th of the month. Witnesses of the will were Trueman West and Leonard Smith. In 1836 Athanasius Mudd, and Richard B. Jameson were empowered to sell the property after Priscilla's death. In 1837, son, Henry A. Jameson, purchased the estate for \$35.00. Mrs. Jamison wrote her will March 22, 1836. She mentions bequeathing to Rev. Francis Marshall \$50.00; mentions daugther, Priscilla Mudd, to provide for and support for her daughters, Jane Frances Jamison and Josephine Jamison; her son, Richard B. Jamison, to support younger sons, Samuel Jamison and Tobias Jamison. The will was probated May 10, 1836, executors, Richard Jamison, and son-in-law, Athanasius Mudd. In the 1850 census, Tobias Belt Jamison was listed residing with his brother, Richard, along with their brother, Jeremiah Jamison.

- Samuel Ignatius Jamison and Jeremiah Jamison were 2 of 6 petitioners in 1834, Blooming Rose, to find a priest for the church.

Captain Belt was married four times. Mr. Jamison and Miss Barrett were married by Rev. John McElroy in Fredericktown, MD. Mr. Jamison was a public spirited-minded person of some reputation and wit. He was a hoseman of the Independent Hose Company February 19, 1831 and was also singularly attentive as a lawyer. Mrs. Jamison died of a "prevailing disease" at age 28 years leaving "her affectionate husband and three infant children". She was a member of the Catholic church and is buried at the cemetery there. Mr. Jamison on a Thursday evening at City Hall 8/1832 "by delegates appointed from each ward, which met for the purpose of taking into consideration the appointing of a Board of Health. Three persons were appointed: Henry M. Jamison from Ward 4". Mr. Jamison married at Saint Thomas' Manor, Charles co., MD. to Miss Mary A. Holmes, by Rev. Thomas Lilly, S.J.

Mr. Jamison's mother, Margaret Boone Jamison, in her will of December 30, 1830 and probated May 9, 1837, Frederick co., MD. states, "...Henry and Mary Jamison have minor children..." and names only her grandson, Benedict, who received one extra share of her estate "in consideration of his deafness". Mr. Jamison was a slaveholder in Maryland and just prior to the eruption of the Civil War, many of these merike Jamison held several meetings for the purpose of protecting their property. In June of 1859, a county convention was held in Frederick to select delegates to the State Slaveholders Convention. Some of the men elected were Richard <b>Thomas</b> , Jacob <b>Young</b> , Ignatius J. Jamison, Francis J. <b>Jones</b> , Dr. Jonathan W. <b>Hilliary</b> , Thomas S. <b>Lee</b> , John L. <b>Belt</b> , and 46 others. The convention reflected the concerns and sentiments of the delegates and those they represented, but made no new laws or regulations *(15) in opposition to the north's gathering might toward the slavery issue. In 1860 a law had been passed to stop the efforts of the "freedom chriekers" and the effects of manumission. The 1860 census showed the results of freeing slaves in that county: of the 8,054 inhabitants of Frederick City, for instance, 1,254 were freed negroes.

Mr. Baughman was a newspaper man and a native of Frederick co., Maryland having been born on the "Merryland Tract". His father was a well known farmer and his grandfather a renoun sea captain, who brough over many of Frederick county's settlers. John Baughman attended St. John's College and later went to Baltimore as a merchant. He had a reputation for honesty and integrity and in 1841, studying under General James M. Coale, became a lawyer passing his bar exam in 1843. In the year he was married he purchased "The Citizen" which he successfully handled. In 1862, he was arrested by Federal authorities for supposed "disloyal utterances and conduct" and incarcerated in the old capitol in Washington. Shortly afterwards he was released through the incession of Honorable Henry May and Robert J. Brent of Baltimore. In 1863, the newspaper was suspended from going through the postal system by then Postmaster General Montgomery **Blair**, though it never stopped publishing. Its success now laid with pstrons and friends, who distributed the paper for him throughout the nation. Again, in 1864 he was arrested, his paper suppressed, his property confiscated, and he and his family sent south beyond Federal lines for his imflammatory editorials against the United States Government. There he was given a position in the Third Auditors office by his old friend General John C. Breckinridge.\*(16) John Baughman returned to Frederick co., MD in 1865 and his wife, and daughters, Corinne and Mary Louise, and her son, Charles, given asylum by Col. Dearmont of Clark co., Virginia until the end of the war. Baughman's son, Louis Victor, joined the Confederate Army, and served with Early, Breckinridge, and McCausland. The young Baughman was captured at Moorfield, W.V. and imprisoned at Camp Chase, Ohio, released just before the fall of Richmond. Remaining in Frederick City, John Baughman resumed publication of "The Citizen". His health, poor from a contracted illness during his stay in the south, prevented his appearance as a delegate at the National Democratic Convention in Baltimore to nominate Horace Greely in 1872. While Greely was anti-slavery, he recognized a general amnesty after the war to help with the reconstruction of the south. But his more liberal views angered far too many people who aligned against him in that year.

Mr. Mudd own property in Prince Georges county named "Gantts Enlargement Enlarged", "Dukes Delight", and "Molleys Delight". Priscilla and Athanasius were married by Rev. Francis **Marshall**. When Benedict Boone vs Levin West and Eliza West & Others came up in court in 1856, the suit prepared the selling of certain holdings bequeathed by Jeremiah Belt to his last and fourth wife, Ann West Belt, for the continuation of her life until her death and the general establishment of these funds and holdings to his children after her death. According to the suit, Priscilla Belt Mudd conveyed her interest in her father's estate to Jeremiah G. **Morrison**(see Chart IV) as did most of the other inheritors of the estate.

Mr. Jamison purchased from Daniel **Murray** June 16, 1832, in Blooming Rose, MD., for \$374.50 Lot #7, called "Resurvey on the Blooming Rose Tract" which borders the Youghiogheny River in Friendsville. Six years later he sold this land to Andrew **Friend**. Richard was the exceutor of his father's estate. Having received Letters of Administration in 1836, along with Athanasius Mudd, they sold the land in 1837 to Henry M. Jamison (21700) for \$35.00. Mr. Jamison was the legal guardian for brother, Samuel and Tobias Jamison until 1849. In 1850 only Tobias Jamison remained in his brother's household until the mid 1850s. Samuel removed in 1849 to the west to look for gold.



Mr. Jamison went west in 1849 to the gold mining fields of California. How much "paydirt" he struck is not known, yet in the following years he settled in Santa Clara county and began raising fruit orchards for a living. Successful in his endeavors, Mr. Jamison built his home, a two-storied affair, in 1866 which later was sold to Alfred J. **Brown** in 1914 and became known as the "Jamison-Brown" house. The old home, later added to by the Browns, was sold in October of 1970 to Kaiser-Aetna Company for development. When this was learned a committee helped to raise the necessary funds to removed the house to the nearby Triton Museum. \*(17).

Jamison made his mark in California in politics and local county elections. He was elected to the county board of supervisors and later elected in 1875 to the State legislature as the Democratic Assemblyman from Santa Clara. His business interests ranged from early cheese manufacturing to that of President of the Bank of Santa Clara.




Mr. Jamison resided in Frederick county, MD. most of his life settling in at Urbana and later at Walkersville where he and his wife died. Brought up on his father's farm in Urbana he attended local schools and graduated from Bryan & Stratton's Business College, Baltimore in 1867. He soon joined his father in the J. I. Jamison & Son company of Baltimore which dealt in general merchandizing until 1886 when he removed to Walkersville, MD. "I, Jane Wharton, wife of Henry Wharton of St. Mary's County, Maryland, gent., fifty years old, was personally present at the house of Mrs. Jane **Doyne**, in St. Mary's County, and saw a certain Mr. Thomas Jameson married according to the rights of the Church of Rome by Rev. Wm. **Hunter**, to my sister, Mary **Matthews** (widow of Thomas Matthews), and that on or about December 20, 1699, I was personally present at the home of said Thomas Jameson in Charles County when my said sister, Mary, was delivered of her eldest son, Thomas, who is now living. This Deponent further says that Mr. Thomas Jameson, her brother-in-law, went one or more times, during his intermarriage with her said sister to England, and she had frequently heard him say he was next heir to a large estate in England, which he could not expect to enjoy during his lifetime, but hoped it would come to some of his children some day, and this Deponent further saith that the said Thomas Jameson, her said sister's husband, departed this life on or about the 18th day of November 1730 and that for several years before his discease he was in a very weak, lanquishing condition, and further saith not. Sworn to by the within-named Jane Wharton the 16th day of January, 1738, before me the subscriber, one of his Lordship's (the Lord Proprietary), his Justice of the Peace for Charles County.

7. Thomas Jameson's son's, Henry and Thomas, both had sons named Henry Joshua Jameson. It is unknown whether any of Thomas' other sons had a son so named. In the name of God Amed. I, Thomas Jameson of Charles co., in the Province of Maryland being in perfect health (praised be God) do make this my last will and testament as follows these things:

I give and bequeath to my three sons, Thomas Jameson, William Jameson and Henry Jameson all the land where I now live being part of two tracts of land the one called Halls Place and the other called Addition containing one hundred and fifty four acres of land more or less to them and their heirs forever to be equally divided among them and if any of them decease without theirs than my will is, that his part of land above mentioned shall be equally divided between his two surviving brothers and my will and pleasure further is that my three sons, Thomas Jameson, William Jameson and Henry Joshua Jameson in consideration of my willing them the land aforesaid shall pay or cause to be paid all the just debts, now --- by me and in case any of them refuse to pay his equal part of the said debts my will is that he so ----shall have no right or ---- to any of my land above said but his part of land above said shall belong to his brother or brothers settling the debts above said to be paid forever and my will further is that my sons Thomas' part of land above said be paid off on that part of my paid land where he now dwells.

Then, I give and bequeath to my beloved wife Frances Jameson during her time that she shall live a widow all my goods and challet and personal estate and my will is that my two daughters Eleanor Jameson and

Elizabeth Jameson enjoy the said goods and challet with my said wife living the time they shall live single and in case my said wife marry before my two daughters aforesaid then my will is that all my goods and challet and personal estate be equally divided amongst my said wife and daughters aforesaid.

I nobly and nominee constitute and appoint my beloved wife Frances Jameson and my beloved son Henry Jameson wholes and executory of this my said will and testament. The witness wherof I have hereunto set my hand and seal this ninth day of September in the year of our Lord one thousand seven hundred fifty eight, 1758.

- 9. A brother of Sarah Queen, b. 1726, Charles co., MD.
- 10. Since this Henry was born in 1733, he could not have been the son of Henry(18021) and Elizabeth Jameson who died in 1733 and noted as deceased in grandfather's, Thomas', will of November 1733. If this is the case, then Henry Joshua Jameson who married Elizabeth **Pye**, may have been the son of Thomas and Frances Jameson(18020). This would make more sense.
- 11. There is some discrepancy with Benjamin Jameson. Other genealogies note that Benjamin, the son of Thomas and Mary Doyne Jameson, married Sarah **Queen** and that there was no intervening generation. On the other hand the Bucy reference states that Benjamin, son of Thomas and Mary, had married Sarah **Pye**. Then again, this latter source also states that he had a son, Benedict, who married Margaret **Boone**, which is patently false. Yet, the following points counteract the Toso document:
- a) The 1790 census shows separate listings for Benjamin Jameson and Sarah Jameson.
- b) Toso contends that Benjamin was b.c. 1719, an arbitrary date at best. This would make him abt. 41 when his first child, Walter, was born.
- c) Maryland Historical Recs, v.68,p.67 shows a Sarah Jameson, b. 1710, d. 4/9/1795. If this was Sarah Queen, she would have been in her 50s having her 1st children.
- d) Thomas Jameson I was b.c. 1665. If Benj. was b. 1719, Thomas would have been 54. If Benj. was born abt. 1719 Benjamin would have been in his 40s having children.
- e) Thomas II, Mary, Martha, Henry, and Joseph all had children born in the late 1720s and 1730s.
- Was a generation missing? Could Benjamin, son of Thomas & Mary, have married Sarah Pye, 1st, then Sarah Queen, 2nd? Or can the situation support Benjamin, b. 1709, m. Sarah Pye, had issue, Benjamin, b.c. 1733, m. Sarah Queen, and have children abt. 1760?
- 12. Until the 1810 census for Maryland is checked out, or some other record comes forth, no determination of

- Henry's death can be made.

- 14. This date, the year, is called into question by the source which gave it (Names In Stone, Holdcraft, p.620). The listing reads, "Jamison, Catherine w/o Ignatius 10 Aug. 1825(?) age 65; eroded(Frdk. Cath. 198)".
- 15. Of historical note, the law of manumission became a steadily increasing route for those in slaveholder states to formally release an individual or group from slavery, personal bondage, and servitude. Fairly common in the colonies, manumission rewarded individual slaves for instance for some special service or affection a slaveowner felt toward his people. In Frederick co., especially around 1860 "many slaves escaped and the work of manumission was rapidly going on." -History of Frederick co., MD., Williams, 1910, p.221.
- 16. John Cabell Breckinridge, 1821-1875, American lawyer, soldier, and politician, was born near Lexington, Ky. Educated at Centre College and Transylvania University he served as a Major in the Mexican War. He served, too, in the State legislature, as a member of Congress, 1851-1855, and elected in 1856 as Vice President of the United States on the same ticket with James Buchanan. In 1860, he was nominated for President by the southern fraction of the Democratic Party and defeated by Lincoln. He became a U. S. Senator immediately afterwards, but resigned to join the Secessionists. At the outbreak of the Civil War joined the Confederate Army becoming a Major-General under Jefferson Davis in 1862 and took part at Shiloh, Murfreesboro, Chickamauga, Chattanooga, Cold Harbor, and the Shenandoah campaign in '64. He was Secretary of War in Davis' cabinet in '65, and at the close of the conflict escaped to Europe until 1868 when he returned and devoted himself to law. (Funk & Wagnalls Encyclopedia)
