NOTES

In 1978, Ruth Jamison of Oklahoma City, OK. completed "A STATISTICAL HISTORY OF THE DESCENDANTS OF WILLIAM ANDREW JAMISON". She xeroxed the data and sent it to some of her family as well as donating many copies to her home state library and other genealogical organizations. It was inevitable that she and I would eventually correspond, and we did over a period of several years before her death. Because of my keen interest in family history she asked if I could assist her in determining her ancestor's parentage, which I did. The resulting genealogy is provided below and while normally this would be included under the 2ND SUPPLEMENT TO THE JAMESONS IN AMERICA I do not have her researched manual but for the first four pages of the Introduction. Thus I do not know how she indexed her family data, nor any other part of her ancestor's history. In her long association with family research, Ruth accumulated additional family trees and records along the way, which she invariably sent to me. Her services and voluntary efforts to discover her own family aided the discovery of other Jameson branches as well. In this all too brief note I feel the necessity to include her as one of the few individuals whose hard work and dedication has amply illustrated the measure of one's worth.

25000-1 JOHN JAMISON SR., was born about 1765-1770, possibly in PA. He died 1838, in Washington, Westmoreland co., PA. Mr. Jamison married circa. 1783, PA., Mary _____.

Notes:

Mr. Jamison may have been a son of Robert Jamison of Cumberland co., PA., though that is highly speculative. He appears in that part of Salem, Westmoreland co., PA. which later became Washington, PA. prior to 1790. He was listed in that year's census as well as the 1800 and 1810 so came to Westmoreland just after his marriage, assumably. Material researched provides a sketchy history, yet in an 1811 land deed he patented and purchased that year, June 26, 209 acres in Salem which was conveyed to him October 13 1813. He later transferred some of this land to his sons, Robert and William Jamison September 11, 1821. In 1823, his sons, William, Robert, and John Jamison, and their wives, Martha, Elizabeth, and Margaret, resp. sold the lands back to John Jamison Sr. No reason was given and they were all residing in the town of Washington at the time.

John Jamison's will was dated June 6, 1829, and probated June 16, 1838, Washington, Westmoreland co., PA. In it he mentions Mary, his wife; daughters-Jean Hall, Martha Barber, Polly Alexander(note against Joseph Alexander); and sons-Robert, William, James, and John Jr.; granddaughters Jean Barber and Jean Jamison, daughter of John Jamison Jr.; and executors, sons, James and William Jamison and Daniel **McKown**.

25011-2 JAMES JAMISON [John], was born circa 1784, Washington, Westmoreland co., PA., the son of John and Mary Jamison (25000). He probably died in OH. Mr. Jamison married about 1808, Washington, PA., Mary **McDivitt**, born circa 1890, PA., the daughter of Hugh McDivitt. They resided in Washington, Westmoreland co., PA. and in Columbiana co., OH.

Notes:

Mr. Jamison was born in Westmoreland county and may have been the eldest son of John and Mary Jamison. He is listed in the 1810 census with spouse and one son. In 1814 he was sued by Jacob **Landis** in an ejection of a tract of 426 acres in Washington, PA., bounded by Jamison, James B. _____ (not decipherable), James **Campbell**, and others. He was defended by his attorney, Mr. **Alexander**, pleading not guilty in the February 1816 Court and was found not guilty November 19, 1816. In probate records for Westmoreland county 250 acres of Hugh McDivitt's estate was granted to two children, David McDivitt and wife, Elizabeth, and Mary McDivitt, since married to James Jamison in equal interest with other heirs, all of Columbiana co., Ohio. Hugh McDivitt died circa 1808, Washington, PA. In a subsequent land deed James Jamison sold his wife's property from her father, to her brother, George McDivitt of Washington, PA., November 19, 1833. Mr. Jamison and his wife, Mary, removed to Wayne, Columbiana co., OH. prior to 1830 and after 1810.

25013-2 ROBERT JAMISON [John], was born circa 1791, Washington, Westmoreland co., PA., the son of John and Mary Jamison (25000). He died in either in 1849 or 1850, Washington co., PA. Mr. Jamison married first, Elizabeth _____, and second, Sarah _____, born 1781, PA. They resided in Washington, Westmoreland co., PA.

Notes:

Mr. Jamison was a farmer in Westmoreland county for many years and attended Poke Run Presbyterian Church. He was married twice, but little information is known about them. He received from his father September 11, 1821, certain portions of a tract his father had patented in Salem, now Washington, PA. back in 1811. This same land he and his wife, Elizabeth, returned to his father, John Jamison, in 1823. In 1838 he was listed as an heir in his father's will and then in the late 1840s, he began selling off his land. On February 22, 1847, he sold to John **Hall** of Washington, PA., and on May 9, 1848 he sold land to John **Macheney** of Salem, PA.

Mr. Jamison died sometime between 1848 and 1850, for his wife, Sarah, is listed on the 1850 PA. Census, and on the 1860 census for Washington township without him.

Mr. Jamison married December 12, 1816, Westmoreland co., PA., Martha **McAllister**, born October 9, 1794, County Down, Ireland, died September 20, 1873, LeClaire, Scotts co., IA., the daughter of John W. and Rachel (**Baird**) McAllister. They resided in Washington, PA., Butler co., PA., and Scotts co., IA.

She died April 23, 1844, Washington, PA. and is buried at Poke Run Cemetery, Washington, PA. Miss Jamison married about 1815, Washington, PA., Joseph **Alexander**, born circa 1793, PA., and died August 22, 1861, Washington, PA. He is also buried at the Poke Run Presbyterian Cemetery. They resided in Washington, PA.
