## ROBERT JAMISON OF PHILADELPHIA, PENNSYLVANIA

[29300-30399]

### NOTES 1:

Some of the later history on his branch was provided by Raymond Jamison of Findlay, Ohio. Mr. Jamison is a descendant of Rev. Ira and Rebecca (Poulson) Jamison, whose interest in genealogy has helped to shape a part of this history.

### NOTES 2:

Occasionally a preface to a family tree is required to bring some of the more trying, complex, and confusing elements of the landscape into perspective. This is the case with Robert and Sarah McKee Jamison family ancestry. Some times we genealogists in our enthusiasm bend over backwards in establishing a relative connection. This family's origins are still shrouded in the past and presents us with difficulties. While I have deduced that some branches may not be linked to this family, some crying vehemently that I have unjustly prejudiced myself, have shown more that proof just does not exist to make them related. The DAR records from which several researchers use to show lineage are merely traditional and have absolutely no basis in fact. I have shown this time and again in other genealogies as well. In the book, "The Glory Belongs To Our Ancestors", by F.W. Swise, is mentioned that some of Robert Jamison's immediate ancestors took part in the Battle of the Boyne, 1690, under King William III. As with the rest of the book there are no references to substantiate what's become traditional over the last four decades. And that, in the main, is the situation with most pre-1980 family histories.

How Jamison's family played in this arena is not known, nor has evidence shown any emigration, children, and other aspects one would expect from a research. Swise may have conducted an exceptional research on much of the present family, culling his findings as he did in this publication, some of its content ringing with authenticity, but we'll never know it. A complete lack of sources ends this possibly excellent book. Few, even none, may never do any of the research to discover whether the content of his publication is correct. And that's a shame for Mr. Swise who spent so much time developing it. Nearly all the information concerning Jamison's stay in Pennsylvania is practically non-existent with the exception of the son, William, his service record, his property ownership in Northumberland co., and his wife's origins from Lycoming co., PA. Through intestate and will probates, links between William, John, David, and Samuel can be established in Virginia and in Kentucky. No actual records have been discovered for daughter Jane nor can it be ascertained for any certainty that sons, Robert, Thomas, and Arthur are those as described below.

On record, evidence shows a Robert and Arthur Jamison in Rowan co., NC in 1788 and 1785, respectively, their migration to Mecklenburg co., NC in 1790, and links to Thomas Jamison already residing in Charlotte. The three men appear well established and related to each other as documented in the genealogy. Thomas and Arthur Jamison have been linked via a will, Arthur and Robert through a land deed, and additionally,

Thomas, Arthur, and Robert Jamison's land abutted each other in the same district along Long Creek, an offshoot of the Catawba River in the western section of Mecklenburg county. Other odd pieces of corroborating support provide fodder as well. Are they linked to Robert and Sarah Jamison of Pennsylvania? Interestingly enough, the Lockhart name appears in early Rowan/Mecklenburg counties of North Carolina. Had some of these people (kin, perhaps) migrated at the same time to North Carolina? Arthur and Robert Jamison appear older than Thomas, and both men had prior wives than the ones married in North Carolina. Arthur, apparently the eldest of the three, appears to have been born about 1755, Robert between 1755-1765, and Thomas between 1760-1770.

On the other hand there is the contention that Robert Jemison, who married Margaret **Kirkham**, (39300) of Georgia was a son of Robert and Sarah (**McKee**) Jamison. Artemesia **Wheat**, a daughter of Robert and Margaret Jemison states in a letter to her nephew, Robert Jemison of Macon, GA., "My grandshire and mother were married in Ireland...They landed in Philadelphia. Their only daughter...married a **Prather**...The name of Robert has descended with the generations. My father's name and his father's name was Robert..." She indicates that William and Arthur Jamison settled in North Carolina, her own father as well. If we're to accept that Arthur, Robert, and Thomas migrated to North Carolina, why did they? Why didn't they move south to Kentucky like the four other siblings, William, Samuel, John, and David? Research has shown that Jane married a Barr; that William Jamison removed to Augusta co., Va. to Bourbon co., KY., and died in Ross co., OH. Obviously, she must have known her grandfather's name, not necessarily the man himself. Yet she indicates that Robert and Sarah Jamison settled in Mecklenburg co., NC. No facts support this proposition in any form. No one has yet shown where Mr. and Mrs. Robert Jamison died or where they might be buried. Though proof that Wheat's parents came from Virginia are now clear with recent research, Margaret Kirkham, the daughter of Henry, resided in Botetourt co., Va. There is proof of a Robert and William Jamison in that territory. Margaret was also from Rockbridge co., VA. and there is strong support that her husband, Robert Jemison, was also from this county, earlier a part of Augusta (even earlier as Orange) county, Virginia. To make this even more trying, research has proven that William Jamison and his wife, Susannah Lockhart, were residing in Augusta county, VA. at the same time as this Robert and Margaret Kirkham Jemison. Is there a link? Could Robert Jemison be the son of Robert and Sarah McKee Jamison? Only with more research and more diligent plugging away at the old records can we ever get near the truth.

In a deed of some extraordinary importance, however, "*Joseph **Kirkham** of Richmond County, Georgia sold to James **Crawford** for 5 shillings, 263 acres on the Middle fork of Buffalo Creek in the forks of the James River. Said tract conveyed to said Joseph Kirkham and Henry Kirkham Jr., deceased by virtue of a will made by their father, Henry Kirkham, Sr., deceased, bearing date March 6, 1765, excepting 60 acres which was willed to Robert Kirkham, his son, it being at the Great Spring. Received August 3, 1784. Witnessed by J. S. **McClown Jr.**, Thomas **Howel**, Robert Jamison, and Samuel **McNabb**; Robert Jamison was not one of the subscribing witnesses in the court acknowledgment delivered April 2, 1792.*<sup>(1)</sup>" What has been shown is the presence of Robert Jamison and Samuel McNabb at the same time at the same place to witness no doubt a family deed amongst them all. This, perhaps, is the Robert Jamison who married Henry Kirkham's daughter, Margaret, circa 1755 in Augusta county, Virginia. With McNabb there as early as 1765 and witnessing the selling of a Kirkham deed, could Robert Jamison have been Samuel McNabb's brother-in-law, or conversely, Isabel Jamison's brother? Or was this strictly a coincidence that Samuel McNabb and a Robert Jamison were there at the same time? It is also important to note that a Robert and Sarah Jamison were residing in Augusta county, Va. at the same time. Not knowing when Robert and Sarah McKee Jamison died, the possibility that they migrated to Virginia with their children makes for an interesting speculation. Add some hard facts and perhaps there is more than speculation at work here. In another related matter a Robert and Sarah Jamison in 1772, sold to William **Black** 100 acres patented the year before by Jamison of a lot on the south side of South River in Shenandoah county, part of the original 1770 patent. Could this have been the Robert and Sarah Jamison of Tinkling Springs, VA. #40912? Or was this the Robert Jamison who was the Robert Jamison of Shenandoah co., VA. #26542? Or was this Robert and Sarah McKee Jamison of Philadelphia, whose

deathbeds we know not, and came to Augusta co., VA. with their children? Witnesses to this deed, incidentally were: Patrick Buchanan, Jacob Lockhart<sup>(2)</sup>, and Gilbert **Christian**. One would assume, then, that this was indeed Robert and Sarah Mckee Jamison and that they had found their way to Virginia with their children.

### NOTES III:

Was Robert a son of William Jameson of County Tyrone, Ireland. Is this the missing Robert Jamison whose brothers were William Jameson of Maine, John Jameson of Massachusetts, and Henry Jamison of Pennsylvania? **No!** And why not!? Because this Robert was born in the 1720's and all his brothers were born in the late 1600's.

**29300-1 ROBERT JAMISON**, was born circa 1723, possibly in Ireland or Scotland. He died 1802 in Philadelphia, PA. Mr. Jamison married some time around 1745 in Philadelphia to Sarah **McKee**, born in Ireland and died in 1802 in Philadelphia. The Jamisons made the famous Liberty Bell City their home.

#### Notes:

There is some conflicting evidence about the early history of this family which makes for some difficult researching. One researcher believes that Sarah McKee may have come out of Philadelphia, though indicating that the family probably settled inland somewhere and provided deaths of 1814 and 1824 for Robert and Sarah Jamison, respectively\*<sup>(3)</sup>. Certainly, discovery shows that the family probably settled along the Susquehanna River and evidence of this can be sourced through their son, William, who served during the Revolution from Northumberland co., PA. and owned some property in the area. The births and deaths listed above are referenced through DAR records listed under References and are not to be taken as absolute. No actual proof has corroborated the vitals. Even the listing of the children may or may not be complete. The whereabouts of Robert, Arthur, and Thomas has also added to the confusion of this family. Research describes three men in North Carolina, see notes prefaced above, but can they be linked to the subject of this ancestry?

It must also be said that there is no records bearing out the names of Robert and Sarah Mckee Jameson's children. It has been assume that the above children are Robert and Sarah Jameson's. Thus, Thomas, Robert, and Arthur Jameson may well be connected to them only through research based erroneously on Artemesia Wheat's link to Mecklenburg co., NC.

There appears to be some thought to the idea that Robert and Sarah Jameson may have died in Virginia. Land records show a Robert and Sarah Jameson purchasing and later selling land along the south side of the South River in Augusta and Shenandoah counties. With the Lockhart name involved with some of these early deeds there may be some substance to this.

Mr. Jamison married 1771, Northumberland co., PA., Susannah **Lockhart**, born 1750 Morland, Lycoming co., PA., died September 2, 1824{September 20, 1824} Ross co., OH., the daughter of Jacob and Mary Lockhart.

Notes:

Mr. Jamison was a private during the Revolutionary War under the Command of Captain John **Loudon**'s Company, of Col. William Thompson's Battalion of Riflemen from Northumberland county, PA. He also served under Captain L. **Marpole**'s Company B, Philadelphia County. With the Revolutionary War at an end William, along with most of his brothers, removed south to Augusta County, Virginia some time between 1780-1782. They settled with the Lockharts and Arbuckles in Beverley Manor along Back Creek. Land records for the area show this to be true. Jacob Lockhart Sr. purchased 436 acres in 1742 on both sides of Back Creek just below the Youngs and Martins(see map). This tract sat less than 2 miles south of Jonathan **Jamison**'s (40900) tract on Back Creek raising the possibility that the two might have been related. Yet, Susannah Lockhart was born in Lycoming county, PA. so the Lockharts appear to have had two residences at the time. Jacob Lockhart was born 1715 in northern Ireland and died 1783 in Augusta co., VA. His will was dated January 30, 1771 <sup>(4)</sup> and probated April 15, 1783. Mr. and Mrs. Lockhart had the following issue:

On May 27, 1783, Jacob Lockhart, Jr., of Greenbrier co., VA.(now WV) grants power of attorney "to my *trusty friend, William Jamison*" to convey title of land he held in Augusta co., VA. which adjoined lands of Peter **Hanger** and Robert **Clark**. These no doubt were the 200 plus acres of land he received from his father's will that previous April. By the late 1780s William and his family, including brothers, John, Samuel, and David Jamison, removed to Bourbon co., KY. They are listed for the March 1791 tax period and remained pretty much in the area for a number of years. But William Jamison apparently wasn't happy with the move either because of the Indian situation or the lands upon which they settled. Hungering for a new start Jamison, with a party of surveyors led by Nathaniel **Massie**, went into southern Ohio territory, like the region so much, he returned to Kentucky, packed up the family, and settled September of 1796 in Chillecothe, Ross co., OH. He settled in at Parna Station Prairie, was one of the first to raise corn in the area, then moved

to Frankfort, Ross co. where he and Susannah died.

His will was dated November 29, 1804 and probated January 19, 1805 <sup>\*(5)</sup> Ross County, OH. An inventory was conducted after his death an estate bond in the amount of \$1500.00 by James **Davis**, John **McClain**, Susannah Jamison, James **Dunlap**, and William **Robinson** ensuing. Land was mentioned in Bourbon co., KY. Witnesses were: Charles **Briggs** and William **Blair**. To sons John & William Jameson, the plantation in Bourbon co., KY. Land to sons George, Matthew, & Jacob, daughter, Sarah; sons Samuel, Merit, and Charles; daus. Elizabeth and Mary. Mr. Jamison was buried upon the farm in Ross county, but he was later removed to Concord Presbyterian Church near Frankfort, OH with a stone.

- George Jamison resided in Ross co., OH where he married Jean Lanezby.

**29314-2 DAVID JAMISON** [Robert], was born March 10, 1757, PA., the son of Robert and Sarah (McKee) Jamison (29300). He died June 23, 1833, Bourbon co., KY. Mr. Jamison married April 9, 1781, (Greenbrier co.,) Virginia<sup>\*(6)</sup> Hannah Richards{Rickards}, born 1762, and died 1814, in Bourbon co., Ky.

#### Notes:

Mr. Jamison was in the War of Rebellion. According to one source[1] he served as a private, 1783, in the 2nd Battalion, 2nd New Jersey Regiment commanded by Lt. Col. Francis **Barber**. However, this appears to be unrelated to the David Jamison of Augusta co., VA., who as a private received a pension dated October 19, 1832 at the age of 78 in Bourbon co., KY. He enlisted in the Fall of 1775 in Greenbrier co., WV into the 12th VA. Regiment under Capt. Matthew **Arbuckle** and served one year. He then re-enlisted for an additional three years and served at Point Pleasant Garrison, receiving his pension in 1832 for \$80.00 a year. Mr. Jamison resided in Augusta co., Va. until his removal in the late 1780s to Bourbon co., KY where he was listed March 1791. He was married in Greenbrier co., WV. by the Rev. John **Alderson** as was his brother, Samuel. They in turn migrated with brothers, William and John, to Bourbon co., and settled in at Paris, KY. where he died. He was listed in the will of William **Jenkins**, a relative, perhaps, dated June 10, 1813, Bourbon co., KY., and proved July of that year. Legacies were bequeathed to Samuel Jamison, Hannah, wife of David Jamison, and to Sarah, daughter of David Jamison. Witnesses were John Jamison, Hannah Jamison, and John H. **Colton**. Mr. Jamison was also the executor of the will for Edward **Stoker**.

- Samuel Jamison's wife's father was William **Hannah**.

- Sarah Jamison's husband's father was J. F. **Lock**; they were married in Bourbon co., KY;

**29315-2 JOHN JAMISON** [Robert], was born about 1755, Northumberland co., PA., the son of Robert and Sarah (McKee) Jamison (29300). Mr. Jamison was married, but his wife's name is unknown. They resided in Bourbon co., KY. where presumably they died.

#### Notes:

Mr. Jamison removed to Augusta co., VA. shortly after the Revolutionary War with his brothers. It is possible he moved in 1783 to Greenbrier co., WV when his cousin, Levi Lockhart, settled there. Some references of him or of other John Jamison's in the area point toward this. However, like his brothers, he removed to Bourbon co., KY and was listed on the March 1791 tax list. He appears as late as 1810 in Bourbon county. Mr. Jamison was a soldier in the late revolution and his name along with brother, David's, is inscribed upon a tablet on the Bourbon County Courthouse in Paris, KY. as "Soldiers of the American Revolution Who Died Citizens of Bourbon County". He was a veteran from the Virginia line.

Land records of Mason county, Ky indicate a John and Rhoda Jamison sell to Robert **Poage** 300 acres at Flat Fork, Mason co. on November 22, 1796. Could this be the above John Jamison? And could this be his wife, Rhoda? A letter supposedly written by John's brother's Jacob's son, Jacob L. Jamison Jr. indicated that John Jamison marrie Elizabeth **Ward**. The letter has yet to be authenticated, but there appears some true to the matter and some doubt.

**29317-2 SAMUEL JAMISON** [Robert], was born 1759, Pennsylvania, the son of Robert and Sarah (McKee) Jamison (29300). He died December of 1793 in Bourbon co., KY. Mr. Jamison married July 7, 1780, Greenbrier co., WV., Rebikah{Rebecca} **Ward**.

#### Notes:

It appears that Samuel and Rebecca Jamison had no children. This seems to be borne out by his will which left the home place to Rebecca and bequeaths everything else to his side of the family. Dated October 29, 1793, it was proved in December of that year. The will specifically notes he was married only the once and the name was Rebekah Jamison. He mentions his oldest brother, William Jamison and brother, David Jamison; nephews mentioned were Charles, son of William Jamison, and Samuel, son of David Jamison. Samuel **Robinson** was mentioned and the will executed by Robert **Finley** and James **Kirkpatrick**, witnessed by David Jamison, George **Wilson**, and William Robinson in Bourbon co., KY.

Mr. Jamison resided for a time in Augusta and Greenbrier counties before coming on to Kentucky in the late 1780s. He was taxed in Paris, KY in March of 1791. He was listed as a legatee in the will of William **Jenkins**, dated June 10, 1813 and proved the following July. Mr. Jamison, like his brother, David, was

He died intestate and on October 17, 1814, in London, Madison co., OH., Judge John **Thompson** gave Letters of Administration to Anna Jamison and William **Erwin**. John **McDonald**, Benjamin **Melvin**, and William **Gibson** were appointed appraisers of the estate and conducted an inventory of the estate November 17, 1814.

After William's death, Mrs. Jamison married May 5, 1816, Madison co., OH., Edward **Hatten**. They were married by Rev. Jonathan **Minshall**. Mr. Hatten died October 18, 1828 and may have been a Quaker from Pennsylvania. They had issue:

Mr. Jamison was in his father's will of 1804 receiving land along Dare Crick and one gray colt.

He served during the War of 1812 as a private under Major General William Henry **Harrison**, who commanded the Northwest Army. Under his command the army was assigned to retake Detroit, but Harrison was unable to do so until he repulse the English from Lake Erie. This occurred September 10, 1813 when Admiral Oliver H. **Perry** sailed into the Great lake and destroyed the British fleet there. With this victory, the enemy withdrew from Detroit and Malden to take positions along the Niagra frontier. On October 5 of that year, Harrison moved his force of 4500 men across Lake Erie to Malden in upper Canada. The British retreated further east from Malden only to be overtaken by Harrison at Moravian Town on the north bank of the Thames River. The Indian chief, Tecumseh, was killed during the Battle of the Thames which brought about the collapse of the Indian Confederation and led to the Indian desertion of the British cause. Fifteen

Americans were killed and 30 wounded. Of the English 12 were killed, 36 wounded, and 477 taken captive.

Known as Judge Jacob Jamison. The following is a letter supposedly<sup>(13)</sup> written by Jacob L. Jamison.

*“The Jamison Family*

*This day I begin to give a history of the Jamison Family. I, myself, was born near what is now Bourbon County, Kentucky, on March 15, 1786, being seventy-seven years of age the 15th of March 1864, next.*

*JAMISON RESIDENCE J. JACOB JAMISON BLAKESBURY*

*Robert Jamison, my grandfather, came here to America, unknown, from Ireland and married Sarah McKee in Philadelphia. The name of his sons are:*

*\*William, Arthur, Robert, John, Samuel, David, and Thomas. He had one daughter, Jane. She married Alexander Barr of Philadelphia.*

*Arthur and Thomas married and settled in North Carolina. Robert settled somewhere in Georgia and reared a family. He had a son, William, who moved to Alabama. Samuel settled in Bourbon County, Kentucky. John also settled in Bourbon County. His wife was Elizabeth Ward. They had one son, David. His daughters were: Rebecca, Sally, Jane, Susannah, Nancy, and Elizabeth.*

*David, too, settled in Bourbon County, and had four sons and six daughters: Samuel, John, Wesley, Thomas, Elizabeth, Rebecca, Esther, Sally, Susannah, and Margaret. \*William Jamison, my father, also settled in Bourbon County but moved in September, 1796, and was one of the first men that raised corn at what is known as the Station near Chillicothe, in Ross County, Ohio. His wife's maiden name was Susannah Lockhart.*

*Grandfather Robert Jamison, Grandmother Sarah, both died in 1902 in or near Philadelphia. William Jamison, my father, died in Ross County, OH., December 27, 1804. Susannah Jamison, my mother, died in September(2), 1824. Father and mother are both buried in the family graveyard in Ohio. Samuel, my brother, died December 19, 1851. Rebecca Jamison, wife of Samuel, died May 13, 1857, aged 63. Sarah Clark, sister, died July 4, 1844. Mary Anderson, sister, died October 29, 1836. Merritt, brother died February 17, 1856. One of his horses threw him against a stump and broke his neck. Charles died November 30, 1838. John M. died June 22, 1835. Elizabeth Kimbrough, sister, died April 9, 1808. William died in Ohio November 21, 1814. George died in 1824.*

*Charles reared three daughters: Susannah, Jane, and Sarah. George had a large family and all are dead. There are a number of orphaned grandchildren believed to still be living in Green County, Indiana, and some in California. John had three sons and one daughter. The sons are all dead, and Elizabeth is married to Abraham Moore, living near Williamsburgh; William had two sons and three daughters. He died leaving his family near Hancock county, Ohio, 10 miles Northeast of Finley, the county seat. Merritt had five sons and three daughters, all living. Two sons live in Ross County, Ohio, one in Kansas.*

*Mary Anderson reared three sons. Susan married and had one daughter when her husband died. They lived in Belfountain, Ohio. Elizabeth Kimbrough had five sons and one daughter. My mother had a sister married to James Clark. They lived 24 miles from Mount Sterling. She had another sister who married Charles Ward and another married to Charles Arbuckle; another married to Porterfield.*

*My mother had a brother, Jacob, Charles and others I don't remember.*

*\*\* I, Jacob Jamison, married Isabeth Hopkins of Ross County, Ohio. She died near Washington in 1812. She had two daughters and one son. In 1815 I married the second time, Drusilla Harrison, who was related to the Harrison family of which William Henry Harrison was a member. She died April 11, 1861, leaving one son, Jacob Lockhart. The other son and daughter died in infancy.*

Born in Kentucky, Mr. Jamison settled in Ross County, Oh when he was but four years old. As a young man he served under Major-General William Henry **Harrison** as a private serving in the field against Tecumseh and later during the War of 1812 like his brother, Jacob Jamison, was at the Battle of the Thames in Upper Canada. He was a Jacksonian Democrat and a Methodist. He remained in Ross County for 19 years and after

his marriage in 1815 settled in Union, Fayette co., OH for the next 25 years. He was an active and energetic person who spent much of his life in community service. For a while he was a member of of the Fayette County Commission, instrumental in maintaining the town proper through the years.

With an itch to travel, Jamison in the fall of 1840 packed up what remained of his family and moved west to Iowa where two of his sons, Samuel and George Jamison, had done so two years earlier. He had put in a claim in the spring for 800 acres of excellent prairie land which was granted under the Military Land Grant Act. With his son George, they returned to Ohio, where George Jamison was married, and back-tracked to the frontier by Autumn. Along with them went Samuel and Reuben **Nichols** <sup>\*(14)</sup>, Elizabeth's brothers, and their respective families. Having settled in Wapello, Louisa county, IA., Mr. Jamison went about establishing his home(1842) and business enterprises.

A pioneer, who cast his lot in the wilds, he aided the development of the community in the years ahead. He purchased in the same year an additional 400 acres of land, providing him with one of the largest homesteads in the region. His home sat upon a bluff that overlooked the valley, four miles south, where the town of Wapello developed. Mrs. Jamison died in 1848, but little of her ancestry is known other than the two brothers that moved west with her in 1840. Mr. Jamison remarried in 1850 to a local school teacher who won over the children and devoted herself unselfishly to that of her new home and family. When her husband died, Mrs. Jamison moved to Monmouth, IL. taking Merrit's daughter, Susannah, with her. There she married Rev. **Mitchell** and returned to Louisa county on many occasions to see her step-children.

Mr. Jamison was an original member of the Bethel Methodist Episcopal Church. He donated the land upon which the church and town school now stands. The church, itself, was built by George Jamison and dedicated in 1855 on a Sunday morning and that afternoon its adherents conducted its first funeral services for its founder, Merritt Jamison, who had passed away a few days earlier. He was buried next to Elizabeth Nichols in the Bethel Cemetery. Mr. Jamison served on the Board of Commissioners from 1844-49, and as Probate Judge in 1850 until the latter office was abolished and provisions for a County Judge made. See end note below for an 1847 letter. <sup>(15)</sup>

Mr. Jamison was buried at the Lucy Buckner Kenney farm, Cane Ridge Rd., Bourbon co., KY. He removed from Bourbon county to Mason county where he help found the Christian church at May's Lick. He was an original founder of the Chruch at Cane Ridge in Bourbon county which explains his devout religious beliefs and the reason he left Bourbon county. His grave stone was erected in 1848 in memory of their father and mother, his beloved wife, Margaret, and one daughter, two sisters, and his two nieces, one son in Ohio, one daughter in May's Lick, and one sister in Missouri. Mr. Jamison sold to Thomas **Hixson**, October 19, 1837, 62 acres at Johnsons Fork and sold November 10, 1842, to James **Weir**, 187 acres at Lee Creek, Ky. On March 6, 1847, David Jamison sells to Newton **Clift** 131 Acres on North Fork, Mason co., KY.

Notes:

Mr. Jamison was a Captain in the Army and served during the Civil War. Several of his sons, Joseph and William, were under their father's command. Joseph Jamison died in Toulon, Stark co., Il, while William Jamison was killed in action at Millikan's Bend, LA. Mr. Jamison enlisted into the 47th Il Infantry and commissioned Captain of Company "K".

Capt. Jamison migrated to Cherokee, KS in 1869 when it was first known as Colchester and bought a farm a mile south near the lake. He attempted to get the town moved by this lake, but the railroad company refused to change the locale for company reasons. Here Jamison established the Cherokee House, the first hotel in the area, though it's first name was called the Grand Central Hotel.

*"It was a proud day for Cherokee when that magnificent hotel was dedicated. It was as good as any hotel south of Fort Scott fro 500 miles. Captain Jamison with plug hat and gold headed cane made an ideal landlord."*<sup>(25)</sup>

Eighteen seventy-one and '72 were slow growth years, but soon the influx of people and the coming of a banker soon established Cherokee on the map. A school was developed by the efforts and money of Jamison and his daughter, Sarah or Sally, as she was known, became the first teacher of the new school, followed by Judge E. A. **Perry**'s wife. In an incident soon after its construction the school house caught fire and it was assume that Rolla Hoffman had died in the conflagration. To everyone's relief he had escape at the onset, but had remained in hiding for sometime afterwards. With the rebuilding of the new school house, Mrs. Margaret (Jamison) Alberty became the next teacher.

The Jamisons were an influential part of their community in every aspect of its growth from business to church. Captain Jamison performed the first marriage ceremony in Cherokee's new church as he was the town's Judge and Justice of the Peace. With A. J. **Cunningham**, Jamison picked out the first spot for the town's cemetery, and there to this day, their bones remain beneath the bleaching sun of Kansas.

Mr. Jamison was a member of the Methodist religion and an unwavering Democrat in politics. He served as a County Commissioner for a number of years before retiring to his farm of some 1400 acres. His son, Merritt

### Notes:

Mr. Jamison settled 1840 in Louisa co., IA. He purchased 160 acres in the township of Wapello, section 27, and had extended his farm by 1889 to include over 4000 acres of prime land and over 1000 head of cattle. He was a substantial businessman, numbered among the pioneers of the county, and had a poor education which by no means failed him in his later life. For many years he hauled his products of dressed pork and wheat to Burlington, the nearest trading post. In politics he was staunchly Democratic and elected to the 17th Iowa General Assembly. In the year he arrived from Ohio, Mr. Jamison helped to construct the first log school house and the Bethel church which was later replaced. His commitment to his community is evident otherwise when in 1854 with \$100.00 from his father and the help of Mark **Davison** constructed the Bethel Church. The building was completed in 1855 and dedicated in February of 1856. That afternoon, Mr. Jamison's father was buried in the cemetery beside the newly erected Church. In 1858, George Jamison erected one of the finest mansions in the county, "boasting 15 rooms, with marble fireplaces and a bath. A solid walnut stairway led to a cupola, later removed, which afforded a superb view of the countryside."\*(26)



The home was sold in 1900 to his son, Oregon, who sold it in 1911 to his son, Frank. The following year, Frank L. Jamison sold the mansion to Thomas and Samuel **Baird**.

Mr. Jameson inherited his father's 71 acre farm in Biglick, OH. and remained there until his death in 1916. He died of Bright's Disease after several years illness. He was the last surviving child of Rev. and Mrs. Ira Jameson, born in 1835, according to the Republican newspaper. "When Governor David **Tod** of Ohio called for volunteers in 1862 to protect the state from an invasion by the Confederate forces, Mr. Jameson responded and was a member of the famous "Squirrel Hunters." He was honorably discharged from the service by the state executive. Jameson was a life long member of the Webster Chapel M.E. Church in Biglick, OH. and a farmer. In 1902, an oil company discovered oil on Jameson's property, set up a rig, and produced oil. Buried West Independence Cemetery.



Someone in the family wrote a small description of life among the Jamesons in Hancock co., OH. The following is that letter:

*My first acquaintance with the Jamesons family occurred at a most opportune time. It was the occasion of the annual Family Reunion. Of course I had met "Aunt Mary", so called by her friends and two of her four boys, Milan, and the youngest, Deloy, to me the most saintly of any of my acquaintances.*

*To this reunion there came yearly the members of the older generation of Jamesons. There was Uncle Shell, who with his wife, Sally, their three children, Ira, Jason and Edith and his sister Sarah lived in the family home near Arcadia in Hancock County, Ohio. There was Uncle Ira and Cerena his wife. They had no children. He was one of the so-called circuit riders who spent his life preaching the gospel in the rural sections. The usual program of these reunions was to come with baskets filled with food, greeting and embraces, and then a visit to the cemetery to honor their oldest brother Andrew.*

*Later visits at the old homestead brought many reminiscences and gave me an insight into the character of these wonderful men and women. I remember one day when Uncle Shell, with a twinkle in his eye, told me that looking out the window one morning he saw "Brother Stecker coming down the lane riding a horse. He had come, he said, to ask for the hand of Maria, the oldest daughter." Later Shell saw again a horse coming down the lane bearing another widow, Isaiah Holopeter, who asked the hand of Minerva, an orphaned cousin who was living with them. It wasn't many years after that that again a horse came down the lane, this time bearing Uncle John, who asked for the hand of Aunt Sarah. All members of this family were devout Christians, living, I would say, almost sanctified lives. One day Uncle Ira told of events in their lives, among others: "One day a neighbor brought payment for a purchase from Shell, a very long overdue. He offered Shell the money on Sunday. "I never saw Shell so mad in my life. His lips were white when he said, "Brother John, you know I never do business on Sunday."*

*Another bit of information relating to Aunt Minerva Holopeter: "When father died, Andrew, the oldest, took Minerva out under the starlit skies and said: "Minerva, as long as I have a roof over my head, you will not lack for a home." Minerva herself wanted to become a missionary. She attended Ohio Wesleyan University, but had to give up her dearest hope because of illness. This, it was thought, was a result of sacrifices she made in going to college. Uncle Isaiah too was a wealthy farmer, devoted to missions. Because he was unwilling to give his grapes to a winery he went as a huckster from door to door in Fostoria, Ohio. The \$2000 which he earned went directly to missions. Both he and Uncle Ira supported missionaries in the Orient, Bible women in India, and gave freely to local missions. Mother and I often thought it would have been fine if they had given help to the one we loved who himself was giving his life in preparation for the ministry. All in all, my knowledge of this family has proven to me that there are saints in this world.*

*As far as I know, Mother with her mother Mary Boltz and Andrew with their boys came to Wood County, Ohio, the latter part of the sixties. Andrew had been released from military duties due to an illness which he had incurred in the service. He passed away in 1876 leaving Mother with her four boys to carry on.*

*With her characteristic forthrightness and energy, she was able to build a real house in place of the log cabin and support herself and her family. She not only made many of their clothes, she would spin the yarn, knit the socks, cooked, went out and helped in the fields when it was necessary. No wonder they adored her. When Deloy became ill, she brought us back to the farm, and with Milan's help and Kurt's, his last days were relatively peaceful. Elmer and Oia at that time were living on another farm with their three children, Mary Ralph, and Deloy.*

*As I think back of those days, I see again some interesting scenes: Elmer, six-feet plus, two hundred pounds, following his little mother five feet tall, to show her the "proud flesh" that appeared on his cut finger. I can still see Oia with a quizzical smile as she watched the proceedings. Also I see little Mary, the apple of*

*Mother's eye, running around and asking, "Where's Grandma?" Whenever Mary would appear, Deloy would unconsciously say, "Where's Grandma."*

*One day when Grandma was away, Althea, Milan's wife and I were supposed to get dinner. We had planned an oven dinner. The stove was empty of kitchen utensils. Everything was quiet. It was no wonder that I and little Mary, when asked what we were doing and told me we were getting dinner, said, "It looks like a scrappy dinner." This pleased the four men who adored their mother, and in their hearts, I am sure, they felt that no daughter-in-law could match her.*

*I learned many things from this family and have the kindest memories of every member of the Jameson's. Now, as the very last living member, I should like to pay tribute to all of them for accepting me as a member of the Jameson clan."*

Mr. Jamison came to Iowa in 1854 with his parents settling in Wapello, Louisa co., IA. He was educated in

the common schools before going on to Iowa Wesleyan University at Mt. Pleasant. In 1868 he taught as a teacher in the Wapello public schools for two years before learning the livestock business in Texas and Missouri. Returning to Wapello Mr. Jamison went into livestocking until 1878 when he was employed as the Principal of the Wapello school system until 1883. Purchasing the Wapello Times, a weekly, Democratic newspaper, he moved its offices to Columbus Junction and changed its name to the Louisa County Times. This remained until January 1, 1886 when he sold it to George P. Neal who renamed it the Columbus Gazette, but printing now in his blood he rebought the publishing house in the following year. In the following years he collected bits of history and folklore which later proved of valuable interest to future historians in the area.

Mrs. Jamison was a grand daughter of British General McBain who fought against Napoleon at the Battle of Waterloo, 1815. William D. Jamison inherited his father's love for publishing becoming a practical printer and an excellent compositor in his father's business. He later went into publishing of his own paper at Shenandoah, Iowa. In the years ahead he was elected from that district into the House of Representatives and later went on to become a U. S. Senator. When he left Congress he opened a law office in Washington, D.C. from which he wrote a syndicated column called, "From My Window Seat". Active in the Democratic party he was appointed as finance chairman just after the close of WWI.

*"I was married just 41 years ago today to Sarah Jamison, daughter of Captain Jamison in his hotel in Cherokee. That was a day of excitement for we took some horse thieves and broke up a gang of them. The day before a man was in town trying to sell a team very cheap and some of the citizens became very suspicious of him and were on the alert. On the 22nd someone climbed to the top of the old mill and with the aid of a telescope was able to detect three men taking a wagon apart and hiding the parts in the bushes. A search showed they had the same team the man had been trying to sell in town the day before. Two of the men were found to be ring leaders of a gang operating in this vicinity and they were almost caught that day in a chase.*

*After all the flurry of their chasing, we were married that night, afterwards, we all went to a dance in the old Masonic Hall which was over the old school house. It all seems like yesterday, yet it was in 1872.*

*The next morning my wife and I drove with a mule team and spring wagon to Monmouth where we had relatives over across Lightning Creek. I came back to Cherokee the same morning in the rain and for three weeks no one could cross the creek. I was on this side and my wife on that."*[\(28\)](#)

The Hoffmans settled in Berks co., PA. in 1680, while Samuel Hoffman moved west to Circleville, OH before coming on to IL. in 1828.

Mr. Hoffman was educated in the common schools in Illinois and went on to teach and also farm. In May of 1871 he removed to Cherokee, Crawford co., KS. until January of 1874 and spent the following winter in Illinois before returning to Kansas in the spring. At the latter part of the year in 1875 he joined in a business partnership with John T. **Metcalf** over the Cherokee Index, a local newspaper. Buying out Metcalf, Hoffman went on alone with his publishing, his Democratic bent displayed in the editorials. In 1877 he removed the paper to Cherokee Co., KS., renamed it the Columbus Vidette for the county seat, and spent the following years as the Democratic mouthpiece in southeastern Kansas. In 1874 he became a member of the Masons, and was an advocate of "Temperance Principles."

*“In the name of God, Amen, I, Jacob Lockhart in Beverley Mannor in the County of Augusta in the Colony of Virginia, being sick in body but of perfect mind and memory, Thanks be to God therefore calling to mind the mortality of my body and knowing it is appointed for all men once to die do make and ordain this my last Will and Testament that is to say principally and first of all I give and recommend my Soul into the hands of God that gave it and for my Body I recommend to the earth to be buried in a Christian like and decent manner at the discretion of my executors not doubting at the general resurrection I shall receive the same again by the mighty power of God and as touching my worldly estate wherewith it has pleased God to bless me with in this life I give devise and dispose of the same in the following manner and form.....*

*Imprimis it is my will and I do order that all my just debts and funeral charges be paid and satisfied*

*Item I give and bequeath to my son James Lockhart ten pounds current mony of Virginia to be paid my son Jacob Lockhart five years after my decease and I likewise order that my son James Lockhart be allowed a being on the uper part of my plantation if he should be drove away from hsi home by Indians for the term of five years and likewise to leave the fences in good repair at the expiration of the said term.*

*Item I give and bequeath to my second son Jacob Lockhart all that part of my land lying being on the south side of Back Creek.*

*Item I give and bequeath to my youngest son, Levi Lockhart all the remainder part of my land lying and being on the northwest side of Back Creek, but if he the said Levi Lockhart should die in his non-age then the said land to go and be by my second son Jacob Lockhart pay or cause to be paid my two daughters Jane Lockhart and Elce Lockhart fifteen pounds current mony each of them the time of payment to be at the discretion of my executors and I likewise constitute make and ordain my well beloved friend John **Moffitt** and my son in law Matthew **Arbuckle** my only and sole executors of this my last Will and Testament and I do hereby utterly disannul revoke and disallow all and every other testament wills and legacies and executors by me in any ways before this time named will and bequeaths ratifying and conforming this and no other to be my last Will and Testament. In witness whereof I have unto set my hand and seal this thirtyeth day of January seven thousand seven hundred and seventy one.*

*I will and bequeath the plantation I formerly lived on in Bourbon County in Kentucky State to my two sons William Jamason and John Jamason also my son William Jamason five dollars also to my son John Jamason five dollars at my widows decease.*

*I will and bequeath all the land I now hold on Dare Crick to my three sons George Jamason Matthew Jamason and Jacob Jamason also my son Matthew Jamason one year old Bay Colt also my son Jacob Jamason one gray colt.*

*I will and bequeath to my Daughter Sarah Jamason one hundred acres of land I now live on also to my son Samuel Jamason one sorrel Mare with all the horses he now claims.*

*I will and bequeath to my well Beloved wife all the horses and cattle sheep and hogs I now claim the waggan and such and all the farming tools as long as she lives and at her death to be equally divided between my too sons Samuel Jamason and Merrit Jamason.*

*Also I will and Bequeath to my well Beloved wife the balance of the land I now live on and all the household furniture except what my daughter Sarah claims and at my widows death the land to be my son Merrit Jamason.*

*I will and Bequeath five dollars to my son Charles Jamason at the death of my well Beloved wife.*

*Also I will and Bequeath to my daughter Elizabeth five dollars to my daughter Mary five dollars.*

*And it is my last Will and Testament that James **Davis** John **McClain** Susannah Jamason shall be my whole and sole executors of this my last Will and Testament hereby revoking and renouncing all former wills and gifts and legacies confirming and no other to be my last will and testament. In witness whereof I have hereunto set my Hand and fixed my Seale this 29 Day of November the yare of our Lord one thousand eight hundred and fore. Declared by said William Jamason*

State of Iowa, Louisa County, Wafellow, February 19,1847

*Dear Nephew,*

*It was a conceivable source of pleasure to me to hear from you. I received your kind letter dated January the 3rd which informed me of your welfare. Today is rather wet and disagreeable and I was sitting in the house and thinking over matters and things and among other things, I thought of you and your family, and thought I would write you a letter and inform you of our being and well being.*

*We are all enjoying common health for which we are grateful to the donor of all blessings that we may enjoy both in time and eternity. We had some sickness in our family such as fever and guc. We are in about the same latitude that you are, but I think likely that it is colder here than it is where you live. The prairies here are large and the wind has a far sweep. We live four miles from Wafello. It is situated on the South bank of the Iowa River. I live nine miles from the Mississippi River. The country abounds with as good a land as there is in the world, but is a little too scarce of timber.*

*You said something about moving to Indiana. I would not advise you, it is owing to what price you can get for your land. If you can get ten or fifteen dollars per acre, then you had better sell and move to where you can get more land. Improved land here is worth four to ten dollars per acre. Our country is improving very fast.*

*I believe I will not say anything to you respecting politics or the Abolition Doctrine. I will just say that neither should engross too much of our time and very little abolition would be too much. Religion and Republicanism and Democracy should go hand in hand.*

*We have four children married namely Samuel, George, Susanah and Margaret. Samuel has two children, their names are Merit and Elizabeth. George has two, John and Jacob. Susan Vertrees has three, their names*

*are Margaret, Tuzy, and William. Margaret Johnson's husband has been dead these two years. She is living with us. She has one child, Mary Jane is its name.*

*We bought twelve hundred acres where we live, and we expect to live on it while we do live. Our boys are going to school. We built a Methodist meeting house one half mile from my house on my land, that is where the present school is taught.*

*We expect to have a protracted meeting commencing next Friday week. I would be pleased to have you here to hear what kind of a preacher you would make.*

*You didn't say anything about Zealy nor Visy and you mearly said William was to see you without any of the particulars.*

*Your Uncle Jacobs son Mathew came here last May and stayed until after harvest with us. William, your Uncle Samuels son was with us more than a year. We hear from Jacob and Uncle Samuel about once every month.*

*We are in a tolerable public place. If you have any notion of moving to Indiana or any other place, you had better start this spring, or next fall and look at it and then come on here and see Iowa. The distance seems to be an objection but starting in good earnest is the main point. I have traveled the road eleven times. Your Uncle Jacob and his son Mathew in their last letter said that they are both coming in the spring, say in April.*

*Since I have been in Findlay, though a good while ago. I think it is a low flat heavy timbered country and sickly but if you are pleased with your country you had better stay in it. I hold the doctrine that it is not what kind of a country a man lives in if he is pleased and satisfied with it. Then it is the place for him, and does wrong to leave it. But if he is dissatisfied, then let him move.*

*The family wishes to be remembered to you all. Will now bring my unpolished address to a close.*

*You say you are all Mehodist, I would only say be faithful and stick to your integrity, and may the God of all please bless you and yours. Farewell to you Ira and all the family. If we never meet in this world, may we meet in that blessed world where parting will be no more.*

*"In the name of God Amen, I David Jameson of the County of Mason and State of Ky. being weak in body but sound in mind do make this instrument of writing my last will and Testament revoking all others.*

*2nd I give and bequeath to my son Benjamin W. Jameson one hundred & twenty acres of the farm on which I now reside on the turnpike road two miles above Mays licke to include the improvements to be taken off the northwest side of Said farm as run by Eli M. **Pogne** to him and his heirs forever I of oxen carte & farming utencils also my rifle gun, Its my will and devise that my son Benjamin become the purchaser of the balance of my farm on the turnpike road at sutch or piece & payment ints as the parties concimed may think just and right and the proceeds of said land to be divised as hereafter named.*

*3rd I give and bequeath to my son John M. Jameson ale my land in Marion county State of Indiana lying on the waters of Fale creek, the farm on which he now resides to him and his heirs forever I also give to my son John my horse buggy & harness I also will to my son John forty dollars of the proceeds of the above named*



land for which he is to purchase a good two year old horse colt and present it to his son David and let him know its a present from his grandpah I also will to my son John my silver watch

4th I give and bequeath to my daughter Hetty **Allen** fourteen hundred dollars eight hundred and fifty of which she received also I give to my daughter Hetty one horse saddle and bridle one cow and heiffer also two beds complete one bureau also my rocking chair also mine table spoons and one set of teaspoons and cream spoon all of which last named articals she has received except the bureau & rocking chair-. Its my will and desire that three hundred dollars of the five hundred & fifty dollars not yet received of the bequeath to my daughter Hetty shall be given of a debt of six hundred dollars coming to me from Newton **Clift** so soon collected the ballance from the proceeds of the land above named.

5th I will and bequeath to my Daughter Julian Longnaker fourteen hundred dollars, eight hundred & fifty dollars of which she has received also I give to my daughter Julian one horse saddle & bridle one cow & calf one bed and bedstead one press & stand with drawers one wardrobe also nine table spoons ale of which last named articles she has received the remaining five hundred & fifty dollars Julian is to receive from the same sources named in the above item to my daughter, Hetty.

6th I give to my son Benjamin one family Bible one testament & websters dictionary the balance of my books not given to my other children to be equally divided among surviving children.

7th I give to my sister Rebecca one hundred & thirty dollars

8th I give and bequeath to my brother Bennoni eighty dollars.

9th I give and bequeath to my two grand daughters children of my deceased son Aquila M. Jameson five hundred dollars each in the hands of my son Benjamin to be laid out in land in some healthy section in some of those new Cpuntries where he may may think it most to the interest and advantage of those children and if he cannot obtain such lands as he may think suitable at congress price its my wish he should make the best arrangement \_\_\_\_\_ that he can and that htis purchase be made as soon as they marry or become of age if either or both of these grand daughters should die without issue the above named lands or money shall fall back into the hands of my present remaining children.

10th Its mt will that ale the balance of my household furniture shal go to my son Benjamin that I have not heretofore given.

11th Its my will and desire that ale the overplus of money or property after amply complying with ale the above Bequests so shall be equall divided among my four children Benjamin John Hetty Julian and if any money

shall be on hands or arising from any source not named shall thus equally be divided.

12th Its my will and desire should my two grandsons David Longnaker and William David Allen live until they are eighteen years of age in that case I wish out of the proceeds of the money bequeathed to their mothers they each should be presented with a horse colt worth forty dollars each.

13th I do hereby constitute and appoint my son B. W. Jameson and my son in law Jacob **Longnaker** executors of this my last will and Testament whereof I have set my hand and seal this thirtyeth day of November Eighteen hundred fifty I wrote the above with my own hand

*Black Hank City, Colorado Teretory January the 29:1865*

*Mr Jameson,*

*I take my pen in hand with great pleasure this morning to inform you that I am still mending, but very slow. I hope and trust God that I may be able to work in the spring. Well I hope these few lines will find you well and hardy as a duck.*

*I received your letter last Saturday night and was very glad to hear from old Shell for the first time. I would have written to you long long ago but I did not know where you was. Please excuse me for not writing to you any sooner, if you don't rewrite. I don't care a dam, suit yourself about that. I am that poor, I had no hard on for the last 16 months, you may guess how I feel about that.*

*We have had some dasut cold weather here this winter. But now the weather is just as nice as you please now. Times are dull here now, but there is some prospects for big wages next spring. The Indians are very hostile on the plains now. There has been no custom mail for a long time until last Saturday. I got two letters, one from you and one from somebody else.*

*The news is now that Old Abe has got tired of freeing the God Dam negros. Bully for Old Abe.*

*Well Shell, I am very glad that you are doing so fine among the girls. I will have to give you credit for that. But don't get to great with my wife or else it will be deerskin for you. I will tell you in time so you can look out for something when I get back again.*

*There was one bran new \_\_\_\_\_ tore all to hell at the Junction house the other day. But I had no share of it you might know that I have not got that far along yet. Tell Bill Damand that I would like to know what extra twist he gives his women whom he made that young one.*

*I know nothing of any importance to write. I sent my last and best respects to you and all inquiring friends now at this time. Please write soon and make it pretty long.*
