BENJAMIN JAMESON OF LOUDON COUNTY, VIRGINIA

[35000-36599]

NOTES

Some genealogies can be so difficult they elude attempts at even the most obvious in research: never leave any stone unturned. Yet, it appears, that is exactly what occurred over the decades as many family historians wend their way into the lives of this particular family branch and failing to further the search of the ancestor concentrated entirely on the balance of the family. This, and many other research problems, has created such situations that much of the work done between the early 1900s to the late 1970s has carelessly included work never verified. The following account is a clearer picture of Benjamin Jameson and his family and his links to an ancestry that still eludes us.

35000-1 BENJAMIN JAMESON [(Robert?) or (John?)], born circa 1740, possibly in Virginia, or Maryland traditionally listed as the son of John and Becky (**Young**) Jameson. He died in 1816 in Greene county, Tennessee. Mr. Jameson married Jane (**Campbell?**) who died between 1818-1822 on the old farm in Greenville, TN., possibly the sister of Arthur **Campbell**.

Notes:

Two situations that has plagued Benjamin Jameson to this day are: his parentage, and the surname of his wife,

Jane. In the first rumors and tradition contend that Mr. Jameson came from New Jersey. Rev. Jameson's account in his 1901 book, The Jamesons in America, states, "Benjamin Jameson...came from Ireland about 1747, and settled in New Jersey, and later removed to Virginia."*(1) However, as with much of Rev. **Jameson's** publication, there is no substantiation to the foregoing statement. Early archive records of New Jersey (prior to 1820) show no record of any Benjamin Jameson, or spelling thereof, having resided in New Jersey. With the loss of census materials before this period, Accelerated Indexing Systems International of Salt Lake City, Utah has attempted to research early land deeds, tax records, and a host of other original documents in the hopes of putting together some sort of early census. What has emerged so far provides no evidence of Mr. Jameson's or Mr. Henry **Farnsworth's***(2) early residency in that state. While both the Farnsworths*(3) and the Jamesons are found in New Jersey records, none have proven to be the antecedents for either man. One recent 20th century family member from McFall, Missouri recalls a family Bible showing Benjamin's father as John Jameson. This important piece of evidence has since been lost, stolen, or destroyed and research up to this time has failed to yield any truth in the matter. Along with this another researcher out of Oklahoma City, OK. has indicated that John and Becky (**Young**) Jameson were Benjamin's parents[11]. So far no proof.

Some of the families that are tied to the Jamesons of this branch were the Campbells, Gass's, McKeehan's, and the Farnsworths who might provide some clue to Jameson's origins. Among the Campbells both Arthur and his brother, William Campbell, both prominent men of the time, were at the Battle of King's Mountain. Arthur **Campbell** was born in 1742 in Augusta Co., VA. and died May 3, 1810 in Kentucky. He helped formulate and push through to Congress the creation of the state of Franklin with John Sevier, which eventually failed. He married first, Margaret _____, and later Elizabeth _____. They had 12 children: William, John B., Charles Lewis, Arthur Lee, James Henry, David Henry, Elizabeth, Margaret, Mary B., who married a Mr. **Beard**, Jane B., Martha C., and Ann Augusta. Arthur's brother, William Campbell married, Elizabeth, a sister of then Gov. Patrick **Henry**. Mr. Campbell was one of the leaders at the battle of King's Mtn. There is a distinct possibility that Arthur and William Campbell may have had a sister, Jane, or a relative of their's who might have been the one to marry Benjamin Jameson.

HENRY FARNSWORTH was born about 1740, possibly in New Jersey. He was married twice, first to Margaret **McKeeham**, and second on November 12, 1807, Greene co., TN. to Elizabeth **Bennett**. He may have been a son of Henry Farnsworth Sr. of NJ. Upon arriving in Virginia, Farnsworth joined the militia in the French & Indian Wars *(4). He was a Lt. and a Capt., the latter at King's Mtn., during the Revolutionary War. He was recommended to the rank of Lieutenant, May 1778. Some of those who attained rank at the same time were: James **Whaley** Jr., 2nd Lt; William Carnan, Ensign; Daniel Lewis, 2nd Lt.; Josias Miles, Lt.; Thomas **King**, Lt.; Hugh Douglas, Ensign; Isaac Vandeventer, Lt.; John Dodd, Ensign; George Summers, Col.; William McClelland, Capt.; Robert McClain, Capt.; John Henry, Capt.; Samuel Cox, Major; John **Williams**, Lt.; George Tyler, Lt.; Nathaniel Adams, Lt.; George Mason, Lt.; and William Elliot, Lt.

"When War began, the Gentlemen justices of the County's court recommended certain of her men to the Governor from time to time as worthy of commissions in the military forces being raised by the Colony. Many an old and familiar name appears on the list and for the interest of their descendants and relatives it is here appended as abstracted from the County records by James W. Head in his very useful History of Loudon. Among the names recommended in May of 1778 were: Henry Farnsworth, LT.[14]" Additionally, Farnsworth took military oath September 14, 1778, Loudon co., VA. Mr. Farnsworth's brother, John, was killed prior to April 14, 1778 in the War. In an early indenture dated April 7, 1772 mentions is made of Henry's two sons, John and George. The instrument was between Sidney **Clark** of Barbadoes (represented by his attorneys, George William **Fairfax** and Bryan Fairfax, all of Loudon co., VA.) and Henry Farnsworth "in consideration of rents granted to farm a certain parcel of land lying in Loudoun co., for and during the natural lives of him the said Henry Farnsworth, John Farnsworth and George Farnsworth, his sons, and the longest living of them..." He resided in Loudon co., VA and moved to Greene co., TN. receiving a 1000 acre tract for his North

Carolina military services during the war. The land was situated at Richland Creek, a tributary of the Nolachunky River, upon which he built a grist mill and later deeded to his sons, John and David. The children were:

While New Jersey may remain a viable option at some future point, recent research has uncovered evidence of other residencies. Tithable records for Loudon County, VA. show the following information:[11][*\(8\)](#).

Of interest here are the names Robert, Alexander, William, and John Jameson, all brothers. These Jamesons

with an “i” in their surname were from Bucks county, PA., all sons of.....

.....(4) **26512-2 ALEXANDER JAMISON** [Henry], who was born 1700, northern Ireland (possibly County Tyrone) the son of Henry and Jane Jamison (26500). He died in March of 1749, Bucks co., PA. Mr. Jamison married November 30, 1727, Bucks co., Pa. Martha **Rickey**{**Richey**}, the daughter of Jonathan Richey.

(5) 26544 Alexander, b. 1743; m. 10/21{23}/1783, Elizabeth **Carmichael**[2].” As you can see, this leaves only two names, Benjamin and George Jameson. Plus, the tithables show that Benjamin Jameson is recorded just one year after Robert Jamison and that George Jameson is listed as at the same time as Alexander Jamison. There is a strong likelihood that Benjamin and George Jameson might have been sons of Alexander and Martha Jamison. Both Christian names George and Benjamin do appear in the Bucks co., PA. family descent.

Among these tithables is also discovered the name of Samuel **McKeeham**, who was a brother of Margaret **McKeeham**, who married and became Henry Farnsworth’s first wife. In her brother’s will Samuel McKeeham speaks of Farnsworth as, “...as my brother-in-law.”[3] The Early Tennessee Tax Lists shows: Jameson-George, Benjamin, & Robert

McKeehan-Benjamin, Margaret

Farnsworth-Benjamin, David, George, Henry Sr., John, & Robert.

The 1812 Tax Lists provide:

Capt. William **Guin** District-Benjamin Jamison; John McKeehan, Benjamin, David, Henry Sr. & Henry Jr. Farnsworth.

While others have zeroed in on New Jersey, it has always been my contention that Benjamin Jameson was related to the Jamesons in the immediate area of Loudon co., VA. This takes in the Jamesons of Charles and Frederick counties, Maryland. Location, Christian names, family associations, and interrelationships all have played an important part in determining this ancestors parentage. Having established his earliest residence it is no coincidence that just across the state line from Loudon co., Va. is Frederick co., MD. where many of the Charles county Jamesons resided in the early 1700s. The only problem with this scenario is that the Charles co., MD. family was and is Catholic. Benjamin Jameson was Protestant.

There are four Jameson family branches worth noting:

(1) Alexander Jemmeson of Kent county, Maryland[39000] and (2) Thomas Jameson of Cecil County, Maryland[39500], who, not surprisingly, may have been a son of Alexander Jemmeson. Additionally, there was a (3) Robert Jameson[28800] of Frederick county, MD. who may also have some association with either one of these families, though that relationship is not clear nor been researched in full, and is documented more fully below. And lastly, (4) Alexander Jamison of Bucks co., PA.

(1) Alexander Jemmeson removed to Kent county, MD.[13](see map below). When he died his wife, Janett, and their children with the help of the elder son, Andrew, removed to Duck Creek Hundred in Kent Co., Delaware[14]. Here, nestled in the thickly forested hills of Duck Creek can be found the family of the **Reeces** whose daughter, Rebecca, married Benjamin's son, Samuel Young Jameson. It is this connection with respect to locality that has prompted an investigation into the Jamesons now being explored.

Of more than passing interest (2) Thomas Jameson[39500] was first discovered in Carroll county, Maryland. He later settled in Charles county, MD. where he died. The close similarity in children's first names, non-Jameson family interrelationships like the Smiths, Wilsons, and Jones, and location all serve to tie these three Jameson families together with Benjamin Jameson of Loudon co., VA. Thomas' grandson, Henry Joshua Jameson, removed to Frederick co., MD. in 1774. I can only surmised that these Jamesons might have been related to Benjamin Jameson, the man now under discussion.

He may also be the son of (3) Robert and Sarah Jameson of Frederick co., MD, too. Could the Robert Jameson shown in Loudon county's tithable records have been the Robert Jameson who settled in Frederick co., MD? There are Benjamin's in both families so either the coincidences are real or the relationships are. Evidence uncovered suggests that there may be more than a passing coincidence between Robert Jameson and Benjamin Jameson.

ROBERT JAMESON I(28800), was born circa 1720s, no place yet identified, nor other history beyond this date. He died prior to 1792, since his son, Robert Jameson II had control of the land in Frederick county, MD at that time and had sold part of this in that year. This presumes that Robert Jameson Sr. was either dead or had moved. Mr. Jameson Sr. married circa 1743, Sarah _____ and no other information has provided details of her life. They resided in Frederick county, Maryland.

Notes:

One of the first records appears on December 17, 1756, a patent on "Move About", granted in the Merryland Tract (Frederick co., MD) consisting of approximately 20 acres. It was located between the small draught in the lock of Coshocton Mountain about a half mile from Wanred Ryons, beholden of Conequocke Manor. This land was later sold in March 20, 1760 to John **Boyon** for 30 Shillings. "Samuel's Greviences" was patented by him in 1761 and later sold to Conrad **Hockensmith** and wife Sarah released her power of thirds. On September 5, 1761, Charles **Carroll** of Annapolis, MD. sold to Jameson 120 acres of "Watson's Delight" which included the buildings and any improvements upon the land as well.

Mr. Jameson died intestate, his son inheriting the entire estate under the laws then in effect. These land transactions of the elder Robert occurred up until 1761, but after this time nothing else has provided any clue to Mr. Jameson's whereabouts. It isn't even known if he died in Frederick co., MD. Of course he could have spent the entire time from 1761 to his death farming only, but the unlikelihood of no other court/deed

transactions make this appear unlikely. The lack of records in Maryland concerning the elder Robert provides gist for thought. It is worthwhile to note, however, that a Robert Jameson appears in Loudon co., Virginia some time in the 1760s. With only a state border between the two counties, and only miles from each other, circumstances may dictate on whether Robert Jameson I either died in Frederick co., MD. or perhaps, he died in Loudon co., VA., instead. Tax records in Loudon co., VA. show Robert Jameson listed for the years 1768 to 1778. Additionally, land records in Frederick co. point to transactions to the early 1780s and quit. A land deed dated December 8, 1770 from John **Vestall** of Frederick co., MD. to Robert Jameson of Loudon county, VA. for 150 acres in Loudon co, plus an extra 32 acres in another tract provides some link between the two counties. Another deed dated April 18, 1780 shows Robert Jameson selling to Peter **Kiphart** land which was recorded the following August 14th.

Listed with Robert Jameson in Shelburn Parish was also Alexander Jammeson, George Jammeson(too old to have been Benajmin Jameson's eldest son), Benjamin Jammeson, and John Jameson. It is not altogether impossible to believe that these men were all related. Together, these indictments stand as testimony for circumstantial parentage for Benjamin Jameson and his descendancy. With further research more may be learned to add to this perplexing situation.

Notes:

Mr. Jameson purchased in November 23, 1770, for 50 pounds from Garrett **Wilson** "Second Addition of Brookes Discovery". On January 11, 1781, he bought from Christopher **Ohaver** of Frederick co., MD. a piece of property called "Addition to Brookes Discovery" which he purchased from Robert **Miller**, in which he got it from James **Brooke**. Both tracts border his father's estate, "Watsons Delight". On June 9, 1784 Mr. Jameson and wife, Jane, sold "Second Edition of Brookes Discovery" to Michael **Barndoller** for six pounds, three shillings, and nine pence. This land was situated near a tract called "Peggy and Molly Delight" and Piney Creek. He and Jane, then, sold to John **Gwinn** Jr. for 38 pounds a part of the tract called "Watsons Delight" on March 23 1786. Four years later on April 15, Robert and Jane Jameson sell to Thomas **Jones** 60 acres known as "Second Addition to Brookes Discovery". The Jamesons resided in Taney Town Hundred. On November 10, 1792, Robert Jameson and Eleanor, his wife, deed to John **Groom**, 10  acres of "Addition to Watsons Delight" that portion adjacent to "Brooks Desire" conveyed to Jameson by James Brooke.

Mr. Jameson appears to be the eldest of several children. The fact that he inherited, via intestate probate, the entire lands in Frederick co., attests to the fact that he never seriously considered Loudon co., VA unlike several other Jamesons of possible relationship. Mr. Jameson's will was dated December 16, 1813, and probated May 3, 1815, Frederick co., Maryland. He bequeaths to son, Benjamin, the main plantation, separate from the land his son, John, already possesses, which was a part of "Watsons Delight". The residue went to son, John, and a dollar each to his children: Samuel, Susanna, Patrick, Jane, Sarah **Garrett**, Martha, William, and Robert. Executor, son, Benjamin Jameson. Witnesses: John M. **Coskeky***⁽⁹⁾ & Hugh **Shaw**. Benjamin Jameson, however, did not serve nor would son John administer their father's estate writing to the court within ten days of his father's signing the will - "*Gentlemen-I hereby relinquish my right of administration of my Father's Estate and take the liberty of recommending to your Honors Mr. Henry **Spalding** if you should think proper to grant him letters of administration on the said Estate your compliance will be much obliged, Gentlemen, your humble servant, John Jamison*".

- Samuel Jamison, is he the one listed in 1790 Census for Washington county with 1 male over 16, 2 males under 16, 3 females and no slaves?

Benjamin Jameson had been actively involved in some capacity with the military during the Revolutionary war. The difficulty is what and exactly when. His friend, Henry Farnsworth, was present at the Battle of King's Mountain, North Carolina in 1780. The leaders of this expedition were John **Sevier**, a co-instigator of Franklin and later Governor of Tennessee, and Arthur **Campbell**, the originator of the Holstein Settlements and with Sevier strove to create the new state*⁽¹⁰⁾. Ben Jameson received from the state of North Carolina a military land grant for 100 acres on September 20, 1787[1] situated in Greenville, Green County, TN. However, Benjamin had already settled in Greene county by 1783[10]. He left Loudon county, Virginia and traveled down the Great Indian Warpath which sprang out of Philadelphia going west to York county, Pennsylvania before heading south through Gettysburg, Frederick co., Md., and Loudon county, VA. From there it sliced neatly into the Holstein Settlements on the eastern fringe of the future state of Tennessee, but then called the State of Franklin, which was carved out of western North Carolina and southwestern Virginia, before ending at Walker county, Georgia. As early as August of 1783 Benjamin Jameson (and John **Reece**) were on the Grand Jury for the first Term of the Court of Common Pleas and again the February following in 1784[3] in Greenville. He settled along Holley Creek adjoining the lands of John **McCroskey**, Nathaniel **McClure**, and Henry Farnsworth. The deed was dated Sept. 20, 1787 and registered September 4, 1788. He also owned land at Burnt Cabin Place, and this pops up in a deed, dated September 20, 1787, from Richard

Caswell to H. Farnsworth for 224 acres in Greene co., TN., joining B. Jameson's land "that lies upon the waters that Burnt Cabin Place is upon." Interestingly enough his Virginia roots were never far away. On March 11, 1785 he and James **McKeehan** were subscribing witnesses to the Last Will and Testament of Samuel **McKeeham** in the State of Franklin[3]. Mentioned in the will was McKeeham's wife and three children -Margaret, James, and Mary. Executors were his wife and Henry **Farnsworth***(11). In the February term of 1786 "...a road was laid out from the Courthouse to Epperson's Ford on Lick Creek, since called Hodge Ford", and that Peter **Blake**, George **Piercy**, Robert **Campbell**, David **Russell**, William **Morrow**, Robert **Hood**, John **Gibson**, Henry **Farnsworth**, David **Allison**, William **Ross**, Adam **Morrow**, Alexander **McCalpin**, Anthony **Moore**, John **Stone**, John **Beard**, Benjamin Jameson, and Mat **Lepor** "...view and mark same and make report of the conveniences and inconveniences thereof to our next Court." [3] On February 3, 1790 Benjamin Jameson et al sold to John and Thomas **Temple** 324 acres. He sold to the Temples 406 acres May 11, 1795 and then an additional 100 acres to them January 25, 1803. Henry Farnsworth sold to Benjamin 624 acres and right after this, February 10, 1795, Benjamin sold the 624 acres to John and Thomas Temple.

Mr. Jameson's will was dated December 13, 1807, Greenville, TN. and proved April{July} 22, 1816, Greene co., TN. He mentions wife, Jane, and bequeaths to her all profits arising from the plantation for her natural life, plus all personal property. Upon her death all real and personal estate she owns was to be sold and equally divided among his children, except for 100 acres to son, Robert. Jane Jameson and Robert **Guin** were executors and the will was witnessed by John McKeehan and Ephraim **Wilson**. On February 1, 1822 a disposition was made that read in part "...that said Robert Jameson of his death had never been married...that his brothers are George Jamieson, John Jamieson, Samuel Jamieson, Henry Jamieson, and his sisters are Anne Williams, the wife of John Williams, Jane Farnsworth, the wife of John Farnsworth, and Nancy, widow of George Farnsworth. Whereupon it is ordered by the Court that the disposition of the said John **Kubnigh** and John McKeehan be recorded and that it be duly certified according to said disposition that the said brothers and sisters of Robert Jamieson are his heirs at law according to the Laws of the state of Tennessee of which the said Robert Jamieson was a citizen at the time of his enlistment."

Mr. Jameson, like his father, was given a military grant of land through the North Carolina grants for services rendered during the Revolutionary War. In his pension application, dated August 22, 1786, Greene co., TN., George indicated that he had been wounded during the late War. No indication, ditto his father, has determined what that military service was, though it is likely they were both at King's Mtn. in 1780 as was Henry **Farnsworth**. The land he received was 200 acres along the branch waters(Burneys Branch) of the Little Clinchy, bordering Richard **Woods** line. The deed was dated July 12th and registered October 29, 1794. In 1810 he conveyed via the Sheriff a 300 acre tract to Conrad Hulvey January 23rd. Jameson left North Carolina sometime before 1787, the first year he was taxed. Records document him in 1784 in which suit was brought against him by the State of North Carolina for rioting. He was proclaimed guilty and fined, a resident of Greenville, TN. He was on the Grand Jury in 1787, 1789,1791, and in 1794. He was taxed in 1805 and he provided bond securities for the following marriages:

Sarah **Gibson** 11/5/1796 to Moses **Reeves**;

Elizabeth **Lauderdale** 8/7/1797 to James **McKeehan**;

Peggy **Morrison** 10/1/1808 to John **Kerbough**;

Polly **Kerbough** 11/22/1810 to Frederick **Myers**.

Security for his own marriage to Elizabeth Reaves/Reeves was provided by Nathaniel **McMore** and North M. **Morris**, and witnessed by William **Reser** and Catherine **McKeghan**. Miss Reaves' parents may not have been able to come up with the bond for their daughter. McMore and Morris were probably sons-in-law of Mr. Reaves, Elizabeth's father, and came to the rescue, possibly. What relationship existed between and among the above bonded people is not presently known, though the McKeehan's and the Reeve's, obviously, had some tie-in to George Jameson. Mr. Jameson appears to have been well off in his time. Much to his business in securities he and Thomas Graham secured bonds for John **Graham** and P. **Larceny** in a suit brought by the State of NC and James **Galbraith** April 28, 1808. He secured a bond for his daughters, Elizabeth "Betsy" and

for Jenney's. On January 23, 1810, George Jameson sold to Conrad Hulvey 300 acres of land in Greene co., TN. Miss Reave's father, John Reaves, Sr. administered his deceased son's, John Reaves Jr., estate August 14, 1792. He enters into a bond with George Jameson and John **Stone** in the amount of 100 pounds.

Mr. Jameson in January of 1817 gave Power of Attorney to David Farnsworth later proven in Court by the oaths of John **Allison** and Hugh **Wilson**.

Notes:

Mr. Jameson was a prominent man in Greene co., TN. He removed from Loudon co., VA. at the same time as his parents and older brother, George, in 1783 or earlier. He was given a military land grant by the state of North Carolina for 30 acres October 3, 1821 in Greene co., TN. for services recognized as being rendered by him. It appears to come to him much later in life than that of his relatives. Like his father and older brother, no explanation has been determined as to what the military service was; perhaps Kings Mtn? Some sources indicate that Samuel and his family were in Christian co., KY. in 1800. It appears he owned 200 acres there on September 25, 1799 near Reen's Lick Creek, and in the following year, July 22, 1800, was taxed on it. Tax records for Kentucky show he owned land there from 1799 to 1805. He removed to Knox co., TN. in 1806 and owned land there until 1817. In a land deed dated February of 1814, he purchased 100 acres on Fountain Creek from Jonas **Kendrick**. After this he moves back and forth between Greene and Monroe counties. An indenture was made on July 12 1821 between Samuel & Rebecca Jameson of Monroe co., TN. and David **Miller** of Harlan co., KY for \$1500.00 for a 208 acre tract situated in Knox co., KY on the north side of the

Cumberland River. In Monroe co., TN. he was a member of the Cleveland Baptist Church in 1820 and in the following year became its Clerk and Deacon. Some difficulties arose within the church membership and in 1822 Samuel Jameson and others propose a separation of the Baptist Church. Bethel Baptist Church in Sweetwater, TN. gained its independence in 1822 and there Jameson became its Clerk. He switched churches from Hopewell Baptist Church in 1825 by a letter to Pond Creek Baptist Church. In the following year he was a Delegate to a Baptist Association gathering, but for reasons unknown he was dismissed by Pond Creek in 1830. Prior to this he resided in Greene co., TN. He gave security for his sister, Anne's marriage in 1790 to John **Williams** and to Rebecca **Sullivan**'s marriage April 2 1791 to John **McKeehan**. He was listed on the Grand Jury in Greene co., TN. from 1791 to 1795, on the Jury in Blount co., TN. in 1798, and appointed in Greene co., TN. again in 1818. In 1808 he enters into bond with George **McKeehan** and Even **Allison** as securities in the sum of \$300.00 for the maintenance of a bastard child born of McKeehan and Elenor **Burnet**. He partakes of a Deed of Conveyance from Conrad **Hulvey** January 24, 1815 for 200 acres. Samuel in 1822 was a witness in a suit brought by William **Glass** against Samuel **Vance** and Ephraim **Wilson**. He sold a 200 and a 30 acre parcel January 23, 1823 to Adam **Proffit**.

His will was dated August 20th 1834, Greene co., TN. and proved in 1836. Executors were Samuel Y. Jameson and Robert **Snead**; witnesses-Robert Snead & Leonard **Harrison**. He mentions sons, John R., Benjamin, David, Samuel Y., and Hiram J. Jameson along with daughters, Jane M. **Wilson**, Eleanor T. **Reynolds**, and Rebecca R. Jameson. His farm he gave over to sons, Samuel Y. Jameson, Robert W. Jameson, and Hiram J. Jameson, subject to the maintenance of their mother until her death or remarriage. Mrs. Jameson and her daughter, Rebecca, after Samuel's death moved in with her son, Samuel Young Jameson II and his family residing then in Macedonia, Union(Towns) co., GA. Mrs. Jameson died there and was interred at the Jameson Family Cemetery now called the Macedonia Cemetery.

The Reece's were from New Castle Co., DE. Rebecca's parents were Jehu Reece and her mother Eleanor Thomas, both of DE. David Reeces ^{*(13)}, the father of Jehu Reece, dated his will November 19, 1762, New Castle, DE. He married a Miss **Williams**, a daughter of Roger(will dated Oct. 5, 1741) and Margaret Williams. From this union the children were:

A road was laid off from Warm Springs on French Broad River to Greeneville, TN and surveyed by Henry Jamison, 1786, along with Jno. **Lee**, Chas. **Robinson**, Joseph **Colyer**, Samuel **Wilson**, Andrew **Miller**, Equilor **Sherrill**, Thomas **Gilbreath**, and Mat **Lepor**.

By 1822, Henry was mentioned in a desposition made out for his brother, Robert Jameson, as still living. It does not indicate if he continued to remain in Greene co.

Mr. and Mrs. Farnsworth resided in Greenville. Records show they were annually taxed on their estate in Greeneville from 1805 on. Their marriage was secured by his father's bond. Jeremiah Farnsworth's will was dated 1854. Agnes Jameson Farnsworth's will was dated April 3, 1839, Greeneville, TN. and proved 1840. In it she says...

“In the name of God Amen,

I Agnes Farnsworth of the County of Greene and State of Tennessee feeling very weak in body but of perfect mind and memory and calling to mind that it is appointed unto man to die. I hereby make and ordain this my last Will and Testament and first of all and principally I recommend my soul to God who gave it me and my body to be buried in a Christian like manner at the discretion of my surviving friends and as touching such worldly prosperity as it hath pleased God to help me with I give and dispose of in the following manner to wit: first I give and bequeath unto my beloved son Jeremiah Farnsworth a coulored man by the name of Tinnesse to have and to hold as his rightfull property to be used by him his heirs and assigns-

Secondly, I give and bequeath unto my beloved son Robert Farnsworth a coulored man by the name of Wesley

to have and used by him and his heirs and assigns,

Thirdly, I give and bequeath unto my beloved son George Farnsworth a coulored man by the name of Jeremiah to have and to hold as his rightfull property to be used as such by him and his heirs and assigns,

*Fourthly, I give and bequeath unto my beloved daughter Malinda and James, her husband, a coulored woman by the name of Mahalu to have and hold as their rightfull property and theirs and heirs and assigns to be used as such and as it respects by beloved daughters Dorcus Farnsworth and Dinah Gillmartens: Dorcas or husband David Farnsworth has had a deed of gift for a coulored girl named Mary Ann and Dinah or husband Tom Gillmartens has had a deed of gift for a coulored girl also named Mary Ann and touching the Ballance of my property I give and bequeath as follows to wit I give and bequeath to my beloved daughter Malinda a feather bed and a _____ bed or sheets quilt blanket and a counterpain a bolster and pillows and my walnut cubbord to have and hold as his right property. The balance of my property to be sold at publick sale and two notes that I have one upon David Farnsworth and one on Thor **Rundalds** these two notes are to be collected by my executors and their amount with the amount of the sale of the property must be equally divided among my heirs whohad been heretofore named in this will. And I hereby make and ordain my trusty friends Jeremiah Farnsworth and James as executors of this my last Will and Testement hereby cancelling all other wills to be made by me. In witness whereof I have here set my hand and seal this third day of April 1839.*

Thomas Gillenwater's mother was a descendant of John **Haynie**, who emigrated to Virginia circa 1650 ^{*(16)}. Robert Hargrove Haynie, a desc. of John Haynie, was born 11/1/1856, TX.; d. 1/3/1882, Brenham, TX; m. 12/25/1879 to Nellie **Brophy**^{*(17)}, ceremony by Rev. **Riggs**. Nellie d. 1937, was the dau. of John and Margaret (**Jamison**) Brophy. Mr. Brophy was a veteran of the US/Mex War and a Confederate Soldier during the Civil War. He emigrated from Ireland and died abt. the age of 100 years. Nellie's grandfather was Isaac Jamison who came to Texas with Stephen **Austin**'s 1st 300. The original spanish land grant was signed by Austin in 1821, in Brenham, Washington co., TX. Margaret Jamison, Nellie's grandmother, was married March 3, 1841, Washington co., TX. to Major John **Gray**, a member of Samuel **Houston**'s army at San Jacinto before her marriage to Isaac Jamison. Isaac Jamison has traditionally been linked to Green B. Jamison (#47000), a brother, in fact who built the fortifications at the Alamo and died there in its defense. But there has been no evidence linking these two as yet.

35016-2 ROBERT W. JAMESON [Benjamin], was born circa 1773, Loudon co., Virginia, the son and seventh child of Benjamin and Jane Jameson (35000). Mr. Jameson never married. He was killed in action on December 18, 1813 at Fort Niagara, New York during the War of 1812. Mr. Jameson settled onto an adjoining piece of property given him by his father, Benjamin. Unfortunately, Robert fell into debt and the land over a short period of time was parceled or sold to pay for those owed money. Some of these litigations were: Mary **Krotsinger** vs Robert W. Jameson-plaintiff recovered judgment against Jameson for \$7.70 plus court costs in early 1812. Since Robert had no personal property of his own the constable levied a fine on Benjamin Jameson plantation located on the north side of the Nolichucky River; Davis **Dealench** vs Robert W. Jameson-plaintiff recovered a debt August 8, 1812 for \$67.83 plus court costs. Again Benj. Jameson's land on Richland Creek was levied to satisfy the debt; John **Russell** vs Robert W. Jameson-plaintiff recovers debt of \$94.05 December 22, 1812 on Benj. Jameson's land. Robert Jameson witnessed a Bill of Sale from Henry **Farnsworth** Sr., to David Farnsworth, September 7, 1812, for a negroe boy named Will. In a case brought to court, Robert Jameson asked for special bail for Robert **Burns**, defendant, vs. Hugh **Evans**, 1808. Mr. Jameson was a witness for Daniel **Guin**, July 26, 1803.

Robert Jameson enlisted into the army during the 1812 War. He was stationed at Fort Niagara, a historic fort occupying a reservation of 288 acres at the mouth of the Niagara River opposite the Canadian village of Niagara-on-the-Lake. Here, the U. S. forces had occupied the site since 1796, when British forces evacuated the place in accordance with the Treaty of Paris, 1783. In December of 1813, the British forces overwhelmed the U. S. Army stationed there, capturing first Fort George and shortly afterwards Fort Niagara in a bloody battle. Before relinquishing the fortified town of Fort George the United States Army had burned the towns of Newark and part of Queenston. In retaliation the British in an unusual show of ferocity assaulted Fort Niagara, then let loose their Indian allies upon the surrounding countryside and the weakened infantry of the U. S. retreated south. Fort Niagara remained in British hands until March of 1815. During the battle at Fort Niagara, Robert W. Jameson was killed.

When notice was received of his death his effects and what property he had was eventually administered by a court appointee. Empowered was John Farnsworth, his brother-in-law. Jameson owned 259 acres which was sold to David Farnsworth May 26, 1814. The administrator put up a \$1000.00 bond to secured the appointment in 1815 which he retained a right until 1826 when the last action upon Jameson's estate was handled.

Disposition of February 1, 1822:

*“That said Robert at the time of his death had never been married...that his brothers are George Jamieson, John Jamieson, Samuel Jamieson, and Henry Jamieson and his sisters are Anne Williams wife of John William, Jane Farnsworth, wife of John Farnsworth, and Nancy, widow of George Farnsworth. Whereupon it is ordered by the Court that the Despositions of the said John **Kirbough***⁽¹⁸⁾ and John **McKeehan** be recorded and that it be duly certified according to said Despositions that the said Brother and Sisters of the Robert Jamieson are his heirs at law according to the laws of the State of Tennessee of which the said Robert Jamieson was a Citizen at the time of his enlistment.”*

Robert and Evaline (Hulvey) Reed, settled in at the head of Panther Creek, six miles from Cabool, MO. He was a Baptist minister tending his farm during the week and preaching on Sundays. They were among the charter members of the Pleasant Hill Baptist Church in Cabool. When Daniel Reed, a neighbor of Bob and Evaline Reeds', was young he was shot and robbed in Old Town neat the Mountain Store. His gravestone, when he died in 1869, was the first in the Baptist plot. As a widow, Carolina Reed homesteaded 200 acres of land on Northfork, her son, William building the cabin. He married Mary Etta **Burton** and they had four

children: Vada, Viola, Eary, and Wilfred E. Vada married Charles **Shaw**, and they ran a successful hotel in Cabool. Viola married Fred **Stone**, and they owned a store in Mammoth Springs, AR. Eary died of appendicitis as a young girl. Wilfred married Bernice **Fould**, who was from Summersville and was a teacher at the Pleasant Hill School. In 1830 Jameson was living in Monroe co., TN. Mr. Jameson was one of two survivors of the Seminole massacre of December 28, 1835 in Florida. After military service he remained in McMinn co., TN. until 1836, at which point he removed to Washington co. MO., and finally to Webster co., MO. in 1837. Cam, as he was often called, got his education at home from his mother, when time permitted, and when the planting and harvesting seasons were done. As a young man Jameson, from late fall to early spring, traveled throughout the mountains from Georgia to North Carolina, Kentucky, and Tennessee, an enterprising man selling New England manufactured clocks. On one of his trips he came to a wealthy plantation in Barboursville, Ky., meeting a family by the name of Pope. Obviously infatuated with Thomas Pope's daughter, Kittie, he asked for her hand in marriage. Pope objected to the union and Benjamin and Christine took the matter into their own hands and eloped. They resided in Sweetwater, Monroe Co., TN. where they remained until her death in 1833. Here Cam committed himself with the livelihoods of working and raising a family. Her death providing too many memories he sold the land to Armistead **Beels** March 7, 1839 and to John **Mesime** two days earlier. Right after this, Cam removed to McMinn co., TN. where he met and married his second wife, Mary, a recent widow of a Dr. Huff, who practiced medicine. With her, she brought her only child, Jenette, and they settled down into a relatively comfortable existence. Mr. Jameson was an Assistant U. S. Marshall in McMinn county and in 1850 he was placed in charge of the 1850 census renumeration which he dispatched with the forthright committed ways that characterized him.

Mr. Jameson's will was dated August 21, 1860 in McMinnville and probate in January of 1861. A cash plan was laid out January 9, 1861 and on February 15, 1865 the settlement of the estate and the terms of the will finally complied.

Thomas Pope was a Revolutionary soldier with General Washington at Valley Forge, Pa. His will was dated December 3, 1833 and probated July of 1834. He names wife, Patsy Pope, sons-James, Lorenzo, Fielding, Thomas, Smith, and William Pope; and daughters-Jane **Tuggle**, Nancy **Woods**, Mahala **Pogue**, Elizabeth Pope, Catherine Jameson(deceased), and Polly **Johnson** (deceased). Executors were Judge Jones and Lorenzo and Smith Pope. Joshua Jones was Judge of the Circuit Court in Webster co., MO. He moved there in 1844.

Democratic and a Master Mason, Jameson also provided the lands upon which the first school, the Mission Home Church, and the old cemetery then sat. When he died he was buried at Timber Ridge in Webster county.
