NOTES

While considerable research has gone into this Jameson family history I am indeed indebted to a woman whose previous work shaped much of the newer generations. To Marianne Spencer Dinsmore, then, whose constant ambition to etched out the truth, whose zest for life, and whose wonderful support I came to rely on for many years, I dedicate the following genealogy and history of James Jameson. Though I have in the past attempted to contact her I have failed to locate her or to know what became of her.

37110-1 JAMES JAMESON, born circa 1665 in Scotland, Mr. Jameson emigrated in 1698 to Virginia. He died January 17, 1720, Middlesex co., Virginia. In 1714 he was residing in Essex county where he was Justice of the Peace.

37111-1 DAVID JAMESON, born circa 1660s, Scotland, Mr. Jameson died in 1711 in Essex county, Virginia. He married Mary (**Robinson?**), who was baptised February 5, 1708 in Virginia.

Notes:

He purchased in 1704, 250 acres in Essex co., Va. Mr. Jameson was no doubt an older brother of James Jameson(37110). He made his will out in 1711, mentioning wife, Mary. One record indicates that a David Jameson married a Mary Robinson, bpt. 2/5/1708 & died in 1771. This record also indicates that she was the daughter of Thomas and Edith (Tyler) Robinson, though this is certainly in error since the actual daughter of

Thomas and Edith Robinson actually married Thomas Jameson(37145) in 1767. Mary was actually bapt. on February 5, 1749. While one can not discount that the foregoing David Jameson did not marry a Mary Robinson, it is certain he did not marry the one born in 1749 in Yorktown.

37120-2 ELIZABETH JAMESON [James], was born circa 1685, Scotland, the daughter of James Jameson(37110). She died in Essex county, Virginia. Miss Jameson married circa 1700, Essex co., Va., Daniel **Gaines**, b.c. 1680, Rappahannoch co., VA, died Essex co., Va., the son of Bernard and Martha (**Taylor**) Gaines.

Notes:

Capt. George **Taylor**, husband of Martha **Tomlin** and father of Martha, was born in 1615 in England. He left London on 8/21/1635 aboard the ship "George Jo", settling at Isle of Wight Co., VA. in the following year. He removed in 1639 to Warwick Co. On June 3, 1659, he was commissioned a Lt. Col in the Virginia militia in which he proved capable and trustworthy. Residing in Rappahannah co., Va. he spent many active years there as a Justice of the Peace between 1680 to 1705. In 1685, receiving 7000£ in tobacco, he built a prison along the north side of the Rappahannah River. Not content, he moved on in 1706 to Richmond co., Va., where he was a Burgess for many years.

Daniel Gaines [*\(2\)](#) was married first to Mrs. Mary **Gaines Doyle**.

37121-2 JAMES JAMESON JR. [James], was born circa 1700 in Middlesex county, Virginia the son and the second child of James Jameson(37110). He died November 17, 1736, Essex co., VA. Mr. Jameson married circa 1718, Margaret (**White?**)(**Jennings?**)(3).

Notes:

Mr. Jameson was a merchant. He was active in community affairs and took a leading part in civic activities. He was elected Constable 12/17/1717 in St. Anne's Parish, Middlesex co., VA. Records from Probate court show he sued a Mary Quarels in 1717. Four years later, 1721, he brought suit against Jonathan Hawkins for trespass and assault. Early on he sold 50 acres to Thomas Shut, patented in 1692 in Essex co. He later purchased land in King and Queen Co., which was bequeath to his heir, James Jameson. This land was purchased from Richard **Coleman**. In 1727, Essex co., Va, he sold another piece of land, though his wife, Margaret, had to relinquish her "Right of Dower" in order to transact the deed.

Mr. James's will was dated 4/19/1736 and proved/probated November 17, 1736 and reads-

"In the name of God, Amen, I James Jameson being sick and weak but of sound and perfect memory do make constitute and ordain this my last will and Testament in manner following:

IMP. I give and bequeath to my son James the land I bought of Richard Coleman lying in King and Queen County.

*Item. I leave 10£ current money to my son David and one gold ring with a stone to Mrs. Eleanor **Roy** and will that all the remainder of my estate of what kind soever be Equally divided amongst my beloved sons, Thomas, James, and David Jameson. Appointing the Rev'd Robert **Rose**, Mr. Daniel **Gaines**, Mungo **Roy** and my said son James, executors of this my last Will and Testament."*

The estate was appraised November 17, 1736.

- John Jameson, #37133, "Upon petition of John Jameson it is ordained: that Ned **Anderson**, a free negroe boy, be bound to hire till he comes to age, and that he teach him to read and the trade of a tanner, and carry him to office to home, indenture for that purpose." [6]

Notes:

Mr. Jameson and family settled as early as 1747 in Orange co., Va. When his father died in 1736, he gave a bond of \$1000.00 and became his brother, David's, guardian. Active in civic and military affairs, he enlisted in the Virginia militia and in 1750 was mentioned as Captain Jameson residing near Panther Gap, Rockbridge co., Va. For a number of years he was a Justice of the Peace in Orange county. His estate was inventoried in Orange co., Va. in 1772.

37132-3 JAMES JAMESON III [James, James], was born 1720, Essex co., VA., the son and third child of James and Margaret Jameson(37120). He died December 6, 1766, Liberty Hall, Essex co., VA. Mr. Jameson married 1742, Mary **Gaines**, born 1702, Essex co., VA, died July 18, 1806, Liberty Hall, VA., the daughter of Daniel and Mrs. Mary (Gaines/Doyle) **Gaines**.

Notes:

Mr. Jameson was orphaned in 1737 shortly after his father's death. Rev. Robert **Rose** put the \$1000.00 security up and became James Jameson Jr.s guardian. After reaching majority age, Jameson took over the property he received for his inheritance in King and Queen county, VA*⁽⁵⁾. This land was probably either sold or passed on to his son, Thomas Jameson. Active in his community, Mr. Jameson took on William **Lenard** as an apprentice from October 17, 1758 to October 17, 1763. At the time Jameson was residing in Princess Anne county before finally removing to Liberty Hall, Essex co., Va. where he died.

The Gaines were from Kings Thorpe, Northamptonshire, England. Daniel Gaines, the ancestor of this clan, was born about 1625. He married Margaret **Bernard**, the daughter of Francis Bernard, wh died in 1630, also of Kings Thorpe, England. Mrs. Gaines was a sister of William Bernard and Sir Robert Bernard of Brampton Hall, Huntingdonshire, England. The children of Daniel and Margaret(Bernard) Gaines were:

Mr. Daniel Gaines was a Justice of the Peace in Rappahanoch co., VA. who emigrated in 1654 through the auspices of R. **Lawson**. On October 11, 1671, he was a member of the Committee of Amherst county, VA. His military service was with the King of England's Colonial Militia in 1680, then a Captain in the army. A deed issued in his name was made July of 1667 in Rappahannock co., VA. His will was dated August 18, 1682 and proved October 16, 1684. He mentions son, Bernard; daus. Mary, Margaret, and Elizabeth; orphans of Col. John Catlett Jr., deceased; son-in-laws John **Smith** and Ralph Rowzee. His wife, Margaret Gaines, he made Executrix of his will.

Bernard Gaines was born circa 1650, England. He married Martha Taylor and had the following children:

Mr. D. Gaines was a vestryman of Frederickville and Trinity Parishes in Louisa co., Va. and Albemarle co., Va. in 1762, and again when the counties were divided. His will was made 8/19/1757 in Essex co., VA. where he died.

37133-3 DAVID JAMESON [James, James], was born circa 1721/22, Essex co., VA., the son and fourth child of James and Margaret Jameson(37120). He died 1793, Yorktown, York co., VA. Mr. Jameson married Mildred **Smith**, born 1733, Yorktown, Va., died December 10, 1778, York co., VA., the daughter of Edmond and Agnes (**Sclater**) Smith.

Notes:

Mr. Jameson graduated from Princeton College, NJ. He was a merchant in Yorktown, VA for many years dealing also in real estate, the shipment of tobacco, conducting lotteries, managing salt works, buying and selling slaves, and operating a warehouse on the waterfront. He was Lt. Governor of Virginia from 1780-81 under the Governorship of George Thomas **Nelson** and served in August of 1780, briefly as Governor when

Nelson took ill. He was elected as a State Senator in 1783. He also served in the Senate during the War in 1776-77, serving on Patrick Henry's Privy Council in that latter year. He was Treasurer in 1773-74 of the Societies for the Promotion of Useful Knowledge, which he co-founded at Williamsburg in 1773 with John **Clayton**, the botanist, and John **Page** of Rosewell. He was also the inventor of the first rain gauge in the new colonies. On November 10, 1775 he sold land to Charles **Mennis**; sold September 1, 1792 various slaves to Dorothea Graham Jameson and Thomas Jameson of Yorktown. Jameson was on the commission to locate a suitable place for the District of Columbia. Lawrence **Smith**, his brother-in-law, was apprenticed to him from 1/15/1753 to 1/15/1760 as a book keeper. He was a son of Enoch Smith. Jameson's will was dated October 14, 1792, and on May 21, 1793, he issued a codicil. The will was proved July 22, 1793, and having no children of his own, he bequeaths to nephews, John of André fame and David Jameson, his personal and real property. The will was witnessed by William **Reynolds**, William **Carey**, and Mary **Mennis**.

Mrs. Jameson was related to the Reades, Washingtons, and Martins of Yorktown. She died in Yorktown, a society matron and community spirited member of the highest order, at Temple Farm, at the site where General George Washington met with General **Cornwallis** where they signed the Articles of Surrender. This property is located 1½ miles south of Yorktown. It was here, too, the battle for Yorktown was engaged between the two giants on October 19, 1781. Originally owned by Rev. Peter **Temple**, who sold it to Enoch **Smith** and family. They resided in Yorktown at the home of her father's on Lot 53 until their deaths at which time the home was sold to Major Thomas **Griffin**. He died in 1836 and the family home went through a succession of buyers until 1915 when George P. **Blow** of Lasalle, Il., bought the property and in an enterprising move joined it with the properties of Thomas Nelson Jr. and Capt. John **Ballard**'s house, giving it the communal name of the York Hall Estate.

Mr. Jameson was a Lieutenant during the American Revolution. He was among the men who "...marched to demand satisfaction of Lord **Dunmore** May 2, 1775."

Will of John Hackley II, March 6, 1799, Probated 1801

"My will is that my Just debts has been paid with any money I have in hand and money owing to me, and if that is not sufficient the deficiency to be made up by the sale of my Riding sorrel horse. My Grey horse and "my" Gray mare and if all these are insufficient to pay my Debts then the balance to be paid from the sale of my Land in the western county.

*Item, I give and bequeath unto my Aunt, Margaret **Barrow**, one hundred Dollars to be paid to her by my Executor out of money arising from the sale of my Western Lands.*

*Item, to my friend, General James **Williams**, the Tract of land whereon my Uncle, William **Ball**, now lives slaves, horses, &c.*

Residue of my estate to be disposed of as follows:

part to my Brother-in-Law, Thomas Jameson, for the Heirs forever.

*part to my Brother-in-Law Samuel **Read**.*

in trust to my Brother-in-Law Thomas Jameson for the benefit of my Sister Lucy Jameson and her children.

*to the children that may be living at my death of my Sister Ann **Talliaferro**, Dec'd.*

part to my nephew John Jameson, son of James and Lucy Jameson.

*part to my nephew John **Read**, son of Samuel Reed and Sarah Reed. The remaining 2/8ths to be put in hands of nephews John Jameson and John Reed in trust for the use and benefit of my sister Elizabeth **Hackley**, wife of Richard **Hackley***⁽⁷⁾ and her children.*

March 16, 1799 John Hackley

Memo, March 1799.

My Uncle and Aunt Barrow to keep the negroes they now have and then that they be set free.

Let Uncle Ball keep possession during his life.

*Then Land given to my brother James **Hackley**.*

*Rest of property to be sold and 1£ money given to Fanny (**Ball**) **Long**, daughter of Major Gabriel **Long** and ½ to Fanny Ball **Thomas**, daughter of Edward Ball **Thomas** of Kentucky.”*

Mr. Hackley was the son of John Hackley Sr. and Judith **Ball**. They had the children: John Hackley Jr., Elizabeth, who m. her first cousin, Richard **Hackley**, and James Hackley. Mr. Hackley Sr. died 1760 in King George County, VA. Mrs. Hackley was the daughter of Capt. Samuel **Ball** (b. 1686, d. 1751) and Anne Catherine **Taylor**, daughter of Col. William Tayloe. Col. Tayloe was from Mt. Airy, VA. He died 1711 in Richmond co., VA. and married Ann Corbin, born 2/9/1664, and died sometime between 1697 to 1710. Miss Corbin was the dau. of Henry Corbin the III, born 1629 and d. 1/8/1675. Henry Corbin emigr. to Va. in 1654, residing in King & Queen co., VA. He was a member of the Council 1663. He married Alice **Ettonhead**, a dau. of Richard. Ann Catherine Tayloe m. 11/25/1717, Capt. Samuel **Ball**, born 1686 and died 1751 St. March's Parish, son of William Ball II, and grandson of Col. William Ball SR. who came to VA. in 1657 with wife Hannah **Atherold**.

Notes:

Thomas Jameson was appointed March 23, 1769 upon presentation of a \$1000.00 security bond, guardian of his brother, William Jameson, until the time his younger sibling reaches majority age. He was granted July 28, 1768 Letters of Administration, on his father's estate which he evaluated September 24, 1772. Jameson was commissioned an Ensign during the American Revolutionary War on February 25, 1773, and took part in several major battles. Mr. Jameson was a contemporary of George Rogers **Clark**, (1752-1818), who explored the vast region known as the Northwest Territories. Jameson might have been a member of this company which journeyed through the present states of Ohio, Indiana, Michigan, Illinois, and Wisconsin as recorded in other Jameson publications. However, no documents record this fact. What comes through, though, in chronicles relating to this event is that Jameson was in a position to supply local military groups, and I believe that Thomas, besides knowing the venerable Clark, also elected to help support the expedition by supplying it—at least from the beginning over and beyond what the military department was willing to provide. At the age of 25, Clark joined up in defense of his new nation. Beyond the Alleghenies, the British were stirring up the Indians, and Clark proposed driving the enemy from their forts. In the summer of 1778 with 175 men he captured three important posts: Kaskaskia and Cahokia on the Mississippi near St. Louis, and Vincennes on the Wabash. In 1779, with 130 men he retook Vincennes which the English had recaptured during the previous winter. With this important engagement the Treaty of Paris in 1783 surrendered this region to the United States.

Thomas Jameson took the Oath of Allegiance and became a loyal, respected citizen of Virginia. On May 9, 1780, he inherited 3500 acres of fertile Kentucky land from his Uncle, David Jameson. He purchased in 1782 an additional 2500 acres and in 1782 migrated to Montgomery co., KY settling in Mt. Sterling. His home, built in 1802, stood at the site of Estill's Defeat*⁽⁸⁾ where tradition states that Thomas's brother, James' son, John Jameson died in that tragic action. However, this was not so ⁽⁹⁾. On March 20, 1787, Jameson received 7 slaves from James **Robb**, administrator of the Estate of Francis **Moore** Jr., deceased.

Thomas Jameson's will was dated June 27, 1827, and probated in the following year.

"In the name of God Amen.

I, Thomas Jameson of the County of Montgomery, State of Kentucky, being very old and infirm in body, but of sound and disposing mind and calling to mind the extreme uncertainty of all transitory things and that it is appointed for all men once to die, do ordain and establishing the following as my last Will and Testament. The little Real and personal property which it has pleased God to bless me with I divide amongst my children in the following manner.

I resign my soul to God who gave it and my body to the dust to be buried in a Decent and Christian like manner at the direction of my executors hereafter named.

1st. It is my will that my funeral expenses and my just debts be first paid.

*2nd. I will and bequeath to my oldest daughter, Lucy Jeter, married with John R. **Porter**, one dollar, she having already received what I intended to give her.*

3rd. I will and bequeath unto the heirs of my oldest son, Thomas, deceased, one dollar.

*4th. I will and bequeath to my daughter Mildred, intermarried with Daniel **Mosely**, one dollar, having already given her what I intended.*

*5th. I will and bequeath unto my daughter, Judith Ball, intermarried with Elijah **Bledsoe**, two horses, one worth fifty dollars and the other worth sixty, which I give to her and her children only, but her husband is forbid any control over said horses which said property is to be furnished from my estate as hereafter directed.*

6th. I will and bequeath unto my son James Jameson my negro man Adam and three hundred dollars in money to be paid to him as hereafter directed.

7th. I will and bequeath unto the heirs of my son Hackley, deceased thirty dollars which they owe me and my executors are directed not to claim the amount.

*8th. I will and bequeath unto my daughter, Elizabeth, intermarried with Lloyd **Thompson** my negro woman Becky and her children which is considered more than an equal divide but being unwilling to separate mother and children. It is my will that said daughter, Elizabeth, and her husband pay the two horses to my daughter Judith Ball as above directed and one hundred dollars in money to my youngest son, Sanford Jameson to make up his deficiency in the divide of my negroes.*

*9th. I will and bequeath to my daughter Margaret, intermarried with David **Stewart** the farm on which they now live bounded on the north by Hinston Creek and on the south by A. G. **Harrison** and wife and on the west by Joseph **Long**, including all the land which is known in my family as "Peggy's Farm", but the said farm being deficient in quantity to be equal to what I gave my other children, I give and bequeath to my said daughter Peggy my negro woman Maria and her two children Jackson and Washington as an equivalent. This my will is to be distinctly understood in this way not knowing the deficiency of land in Peggy's Farm I gave her and Maria and her children in lieu thereof so as to make her farm equal to one hundred and fifty acres but if it shall hereafterwards appear that the deficiency in land is less than I suppose it to be and any complaint should arise amongst my heirs it is my will that the deficiency by Respectable and Disinterested neighbors and if value of the negroes should be greater than the deficiency of land in that case said Peggy and husband shall pay back in my estate the surplus and it is further my will and I hereby bequeath to my said daughter Peggy my negro man Charles as her share in the general divide.*

10th. I will and bequeath unto my youngest son Sanford Jameson all my horses, farm with its appurtenances being the same whereon I now live which is the residue of my land not already disposed of and also my negro man Morton and one hundred dollars which my daughter Elizabeth and her husband are bound to pay as having a larger divide in my negroes than my other heirs and I give my son Sanford Jameson my desk and Book case and my large dining table and two of my best feather beds.

*11th. It is further my will that no legacies as above bequeathed shall be paid out of my estate until after the expiration of a lease which I have given to my sons James, Sanford, and David **Stewart** in which lease I find I have conveyed to them my personal property entire except my negroes which leaves me destitute of funds to*

*meet some contingences and Bequeaths which I have already made and others which I intended to make and further it is my sincere desire and request that my sons James, Sanford, and David **Stewart** who will own all my personal estate, at the expiration of said lease negroes excepted, that they and each do agree and voluntarily let my son John Jameson in Mo(Missouri) for a full share in the division for him in my will. Having no disposable funds wherewith to do so.*

*It is my further will that Sanford Jameson, my son, and David **Stewart**, my son-in-law, be and at the same is hereby appointed Executors of this my last will and Testament.*

In testimony whereof I have hereunto affixed my hand and seal this twenty-seventh day of Hune in the year of our Lord One thousand eight hundred and twenty-seven.

Thomas Jameson (seal)”

- James Jameson apparently was unmarried. He appears to have lived his life primarily in Montgomery co., KY. When he died his will, dated September 29, 1842, and probated November of '42, in Montgomery county, mentions no children or spouse. He names Margaret **Thompson**, dau. of Lloyd and Elizabeth (Jameson) Thompson, and Malinda **Moxley**, wife of Josiah Moxley, as heirs. From his father's will he received a negroe man names Adam plus \$300.00.

The key to America's survival lay, in 1780, in the hands of 29 year old Lt. Colonel John Jameson of the American Army under the command of General George **Washington**. Born in 1751 in Culpeper co., VA., Jameson, a son of the prominent Gentleman and former Captain of the Virginia Militia, went to William and Mary College graduating sometime prior to 1774. In that particular year he signed a resolution to defend his rights against the encroaching British authority. In Fairfax, Virginia under an old Oak tree during the spring of 1775, he volunteered with other men from Culpeper, Orange, and Farquair counties forming the Culpeper Minutemen. Their flag known by nearly all history students portrait the snake and phrase "Liberty or Death" on one side and the phrase the phrase "Don't Tread on Me" on the other side. Organized at the request of Virginia Governor Patrick **Henry**, it was led by Major John **Marshall** Sr., father of third U. S. Supreme Court Justice John Marshall Jr. Their first engagement came when Lord **Dunmore**, then Governor of Virginia for his Majesty's Crown, seized the gunpowder at Williamsburg, the seat of English government in Virginia. In their forest-green buckskins, buckstail caps, scalping knives, and tomahawks, the Minutemen marched off to Williamsburg. Fortunately, a battle was prevented when negotiations between the two parties were satisfactorily concluded. Later on in December of '75 the Minutemen found themselves among 900 Virginian and Carolina troops who defeated Lord Dunmore at Great Ridge, Virginia. Burning Norfolk on New Year's Day in 1776, a bloody fight ensued and Dunmore with his troops following fled to Chesapeake Bay. From here he was reassigned to the West Indies.

On June 13, 1776, John Jameson was commissioned a Captain of the Third Troop of Horse. Three days later he took command of a regiment of Dragoons-an applied term meaning generally cavalry. In the early spring of 1777 he was promoted to Major and served with the First Continental Dragoons. His first engagement appears to have occurred on September 11, 1777 at the Battle of Brandywine. Washington's orderly retreat from this situation subsequently created the hard winter at Valley Forge in Pennsylvania when Generals **Howe** and **Ferguson** destroyed the supplies placed there. Twenty some miles west of and a littlenorth of

Philadelphia where the Schuylkill River meets the Valley Creek the land rises up 250 feet cresting then flattening out into a plateau for two miles. An old forge marked its location. Here Washington and his men rested for the duration of that hard winter.

It was also here that several things coalesced that marked turning points in military careers for a number of men and in the military situations that followed. General Nathaniel **Greene**, 1742-1786, succeeded Thomas **Mifflin**, 1744-1800, as Quartermaster General of the Army and quickly managed to scour the countryside in search of food and much needed supplies. General Frederick William **Steuben**, Baron Von Steuben, 1730-94, had come to Washington highly recommended by Benjamin **Franklin**. During the height of the rigid winter, Von Steuben formed the first American drill and taught the raggedly-dressed men the techniques of military bearing and maneuver. Martha **Washington** rode in one day, set up a small salon, and belong long a social gathering of military and national giants walked in-Anthony **Wayne**, Baron **DeKalb**, Alexander **Hamilton**, John **Sullivan**, and Casimir **Pulaski**. To offset the genial relationships that were forming, Washington brought General Benedict **Arnold** into camp with Aide Charles **Lee**,*⁽¹⁰⁾ 1731-82, who upon arrival, made it clearly known that he thought Washington was unfit for command and that the American Army could never defeat the British. His gloomy attitudes aside, Arnold's introductions brought a state of nervous peace to the cordial atmosphere. Many of these pivotal soldiers would later come together under far stormier circumstances.

While staying with Washington at Valley Forge, Major Jameson was wounded in a skirmish nearby on January 21, 1778. Throughout that year and the next he remained at Washington's side, engaged at the Battle of Monmouth, NJ in June, and promoted to Colonel in August of '79. While the battle had no clear winner, it represented the last major fighting in the northern colonies. With West Point guarding the way into North America, Washington assigned many of his men to defense holding positions which they commanded. Arnold was sent to West Point in 1780; Jameson to Tarrytown, NY under Arnold's command and made commander at a garrison currently under construction at North Castle. Greene was still Quartermaster General of the Army, remained at this post until 1780. Wayne, ordered by Washington to Stony Point, NY., fought the British held defenses there on July 15, 1779, remaining in the north through 1780.

While Howe continued to send smaller advances down the Hudson from Canada, the Battle of Monmouth in 1778 had ended any major consideration of taking the north away from Washington. West Point had become the General's major defensive stronghold for the north and the war went south into Virginia and the Carolinas. Other means of wresting control from the colonists were vigorously pursued by Sir Henry **Clinton**(see aside) who took over Commander-in-Chief of British forces in 1778. The one door Clinton opened could have had dire consequences for the fledgling Continental Army had it not been for some quick thinking militiamen and one very undecided Lt. Colonel.

Shortly after the Second Battle of Freeman's Farm, Major General Arnold in June of 1778 was placed in command of Philadelphia. Born in 1741, in Norwich, CT., he ran away from home and fought bravely during the French and Indian War. He was made Captain for the Connecticut Militia upon its completion. When the Revolution commenced Arnold was already an experienced soldier, having been with Ethan **Allen** at Fort Ticonderoga, and as the planner of the failed attempt at Quebec. Proving himself capable and able however, the fiery, oftentimes quick-tempered soldier was soon commissioned a Brigadier General in 1776. In the following year he helped bring about British General John **Burgoyne**'s, 1722-92, surrender at Saratoga, NY. Benedict Arnold was married twice, was a lavish host, and tended to be in debt much of the time. Over the course of time he befriended a number of British Tories who managed to hang around after Clinton's defeat at Monmouth. He managed to avoid attempts by Congress to maintain a financial journal of his military expenses, none of which came into question. In '79, however, he was charged with using his position for personal profit. The Court Marshall cleared him of the most glaring indictments and Washington gave him a personal reprimand. New discoveries later engulfed him in military controversies surrounding his expenditures.

In anger he began corresponding in secret with Sir Henry Clinton through Major John André exploring possible alternatives that would relieve him of his debt and possibly provide him with a better way of life. Their conversations didn't work to Arnold's benefit. He became more sullen, angry, and lastly, withdrew his offers to Clinton. André, who didn't know who his unnamed American source was, baited the hook with a little gold. Arnold snapped at the line, and while the British agent learned at long last who the American was, the door had closed once again on General Arnold.

August of 1780 came and Washington appointed Arnold to take command of the U. S. Military Academy at West Point. His command was no surprise, for the flamboyant General had finagled his way into the position with the plan to turn over the military stronghold into British hands! The dickering and haggling of Arnold's negotiated *settlement* nearly collapsed the proceedings. Insistently, the American managed, not necessarily a small fortune, but at least a comfortable living if he did turn over the plans to the English enemy. The terms finally decided, Arnold summoned John André.

Morale was at a low ebb in the northern colonies. A lack of food and supplies hindered the army in maintaining their defenses of the region. At one point a mutiny had broken out during the hard winter of 79-80 in Morristown, NJ where conditions were conceivably worst than at Valley Forge the year before. A blow to America's defense like the loss of West Point would have major repercussions throughout the new nation. It was one reason why Washington had ordered the previous U. S. Military Academy Commander General **MacDougall** to run a heavy gauge chain from the Academy to Constitution Island some 1500 feet to secure the River from possible British invasion from either direction.

Meanwhile, Major Benjamin **Tallmadge**, Washington's Chief of Intelligence, was on patrol in the Westchester-Fairfield county, keeping a tight reign on the territory above New York City as his Commander-in-Chief traveled by on his way to Hartford, CT. for a conference. Concerned with General Arnold's constant and demanding reports on the movements of his agents in the area, Tallmadge was struck by Arnold's repeated message concerning a John **Anderson**. If Tallmadge meets up with the man to immediately send him directly to West Point. This struck the Major as rather peculiar since Anderson was coming from British Manhattan, and any person from that area would naturally come under suspicion. Sending an unknown stanger to Arnold carried even deeper misgivings, and Tallmadge's mistrust of the Commander at the Academy deepened the situation considerably. To the Major's astonishment, then, when he returned to his lodgings was a report and the person of Lt. Col. John Jameson waiting for him with the news that he had in custody a man calling himself John Anderson. The report incorporated the following activities in relation to the capture and subsequent findings of this British citizen.

Samuel **Wood**, born in Westminster, Mass. and under the command of Brig. Gen'l Arnold, was on the 22nd of September of 1780 on a reconnaissance with twelve other men led by their sergeant. Coming across a party of three *cowboys* ^{*(11)}—John **Paulding**, David **Williams**, and Isaac **VanWort**—the soldiers had discovered that the men had arrested a loyalist calling himself John Anderson who claimed to be a British officer. In their excitement they related they had quickly searched the prisoner only to make a remarkable discovery in the process. Hidden inside Anderson's boot, stuck inside his sock, were a number of official looking papers. Producing them, the cowboys handed them over to the sergeant who, upon realizing what the papers contained, ordered his men to tie Anderson's stirrup straps to his wrist. Wood was given the other end of the strap with the charge of being the prisoner's personal bodyguard. Addressing his men, the sergeant ordered the troops into a state of alert, giving the order to kill if Anderson should attempt to escape. The squad returned the British officer to Jameson at North Castle, NY. where the Lt. Colonel locked the captured officer up and placed Reuben **Shumway** of Steuben co., NY to oversee Anderson's guard.

On the next day John Jameson sent Anderson under heavy guard to West Point. Tallmadge, having heard of Anderson's capture rushed to North Castle only to find that the Dragoon Colonel had inadvertently and unintentionally sent the British officer into the hands of Benedict Arnold. In going over the papers found

upon him, Tallmadge was appalled to learn that Anderson had a signed pass direct from Arnold and that the official papers actually contained detailed information on the strengths, weaknesses, and designs of the military stronghold all of which was in the General Arnold's handwriting. Taking direct action Benjamin Tallmadge had Jameson send someone out to return the troops and the prisoner back to North Castle before they got to West Point. Under the intelligence officer's questioning it was finally learned that John Anderson was actually John André, a British spy for Sir Henry Clinton. With this knowledge John Jameson sent an immediate dispatch to General Washington which included the plans of West Point.

In the meantime, Arnold was having breakfast on that fateful morning when Jameson's messenger arrived and informed the Commander of the events concerning Anderson. Masking his shock, the General excused himself from his family and immediately took leave by rowing down the Hudson. Reaching the mouth of the River he went on board the British H.M.S Vulture and made his escape.

Galloping swiftly from Hartford, George Washington reached West Point and at once ordered the garrison increased and the fort strengthened and on alert. Convening a military court, André was convicted as an enemy agent of the Crown, and sentenced to be hung. Ten days after his capture he was sent to the gallows. His head held high he went to his death in a manner described and remembered for its bravery and courage. As André hung from the rope about his neck, Arnold cashed in on his infamy, commissioned a British Brigadier General, and sent to Connecticut where he commanded a small force there and in Virginia. In 1801, Arnold died, an unhappy man distrusted by both continents.

John Jameson remained in the military a few more years, stationed in Tarrytown where he met his first wife. Married, and now out of the service, they settled down in Culpeper county, Virginia. He joined the Alexandria masons and was a founding member of the Society of Cincinnati, an organization which purpose was to provide for the needs of the widows and orphans whose husbands died in the late war. His plantation began at present day Main Street in Mt. Sterling running west to Mountain Run

Mr. Jameson graduated from the William and Mary College, Va. He was described as being 6' tall, blue-eyed and fair-complexion with black hair. He was Clerk of Court in 1772, a position which he held for the next 38 years. He was listed as a Clerk of the Culpeper Freeholders, signing a resolution in 1774 to defend their rights against Great Britain. After the war he was awarded over 416 acres of land some of which was located in Greene co., Ohio. The first tract there was entered into the Virginia Military District on August 1787, survey #387, by Nathaniel Massie November 20, 1784, and recorded May 31, 1795. At his death, Jameson owned several thousands acres of land throughout Virginia, Ohio, and Kentucky.

Mr. Jameson was a Colonel in the Virginia Militia, a Dragoon Commander like his brother, Col. John Jameson during the American Revolutionary War. He was at the Battle of Great Bridge, December 9/1775 and under the command of Adam **Stephens** from 1780 to 1781. He was commissioned a Major in 1777, and toward the end of 1778, commissioned a Colonel. After the war he led an active civic life. He was a lay delegate to the convention in Richmond, Va. in 1791. He was a vestryman, a Magistrate, and High Sheriff of Culpeper county. A member of the Fairfax Lodge #43 Masons, 1820-36, and one of the first trustees and co-founder of the first academy in Stevensburg, established in 1791. Known mostly as Colonel Jameson after the War he owned considerable land in and around Culpeper City having received parts of his Uncle David Jameson's estate nearby. Mr. Jameson is buried at the Jameson Cemetery located about 2 miles north of Culpeper on old route 49, west side of the road. His wife's gravestone reads:

To the Memory of

The Second Day of July 1802 In the 30th year of her Life

Notes:

Mr. Jameson's father died leaving William Jameson an orphan. He chose his brother, Thomas Jameson, March 23, 1769 as guardian and whose home he remained until he was of majority age. Mr. Jameson was a sergeant during the Revolutionary War under the command of Capt. Patrick **Gray** having been stationed along with his older brother, John, at North Castle, NY where he was witnessed to one of America's most tragic events. He was called as a witness in the trial of a Mr. **Smith**, regarding the treasonable acts of Brig. General Benedict Arnold(see Col. John Jameson #37139). Mr. Jameson came back to Culpeper co., Va. and like his brothers, Thomas and John Jameson, migrated to Fayette co., Kentucky sometime around 1787. On August 29, 1800, William Jameson was listed as a resident and taxed in Jessamine county. George Jameson, a contemporary of Jameson's was taxed Aug. 25, 1800, and there in 1810, possibly a few years younger than William and probably his cousin, # 37188.

Mr. Jameson's will was dated January 16, 1814. He mentions wife, Anne, and children-David, John D., Kitty, Jinny, Archibald, Burd, and William Jameson. Mrs. Anne Jameson's estate was settled November 19, 1818, Jessamine co., KY.

The De Boogh Family began in America with Frederick De Boogh, born 9/19/1686, a son of Solomon and Anna **Brat** De Boogh of Amsterdan, Holland. Frederick died 12/19/1757, Freehold, Monmouth co., NJ. He married 6/8/1712 Johanna **Van Hook**, born 6/11/1693 NY City, NY, the daughter of Lawrence and Johanna Hendricks **Smith**. Mr. Jameson was in the contracting and building trades in Mt. Sterling, KY. One of his projects was spent dredging the Ohio River for two years. He worked eventually with his father-in-law, John Bruce in running the Kinnicanick Salt Works of Lewis Co., Ky. Unfortunately, the business failed, and being the proud man he was, Jameson packed up his belongings and family. Boarding an emigrant boat, he finally settled in Clarksville, Pike co., MO., in 1831. Here, he became established once again, elected to Justice of the Peace for four years and later Lincoln county assessor for ten years. Old school Baptist, Mr. Jameson and family converted to Campbellism ^{*(12)} and assisted in establishing the first Christian Church under the Disciples of Christ in 1832 in Missouri. He was a Democrat and staunch supporter of President Andrew Jackson. In 1846, Mr. Jameson returned to Kentucky in a court suit, and while there caught a cold and died. William Jameson was a soldier in the War of 1812 and was engaged at the Battle of Lake Erie.

Mrs. Jameson was born in Sumner co., KS. near Caldwell. She was the eldest of two children. Her parents learned that the Oklahoma Territory was opened for settlement and so they homesteaded in an area known as "ten-mile flat." "There were five or six miles of nothing but timber and mountain lions, deer, turkeys, prairie chickens, quail, ducks, and geese."⁽¹⁸⁾ They lived in a rough built dugout harrassed at time by the Indians who were just beginning to realized that the white man was here to stay. Camped inthe timber near the South Canadian River, Minnie would fish and Douglass would hunt for deer and geese. many of their furnishings and clothing were made from the hides of these animals. The Oklahoma Land Race began April 22, 1889 and Mr. McPeek was fortunate to stake a claim during that period of time. They lived in a tent until he was able to provide a one room log cabin which he later transformed into a one room house with a floor. Mr. McPeek's mother was Jane (**Skidgel**) McPeek, who married a Mr. **Morris**. Mrs. Jameson lived with her grandparents for some time at Moore, OK., where she met Irving S. Jameson.
