### ANDREW JAMISON OF ROCKINGHAM COUNTY, VA.

#### [38100-38299]

With the exception of the early history of Andrew Jamison and his immediate family, most of the material from James Jameson(38112) on was entirely researched by Mrs. Jean Jamieson in her 1978 publication, "JAMIESON AND O'CALLAGHAN ANCESTRY". She writes in her forward, "Our research on the Jamieson ancestry is admittedly incomplete and needs to be pursued further...Our principal source consisted of charts and documents furnished by Mary (O'Callaghan) Jamieson (1886- ), widow of James Yancey Jamieson (1869-1924)." The following information is an extract from Mrs. Jamieson's book and excludes much of the fine history and genealogy she has developed on the Hobson, Pate, Jordan, Gold, Tillotson, Yancey, and O'Callaghan families. The intention here is to concentrate solely on the Jamiesons and to research the earlier history of this branch in Virginia.

**38100-1 ANDREW JAMISON{JAMIESON}** was born some time around 1765 and probably in Virginia. He married 1789, Rockingham co., Va., Elizabeth **Davis**.

## Notes:

It is difficult to ascertain without any actual proof relationships that existed in Augusta co., VA., especially in light of the destruction of public and religious records caused by the Civil War. While other materials have documented various facets of public vital statistics obviously gaps exist and make the researcher vulnerable to incorrect guesses. This is so in the case of Andrew Jamieson and his clan. Making this tougher is the abundance of Jamesons throughout this area and the close proximity in which they lived among each other. However, less we forget, some circumstances can and have adequately placed relationships in forms of loose family ties and as one thread is wrapped about another a strong life line provides coverage we may not have had in the first extreme.

So must we arrange the earlier genealogy of Andrew Jamieson and his brood in respect to those Jamesons discovered in the large territory known as Augusta county. Of particular note is William and Sarah Jameson who arrived and settled as early as 1745 besides the Big Calfpasture River along the present Bath, Rockbridge, and Augusta county boundaries. William and Sarah settled actually in the northwest corner of Rockbridge county and from here the Jamesons spread to the four points of the compass. Four of their known children were listed in William Jameson's will: John, George, Andrew, and William. If there were daughters or other sons no such source has materialize to produce them. The will provides for John a 237 acre tract along Jackson River in present day Bath county. Sons George and Andrew each received 400 acres, while William Jr. inherits the main plantation, and William Sr.'s wife, Sarah, to manage the whole affair. John removes to Bath county and by 1765 he and his family leaves the area. George Jameson purchases land east of the plantation on Moffett's Creek. He is employed like his brother, Andrew, as an attorney, and leaves Va. altogether to settle in Harrison county, Kentucky. Andrew settles in Staunton, Augusta co., VA. as an attorney and is there as late as 1818. He marries and has at least two children: James and Jacob Jameson. Little information pervades this period of time for Andrew Jameson. He is active as an attorney and is called upon to resolve several litigations. And it appears his life revolved around the affairs of Staunton and the people within Augusta county.

Just to the north of Staunton in present day Rockingham county, VA. is the town of Jamison. Here, nestled within the valley of the Shenandoah, David, John, Samuel, Robert, Arthur, Thomas, and William Jameson all brothers and all from Pennsylvania settled as early as 1775 along the northern Augusta county border. William, Samuel, and David Jameson can be found in the Augusta county records, while it appears that John Jameson removed to Greenbrier county, WV. After him came his brothers, William, Samuel, and David, all four leaving the area and settling in Bourbon county, Ky. in 1790. Robert, Arthur, and Thomas moved further south into North Carolina. This accounts for most of the Jamisons recorded in Rockingham county, Va. except, James, Andrew, and Jacob Jamison. A record appears showing that James Jameson marries Martha Crow on August 18, 1777 in Rockingham county. Another shows an Andrew Jammison in Capt. Richard Ragan's Company #13 for Rockingham co., a part of the militia under Capt. George Crissman's company #12 in 1788. In the following year Andrew Jammison is taxed on 10 acres of land. Another source indicates that Andrew Jamison had a son, Jacob, and Jacob, who was taxed in 1777 for six horses had a son, Andrew.

The hypothesis is to speculate that Andrew Jameson, born about the mid 1730s, of Staunton resided for a period of time in the vicinity of Jamison, Rockingham co., VA. With a lack of records from 1759 to 1818 showing no activity for him in Augusta county, it is conceivable that the man removed to Rockingham county. Here his sons, Jacob, Andrew, and James, were married and had children. James m. Martha Crow in 1777; Jacob was in the 1777 militia and had a son, Andrew; Andrew, probably one of the younger children married according to the IGI Index of the Mormon Church of Latter Day Saints Elizabeth Davis in 1789 in Rockingham county. Could he have been the same one in the 1810 census for Augusta county with seven males and three females in Waynesboro? To provide some idea how this sketches out please see diagram below.

It should be noted, too, that Rev. James Jamieson converted from Presbyterian to Methodist Episcopal Church. More than likely this stirred up plenty of trouble and as mentioned by Mrs. Jean Jamieson in at least one occasion he seriously disagreed with his father on one religious issue-infant damnation. She further gives testimony to the state of affairs when she quotes from a book about the Scots-Irish in Virginia in which an unnamed Presbyterian says, “Two curses came to Rockbridge - the blue thistle and the Methodists.”\*(1)

**38110-2 JAMES JAMIESON** [Andrew], was born April 4, 1802, Waynesboro, Augusta co., VA., the son and only known child of Andrew and Elizabeth (Davis) Jamieson(38100). He died June 25, 1880 at his farm at Buffalo Junction, Mecklenburg co., VA. Mr. Jamieson married first, March 24, 1840, Roxboro, North Carolina, Susan W. **Jordan**, b.c. 1805, the daughter of William and Susan (**Pate**) Jordan. She died May 28, 1845, Halifax county, Va. He married second, December 10, 1849, Martha Emily **Lindsey**, b. 1817 North Carolina, died January 18, 1856, Danville, VA., the daughter of Andrew Lindsey of Guilford county, NC. Mr. Jamieson married third, October 28, 1859, Halifax co., VA., Mary Lee **Pittard**, widow, who died July 6, 1865.
