# JOHN JAMISON OF VIRGINIA



**42811-2 KENDRICK** (**KINDRED**) **JAMESON** [John], was born July 19, 1807, Barren co., KY., the son of John and Mary (Burke) Jameson (42800). He died 1899, Barren co., KY. Mr. Jameson married first, July 7, 1829, Barren co., {Green co.,}[5]KY., Louisa F. **Burke**, born December 1804, VA., died January 13, 1845, Hart co., KY the daughter of Silas and Elizabeth (**Knox**) Burke{Burks}. He later married July 7, 1850, Hart co., KY., Ellen A. **Mudd**, born Marion, Crittenden co., KY., the daughter of William and Artemisa Mudd.

#### Notes:

Mr. Jameson was a judge in Hart co., KY, born in the southeast part of Barren county, Ky. He was the second of eight sons and five daughters. Mr. Jameson left home at the age of 18 and worked for Michael **Hall** until the age of 21. He married Miss Burkes in 1829, born in Va., and raised in Greensburg, Green co., KY. William Mudd married secondly, Miss **Withrowe**, and removed to Cedar co., MO. for three years. Losing his

wife, he returned to Kentucky about 1850. Mr. Jameson settled Blue Spring Grove, Hart co., KY. where he purchased a small farm. In 1844, he removed to Munfordville, KY and was engaged in the hotel business. With the death of his first wife, he taught school the following year and began his study of the law. He was sheriff for two years. In 1849 he resided at Bonneville on a 65 acre ranch which he built up to a 600 acre spread at Bacon Creek. When the Civil War ended he lost nine slaves and all his stock. Tenaciously, he hung on, rebuilt his fortune and was elected Justice for the for several terms before becoming a Judge in 1854. He held this position for eight years. In 1844 he was appointed a delagate to the Democratic Natinal Convention in Baltimore, MD. With the Civil War, he became a Union advocate and was commissioned a Colonel by the Governor of Kentucky to recruit and organize the 33rd KY Volunteer Infantry. He was Catholic.

**42847-3 JOHN G. JAMESON**, [Kendrick, John], was born 6/2/1854, Hart co., KY. the son of Kendrick and Ellen (Mudd) Jameson (42811). Her married January 19, 1854, Allen co., KY., Elizabeth **Moore**. They resided in Allen co., KY.

#### Notes:

Capt. Toliver Moore was born September 28, 1832, on Walnut Creek, Allen County, where he grew to manhood and now resides. In 1861 he enlisted in Company C, Ninth Kentucky Regiment, Volunteer Infantry, and in 1862 was promoted to captaincy of Company E, which position he retained until the regiment mustered out in 1864. He then recruited a company in the Middle Green River Battalion in which he remained until the regiment was mustered out in 1864. His father, Thomas Moore, a native of Virginia, removed with his parents in childhood to Warren County, Ky., and died in Allen County November 9, 1872, at the age of seventy-seven years. He married Amelia, daughter of John S. **Gibson**, of Allen County, died April 14, 1873, aged seventy-six years, and from their union sprang:

Elijah, Robert, Louisa (Atwood), William, a soldier, Elizabeth (Jameson), Capt. Toliver, Araminta A. (Mitchell) and Thomas R., killed by a horse.

On the 27th of September, 1870, Capt. Moore married Mrs. Lucinda, widow of James M. Wheeler, and daughter of John H. and Elizabeth (Gibson) Davasher, of Allen County, born November 1, 1838, and to them have been born Bettie C., John W., Francis C. and Thomas R. Mrs. Moore's child by first husband is Mollie S. Wheeler. Capt. Moore acted as assistant revenue assessor for three years, and held the position of postmaster for six years. He was also deputy sheriff four years. He is a farmer by profession, having 200 acres of productive land in good condition and in a fine state of cultivation. He is a member of the Masonic fraternity, and in politics is a Republican.
