NOTES I

The following genealogy reflects the research efforts of Mrs. Helen Johnson of Chamblee, GA and her undeniably persistent push to get at the truth. With help from other members of her family the following history has developed over the years ⁽¹⁾. Her contributions have led to the ever widening and expanding Jameson Family and the unique history that has unfolded within these pages.

NOTES II

Special interest should be taken among the families the Jamesons were neighbors with and among the places the Jamesons and their friends resided. The surnames Ruffin, Wimberly, Watson, Fort, Williams, Andrews, and Bakers in the early years and in the earliest counties-Bertie, Northampton, and Edgecombe, come to play out among their descendants in the future places of Anson co., NC., and Twiggs co., GA. The Lancasters and Alstons and Mays also play prominent parts in the early Jameson history as do the counties in North Carolina as Nash, Franklin, and Warren. The interplay of Robert and David Jemison of Twiggs co., GA. and the "feeling" one gets that they may be related to Dr. John Jameson and his children may be of some concern as we note similarities among them. It is easy to conclude that David Jameson (44613) of Anson co., NC is the same David Jemison (39310) of Twiggs co., GA. Yet too many differences pervade the unrelenting search of genealogical data between them to make any such conclusion. While Wimberley can be associated with the Jamesons of Anson co., NC and with the Jemisons of Twiggs county, GA., and there may even be a given relationship discovered for the two Wimberley families at some time, does not impart any special significance between the two Jameson clans. Augusta co., VA comes to mind in the vast valley that lays below the Blue Ridge where some fourteen Jamesons branches may never be so easily divided, but are none-the-less distinct enough to warrant new indexing.

Confusion reins among the present crop of researchers in the 1980s and 1990s for this family, all claiming some form of relationship to Dr. John James Jameson. In Wake co., NC. one source cites the following:

That these families are inter-related appears not so much in doubt, but as to how they join together. The following provides as much good facts as any in this volumous work.

43400-1 JOHN JAMES JAMESON, was born some time in the 1720s. He died just prior to March of 1761, Edgecombe co., NC. Mr. Jameson was married circa 1740/41, Bertie co., NC. Elizabeth _____. He later married about 1753, Edgecombe co., NC. Martha _____, who died in 1769, Edgecombe co., NC. They resided in Northampton, Bertie, and later Edgecombe county, NC.

Note:

Dr. John Jameson ^{*(2)} was a physician and an intelligent realtor who appears as early as 1741 in Bertie co., NC. His ancestry and parentage is unknown to us at this time, though he may have come from Virginia. A contemporary of Dr. John Jameson was a Henery Jameyson, who along with John **Stokes**, gave securities to William **Deaves**, June 20, 1749 for a 210 acre tract on the south side of Beaver dam swamp in Edgecombe co., NC[4]. The first recorded document of Jameson in Bertie co., is a land deed dated June 5, 1741, in which Charles **Stevenson**, having had it patented February 14, 1739, sold to John Jameson 1280 acres on the north side of Roanoke River adjacent to James **Castellow** for the sum of 98 pounds, 10 shillings. Witnesses were John **Davison**, and George **Doring**, recorded August Court, 1741, Benjamin **Hill**, County Clerk[1]. On August 19, 1741, Bertie co., NC., John James Jemmison, physician, and wife sold to Theophilus **Pugh**, merchant from Virginia, for 150 pounds at a neat profit the 1280 acres he originally purchased[2]. Dr. Jameson then turned around and purchased August 24th from Thomas **Baker** for 8 pounds a 600 acre tract on the north side of the Roanoke River[1]. In the first recorded deed naming his wife, Elizabeth, Jameson sold to James **Wilkins** of Northampton co., NC., 110 acres, part of a 540 acre tract patented to James **Brown**, patented November 29, 1716, May 8, 1742. This land was situated in Northampton co., on the north side of Meherrim River bounded by Mr. **Durden**, William Brown, and James Wilkins[2]. Dr. Jameson was listed in the 1743 Bertie county List of Taxpayers in which was listed five whites and five blacks. This would make his first three children, Elizabeth, John, and George all born before year end of 1743[3].

There appears to be little activity from 1743 to 1749, though no doubt he practiced his profession and raised his family in these intervening years. For his times he lived well and appears to have been well regarded by the local community. Jameson witnessed a deed[4] February 20, 1749, in Northampton co., NC., between William **Livingston**, planter in Northampton county and Joseph Livingston, planter, same county for a 181 1/2 acre tract. On August 8, 1749, John and Elizabeth Jameson sold to David **Meade** for 150 pounds some 600 acres plus situated on the north side of the Roanoke River bounded by Charles **Stevenson** and James **Castellow**, William **Williams**, and Colonel **Jones** all of Bertie co., NC.[2] William Williams of Edgecombe co., NC. then sold to John and Elizabeth Jameson of Bertie co., NC. September 24, 1752, a 350 acre tract for 300 pounds on the south side of Tar River in Edgecombe county[1]. On the same day Jameson and his wife, Elizabeth, sold to Williams a 400 acre tract for 300 pounds in Bertie co., NC. This land sat next to Theophilus **Pugh** on Apple Tree Swamp at Falling Run[2]. It appears to be an even swap between the families. Williams on August 10, 1754 sold to Dr. Jameson of Edgecombe county 364 acres on the south side of Tar River for ten pounds sterling, which had been earlier granted to Williams October 25, 1753[1]. This deed was rewritten on the same day but changed were the following: 364 acres to 365 acres; and south of Tar River joining Pittman to read south side of Tar River and both sides of Walnut Creek, joining Holliman. Otherwise

everything else remained the same[1]. In a land deed between Samuel **Holliman** of Duplin co., to Moses **Hare** of Edgecombe county, January 8, 1756 for 15 pounds for 360 acres on the south side of the Tar River which land sat adjacent to said Hare, John Jameson, on a small branch called Walnut Creek, the river, and **Cahoon**'s farmlands[1].

It is not known just when Elizabeth Jameson died. She was listed in the 1752 deed when the family removed to Edgecombe county, but no researched thus far indicates exactly when she died. Yet Dr. Jameson did remarry for the probate records of his death are filled with his widow, Martha Jameson, who was granted letters of administration in March of 1761. It can be ascertained that the children, David, James, and Jane were the issue of Martha Jameson, widow, for at the time of her death, 1769, she sold off the estate and Thomas **Williams** was appointed in Aaron Baker's place. Yet Baker maintained an interest in two of the children: David and James Jameson, for both were involved and received some portio of Baker's estate in 1782. Dr. Jameson apparently left no will and Mrs. Martha Jameson was held accountable for inventory of the estate. In June of 1761, Elisha **Battle** was appointed the guardian of Elizabeth Jameson, Sherod **Haywood** and George **Fort**, securities. The following December, Elizabeth Jameson chose Martha Jameson, guardian * (3), Samuel **Ruffin** and Thomas **Williams**, securities. During the December court, Martha Jameson was appointed the guardian of David, James, and "Jenny" Jameson, orphans of John Jameson, deceased, same securities as Elizabeth. At the June 1761 Court, John and George Jameson chose George **Wimberly** as guardian. On May 1763, George Wimberly's will was probated, but by this time John Jameson Jr. was over the age of 21 and probably given a piece of the estate to get him started.

About 1763, Martha Jameson married Aaron **Baker**, who in April of 1765 was appointed the guardian of David, James, and "Jane" Jameson. She and Aaron Baker maintained their guardianship and "trust" of Dr. John Jameson's estate until February of 1769, when Martha Jameson Baker died. At that year Thomas Williams was made guardian of the three children of John and Martha Jameson until at least 1773. After that the children appeared in various order accountable unto themselves. While married to Aaron Baker the two made the following deeds. In April of 1768, Micajah **Andrews** made an agreement with Aaron Baker to divide the lands that Andrews obtained in a judgment for his wife, Elizabeth Jameson Andrews, daughter of John Jameson. Baker was then residing on Dr. Jameson's plantation, claimed under his wife's name, Martha Jameson, wife of Dr. John Jameson, under her right of Dower. The farm consisted of 175 acres on the south side of Tar River and Baker gave up his right to two tracts of this known as Poke Island and Walnut Creek. On August 11, 1768, Aaron and Martha Baker of Edgecombe co., sold to Samuel **Ruffin** of Edgecombe co., NC., all rights to several tracts of land belonging to Dr. John Jameson. This included the 175 acre tract which Andrews conveyed to Baker April 25, 1768 and several other tracts as well. On May 15, 1769, Andrews and his wife, Elizabeth, sold to Samuel Ruffin of Edgecombe county two tracts south of Tar River and just below Sherwood **Haywood**'s property amounting to about 714 acres, this being most of Dr. Jameson's previous plantation, plus another 365 acres along Walnut Creek. Samuel Ruffin sold these two parcels(714 & 365 acres) on May 24, 1769 to Robert **Gray** of Edgecombe co., NC.

Aaron Baker resided in Edgecombe co., NC. until 1771 at which time it appears he removed to the George town District in South Carolina. Along with him went David, James, and Jane Jameson as well and they along with Baker's own children remained at the plantation situated between the Big Pedee and the Little Pedee Rivers just outside and northwest of Kingston Township. On October 15, 1777, Baker purchased a 500 acre tract from Thomas and Sarah **Williams** of Cheraw District, Anson co., NC. but seems to have kept the George town resident none-the-less. Mr. Baker died March of 1782 and the inventory of his estate was handled by David Jameson and auction by Jonathan **Jackson**, Sheriff of Anson co., NC. In a later sale performed January 28, 1784, the estate sold one "negro woman" to James Jameson of Anson co., NC. Baker was probably a brother of? Moses Baker of Edgecombe co., NC. who died around October of 1786. His 1781 will lists sons: Michael, Moses, Aaron, Thomas, Joshua, Jesse, and daughters Ann, wife of Ralph **Vickers**, and Mary, widow of Micajah **Stinson**[10].

43411-2 ELIZABETH JAMESON [John], was born about 1741, Bertie co., NC., the daughter of Dr. John and Elizabeth Jameson (43400). Miss Jameson married January 26, 1763, Edgecombe co., NC., Micajah **Andrews**, born circa 1740, son of William and Catherine Andrews. They resided in Edgecombe and Craven co., NC.

Notes:

In 1761, Elizabeth's father died and she chose to have Elisha **Battle** June 23, 1761 as her court appointed guardian, Sherwood **Haywood** and George **Fort**, securities. After her mother and law, Mrs. Martha Jameson obtained her Right of Dower, Elizabeth in December of that year switch over her guardianship to Martha, Samuel Ruffin and Thomas Williams, securities. As the administration of her father's will advanced Elizabeth Andrews appears to have inherited the entire estate belonging to her father. With her husband, Micajah, an agreement was reached with Aaron **Baker**, Martha Jameson's second husband, in which Martha's right of Dower divided the lands Andrews' obtained on his wife's behalf during the April 1768 Court session. The Bakers were already residing on this division which consisted of 175 acres on the south side of Tar River, though Baker gave up two tracts known as Poke's Island and Walnut Creek which consisted of 714 acres and 365 acres, respectively. In the following year the Andrews removed to Craven co., NC. after selling the two tracts of land to Samuel **Ruffin** May 15, 1769 for 400 pounds. These two tracts were then sold Robert **Gray** nine days later by Ruffin.

Micajah Andrews father, William died November of 1761. In his will, dated October 20, 1761, he lists the following people: son Henry, William, Abraham, Isam, 12 shillings each; daughters-Jean **Bryant**, Amey **Bailey**, 12 shillings each; son, Micajah, desk, etc., and 240 acres in Halifax co., NC, situated near Wigger's Cart Road bordering Joseph **Moore** and **Wiggins**; wife, Catherine, lend use of plantation, livestock, etc., for her natural life, and after her death to son, Jesse Andrews, and should he died without heirs, to Micajah Andrews; son, Jesse, two tracts of 400 acres; executors: wife, Catherine, sons, Henry and Jesse[4].

43413-2 DAVID JAMESON [John], was born about 1754/5, Edgecombe co., NC., the son of Dr. John and Martha Jameson (43400). Mr. Jameson married Ann _____(Baker?) and they resided in Anson co., NC.

Notes:

Mr. Jameson was orphaned at any early age, under 14, when his father died in 1761. When his mother, Martha Jameson, received letters of administration on Dr. Jameson's estate, she was appointed his guardian in December of 1761, but joint guardianship occurred in 1765 when she married Aaron **Baker** in 1763 and he took over the estate. Aaron Baker retained guardianship until 1769, when Martha Jameson died and the court appointed Thomas **Williams**. This lasted until 1773, Mr. Jameson appears to have been declared of legal age and responsible for himself. His first recorded document occurred on March 7, 1771, Edgecombe co., NC. when he witnessed a deed from Thomas Williams to John **Davenport** for an 80 acre plantation on the north side of Tar River and Compass Creek, a tract conveyed to Williams by William **Taylor** in March of 1770.

Mr. Jameson had a close association with Aaron **Baker** up until Baker's death in 1782, when Jameson inventoried his step-father's estate April 1 of that year. David Jameson and Aaron Baker removed to the Georgetown District of South Carolina, settling at a spot between the Big and Little Pedee Rivers just northwest of Kingston township which is situated on the upper coast of South Carolina. Yet on October 15, 1777, Baker, planter, purchased 500 acres in Anson co., NC. from Thomas and Sarah **Williams**, and had decided to move back with his family. On November 23, 1778, David Jameson of Prince Frederick Parish(Georgetown District), SC. purchased from Charles and Elizabeth **Clark** 400 acres on the west side of Lick Branch of Gould's Fork of Browns Creek in Anson co., NC. And over the next few years he appears to have traveled back and forth between plantations. On September 28, 1779 he and brother James Jameson witnessed the will of John **Haymes** of Anson co., NC which was proved in the October Court session that year. They were both signers to a document relating to the division of the county in 1779. On September 28, 1782 he purchased from William **Helms** 10 acres on the west side of Rocky Fork of Jone's Creek, including Mill seat. Oddly enough he received a grant from the State of North Carolina of 350 acres *(4) on the southwest side of the Pee Dee River(Pedee) on Little Flat Fork on Brown's Creek October 14, 1783. From June 6, 1784 to April 5, 1785 David Jameson was involved in an assault upon his person by John **Day** in Georgetown, SC. The case was decided in his favor.

From the mid 1780s on until he left Anson county in the mid 90s a flurry of activity whirled about Jameson. David Jameson along with Jesse Gilbert, Pleasant **May**, Samuel **Spencer**, and Thomas **Wade** were the Anson

county delegates to the 1789 United States ratification convention for the U. S. Constitution which was held in Fayetteville, NC and attended by 271 people. Interestingly enough, a William **Lancaster** was a delegate at the same time from Franklin co., NC. Some reversal of fortune seems to have occurred in the 1780s and 1790s and by 1794 Jameson was gone from Anson county. The difficulties he had appear to be primarily his property taxes in arrears. Early probate records shows David Jameson as a buyer of the estate of James **Childs**, 1780, and John **Williamson**, 1782, administrator of the estate and one of its buyers. In the following years he continued to purchased property: 2/11/1785-Milberry **Bennett** to Jameson, 50 acres, Bertie co., NC; 4/1785-Thomas **Wade** to Jameson, 1/2 a., Lot #4, Newtown, Anson co.; 5/10/1785-James **Howard** 350 a.,sw side Pee Dee R., n. side Rocky Fork of Jone's Creek, bounded by William Bennett Jr. son Of William Sr. and bro. to Millberry Bennett; 4/21/1786-John **Ivey**, Georgetown, SC to Jameson, 150 a. Anson co., sw side PeeDee R., on w. branch of Flat Fork of Brown Ck; 10/18/1787-Patrick **Boggans** to Jameson 62 a., s. branch of Flat Fork of Brown Ck; 2/27/1788-Abner **Harrel** to Jameson, 50 a., s. branch of Flat Fork on Brown Ck, James Jameson witness; 5/10/1790-Sheriff Jesse **Gilbert** to Jameson 95 a., East Branch of Flat Fork of Browns Ck.

On the other side of the coin he resold much of what he bought as well: 10/24/1784-David and Ann Jameson to James **Boggans** Jr, 400 a. Clark land; 4/21/1786-to Lewis **Lanier**, 1/2 a. Lot \$, Newtown; 5/10/1790-to Daniel **Gould**, 150 a., sw side Pee Dee R., w. branch of Flat Fork of Brown Ck; 5/10/1790-62 a. to Daniel Gould s. branch of Flat Fork of Browns Ck; 11/24/1787-to Ralph **Vickers**, 100 a., e. side Cader Ck., bounded by Elisha **Bonds** & 350 a. Little Flat Fork of Browns Ck; 5/10/1790-to Daniel Gould, 50 a. s. branch of Flat Fork of Browns Ck; 5/10/1790-to Daniel Gould, 95 a. e. branch of Flat Fork of Browns Ck.

In 1786, Jameson, Jesse Gilbert, Charles **Sparks**, and George **Hammons** appeared December 1, 1794 Court for arrears of taxes amounting to 923 pounds, 2 shillings, 7 pence which was paid through the selling of Jesse Gilbert's holdings of two tracts: 108 acres on River Bank below the mouth of Richardson's Creek; and another 100 acre tract adjoining the first tract on both sides of Richardson's Creek, the proceeds going to the state and the property having been purchased by Phillip **May**. On May 8, 1797 and July 17, 1806, the sheriff of Anson county in both cases sold portions of David Jameson's land in order to pay off the taxes that accumulated over a period of time. The 1794 sell-off was to help pay off the 1786 tax, the 1797 to pay off the 1794 and the 1806 to pay off the 1797 tax liens against the property. Jameson had long since left, probably about 1794 and removed to Mecklenburg co., NC.

Mrs. Ann Jameson died some time between 1797-1799. In the 1800 census for Mecklenburg county was listed one male and one female under 10, two females between 10-16 and one each male and female 16-26. According to the 1790 census they had 3 sons one of which is no longer recorded in the 1800 census and probably died young. Mrs. Jameson was not listed in the 1800 census either making her death some time previous to this enumeration.

43414-2 JAMES JAMESON [John], was born around 1756/7, Edgecombe co., NC., the son of John and Martha Jameson (43400). Mr. Jameson died March 27, 1815 in Twiggs co., GA. He married about 1783, Nash co., NC? to Christiana Emeline **Linnington**, possibly the daughter of George Linnington. Mrs. Jameson died March 2, 1821 in Twiggs co., Georgia. They resided Fayette, Anson co., NC.

Mr. Jameson was left an orphan at an early age when Dr. John Jameson died in 1761. And like David, his brother documented above, was brought up by his mother, Martha Jameson, until her death in 1769, and by her second husband, Aaron **Baker** until James was old enough to be on his own. Baker kept some inheritance in trust for the boys with the settlement of the estate with Elizabeth Andrews and when they all came of age he helped them in their early careers doling out the behests. James, David, and Jane Jameson along with Baker's own children all removed to Georgetown District, SC. with Baker in 1771. By 1777, Baker ^{*(5)} had purchased from Thomas and Sarah **Williams** a 500 acre tract in Anson co., NC. which he removed to in that year. In 1779, Jameson and his brother, David, both of Anson co., NC. were witnesses to the will of John **Haymes**, September 28, in which David Jameson, Esquire probated it in court in 1784. Mr. Haymes names his wife, Ruth, daughter Betty Ann **Hancock**, daughter Charity **Thomas**, and son William. He names his wife and William **Hammock**, and William **Best** as executors. James appears to have been residing in Nash county, NC. in 1782, possibly among some of the Lancaster/Alston relatives that were residing here and in the nearby counties. His sister, Jane, no doubt was the one who married William Lancaster October 1, 1784 in nearby Warren co., NC.

By 1784, Mr. Jameson was residing in Anson co., NC[3] and received that year from Aaron Baker's estate one negro woman. He purchased in 1785 from John **Boggans**, son of William who originally owned the 330

acre tract southwest of Pee Dee River on Goulds Fork on Browns Creek, 200 acres of the original. As with David Jameson this property James (Jamerson) lost through seizure and was sold October 1, 1796 by Sheriff Patrick Boggan by an order issued from Montgomery county, NC in the sum of 41 pounds for failure to pay taxes-John **Wright** Jr. buyer. The other 130 acres Boggans sold to James M. **Lain** in that year which was confirmed in 1794. On February 27, 1788, Anson co., NC., James Jameson was a witness to a deed from Abner **Harrel** to David Jameson.

George Linnington's will was dated January 24, 1741, Craven co., NC. A Christian Linnington, probably a daughter of George, married 1747, Craven co., NC., to James **Alston**, who died in 1761, Orange co., NC. Obviously, this Christian was entirely too old to be the one who married James Jameson. On the other hand research may prove that a son of George Linnington may have had a daughter, Christiana, who would have been born in the 1750s and been of more correct age to James Jamesons[5]. Interestingly enough, Catherine Linnington married Van Holt **Nash** and their daughter, Nancy, born February 28, 1800, NC, died September 28, 1869, Geneva, Talbot co., GA., married George Jameson, son of James Jameson(subject under discussion)[6].
