JAMES JAMISON OF ROWAN COUNTY, NORTH CAROLINA

44500-1 JAMES JAMISON, born circa 1720s, died August 1778, Rowan co., NC. Mr. Jamison married circa 1747, Isabel **Kerr** ^{*(1)}. Mrs. Jamison died prior to 1790, Rowan co., NC. They resided in Rowan co., NC where they died.

Notes:

Mr. Jamison's ancestry and previous whereabouts are unknown. The earliest records of him were: a 1765 grant of land along Bullocks Creek in Rowan co., NC; and an additional grant in 1768 on Broad River; a 1768 tax list[9] and his appointment as constable January 17, 1769 in place of James **Hains**[1]. On February 16, 1770 James **Robinson** replaced Jamison as Constable for the new year. However, two other Jamisons were in the area in 1767: Joseph Jameson[2] listed as a witness September 16, 1767 between John and wife, Jane, **Oliphant**, 183 acres along the Catawba River; and William Jamison of Charlotte co., VA., buying 600 acres on the south side of Dan River February 20, 1767[2]. Others of the name and early settlers of Rowan co. were Arthur Jamison, 1785, and Thomas Jamison, 1788. The history and genealogy on these last two can be found under Index #44200. In 1770, James Jamison was listed upon the tax rolls[3], but for the most part little emerges until his death in August of 1778 and the reading of the will as follows:

"In the name of God Amen. This third day of July of our Lord 1778. I James Jamison of Rowan county in the State of North Carolina, being Sick and weak in Body but of Sound Mind & memory, thanks be to God,

therefore: Calling to mind the Mortality of the Body.....”

“First, I allow all my lawful Debts and Funeral charges to be paid out of the whole of my Estate.

I Give & Bequeath unto Isobel my Dearly beloved wife her Horse & saddle, her Bed & its Furniture together with her wearing apparel & spinning wheel.

I Give & Bequeath unto Elenor my oldest Daughter her Saddle & Bridle & her wearing apparel & her Bed.

I Give & Bequeath unto my two sons William Jamison and David Jamison all my right and title to the plantation wheron I now dwell, to be equally Divided between them & it is my will that Each of my said Sons have a Grant for his own part, so they do not Disturb their mother during her Widowhood; With whom I allow them and the younger Children to live in the fear of God until they come of age or marry.

It is my will that the remainder of my personal _____ two bushels, which I allow for the support of the family be sold at publik Vendue, and the money _____ arising to be equally Divided between my Wife and my seven children, each of them to have one Eighth part thereof.

I nominate constitue & appoint my dearly beloved wife Isabel Jamison & my beloved son William Jamison executor of this my Last will &

*Testament, and my trusty friends Robert **Cochran** and John **Braly** guardians of my Children, with whom I allow my Executor to Advise & be Directed in all matters concerning the children’s Estates & Ratifying & Confirming this And no other to be my last Will and Testament, In witness whereof I have hereunto set my hand & Seal*

*John **Braly***

*Robert **Cochran** James X Jamison seal*

*Alason **Floming**{Fleming}[4].”*

With the will probated, Isabelle Jamison, under Capt. Dickson’s Company, paid off her 1778 taxes of \$419.13. The will was proved by James **Braly**, widow Jamison, and son William Jamison; an inventory was returned on November 3, 1778, Esquire William **Cathey** attending to James Jamison’s affairs. After this a flurry of deed transactions occurred in the following years.

February 5, 1778, State grant #112, 640 acres on Dixons Creek, a branch off Coddle Creek, bounded by David Kerrs on the west, Joseph Dixon on the south, Hugh Parks line and the balance on vacant land[8].

February 6, 1778, State grant #255, Alexander Aston, 300 acres on East Branch of Coddle Creek adjoining Hugh Parks on North, James Jamison on East, Widow **Baker** on the south and vacant lands on the west[8].

April 9, 1778, State grant #722, Joseph Dickson 670 acres on Coddle Creek and bounded north by David Kerr, west by Thomas Cook and James McKnight, south by Robert Cochran and George **Flemming**, and east by James Jamison[8].

August 18, 1778, State grant #1396, Robert **Carlisle**, 200 acres bounded on the north by John Braley, on the west by David Kerr, on the south by Widow Jamison, and on the east by his own survey[8].

July 1, 1779, State grant #11 at 50 shillings 100 acres to Elizabeth **Baker**, 250 acres on Hugh **Parks** Creek adjoining James Jamison, Alexander **Aston**, John **Lowery**, and Jannett **Kennedy**[5&6].

July 1, 1779, State grant #50 at 50 shillings the 100 acres to Alexander Aston, 300 acres on Hugh Parks Creek, waters of Cottle Creek adjoining James Jamison[5&6].

July 1, 1779, State grant #45, at 50 shillings the 100 acres to Joseph **Dickson** the 720 acres on Coddle Creek adjoining Robert **Cochran**, George **Fleming**, James Jamison, deceased, David **Kerr**, Thomas **Cook**, and James **McKnight**[5&6].

July 1, 1779, State grant #28 at 50 shillings the 100 acres to William Jamison and David Jamison, sons of James Jamison, deceased, 640 acres on Coddle Creek adjoining lands of David Kerr, Joseph Dickson, George Fleming, and Hugh Parks[5&6].

July 1, 1779, State grant #26, at 50 shillings the 100 acres to Jannett Kennedy, the 400 acres adjoining John Lowery, Mr. **Huston**, Hugh Parks, and James Jamison, deceased[5&6].

December 31, 1781, Joseph Dickson, Gentleman, to Archibald **Woodside** for 2000 pounds, processed money, 349 acres on Coddle Creek adjoining Fleming, Jamison, Kerr, John Woodside, James Dickson; proved 2/1783 Court[5&6].

October 10, 1783, State grant #590, at 50 shillings the 100 acres to John **Braly** 400 acres on Coddle Creek adjoining his own land at that of William Braly, William **Kellum**, Robert Carlisle, Alexander Aston, and James Jamison, deceased[5&6].

April 20, 1786, William Jamison and David Jamison to John Park for 100 pounds, 139 acres in Rowan co., part of 640 acre grant; John Braly, witness; proved 5/1786[5&6].

April 20, 1786, William Jamison and David Jamison to John Jamison, part of 133 acres[7] of land inherited from their father.

Sarah **Braly**, wife of John Braly whose close friend was James Jamison, made her will October 27, 1800, naming her daughters, Ann, Mary, Peggy, and Peggy's daughter, Sally, and sons, James, and his wife, Ruth, son, John, and John's daughter, Sally,, and son, Hugh, and Hugh's daughter, Sally **Carruth**. Executors were sons Walter and Hugh, witnessed by John Braly and James Jamison[12]. The will of John Braly Sr.⁽²⁾ provides a little more insight to the Jamison-Braly relationship. In it he names his daughter, Margaret (Braly) Jamison and provides her with "*the negro boy named London now in her possession.*" Braly's will was dated April 21, 1797 in Rowan co., NC. He mentions wife, Sarah (**Carruth**), and the following children:

Agnes **Downell**, Walter Braly, Margaret Jamison, John Braly, Anne **Aston**,

Sarah **Bigham**, Hugh Braly, Mary Jane **Oats**, and James Braly. Property to be sold were four lots in the north square of Salisbury. Walter and Hugh Braly, executors and witnessed by William and John Jamison.

44510-2 WILLIAM JAMISON [James], was born circa 1748, the son of James and Isabel (Kerr) Jamison (44500). Mr. Jamison married about 1770, Rowan co., NC., Miss **Alexander**. Mr. and Mrs. Jamison died after 1810. They resided alongside Coddle Creek in Rowan co., NC. where presumably they died.

Notes:

It is doubtful that the William Jemeson of Charlotte co., VA. listed in the February 20, 1767 land deed purchasing from John and Edward **Hunter** a 600 acre tract south of Dan River is the same William, son of James Jamison of Rowan co., NC[1]. He was one of the executors of his father's will in 1778 and he and brother, David Jamison, equally splitt the plantation[2]. Jamison and his brother, David, sold a portion of the 133 acres of this land to their brother, John Jamison on April 20, 1786[3]. In 1795, John Jamison and William Jamison were witnesses to the will of Hugh **Parks**, dated May 10, 1795[2]. Mr. Jamison gave his security for his daughters, Jane Jamison to Robert **Cochran** in 1796, J. **Troy**, witness, and for daughter Mary Jamison in 1820 to David **Morton**[4]. William, along with his two brothers, William and John Jamison, were taxed in Rowan co in 1815. They were taxed upon land sited at Sills Creek(259 acres), Coddle Creek(254 Acres), and Coddle Creek(253 Acres), respectively[5]. Cited in the will of Hugh **Braly**, proved November 1825, tract of land adjoining Williford **Cochern** and William Jemeson. Hugh names sons, Rowan C., eldest, Sanhope, John, and William Braly[6].

- William Jamison's #44522 will was dated June 21, 1838 and proved August 1842, Rowan co., NC. He names William **Hargrave**; witnesses Hugh **Parks**, Archibald M. **Woodside**; he mentions

niece, Eleanor Milford, \$300.00;

brother, John M. Jamison, \$800.00;

sister, Jane Cochran, \$400.00;

brother, James Jamison, \$400.00;

sister, Mary Morton, \$100.00;

Mr. Hargraves on May 30, 1846 was brought to court to account for indebtedness to the estate to the amount of \$3,596.30.

44511-2 ELEANOR JAMISON [James], was born circa 1750, the daughter of James and Isabel (Kerr) Jamison (44500). Miss Jamison married January 30, 1780, Rowan co., NC., Thomas **Milford**. They resided in Rowan co., NC.

Notes:

A particular problem with Eleanor Milford is the will of William Jamison(#44522) in which he names niece Eleanor Milford. With Eleanor's marriage to Thomas Milford dated as 1780, it is more probable that his niece was in fact his cousin instead. Even had William Jamison married Miss Alexander say in 1765, Eleanor still would have only been fifteen at the time of her marriage to Thomas Milford. While no one fact verifies this speculation, its hardly reasonable to consider that Eleanor Jamison (44525) could have married Thomas Milford and had the child, Eleanor. Note also that William Jamison (#44522) did not name a sister, Eleanor in his will, though if he had a sister, she might have died prior to his own death in 1842. Yet the will of John M. Jamison (44521) states explicatedly "to the heirs of my sister Eleanor Mitchell, \$1200.00." Was Eleanor Milford dead by this time? The issue remains unresolved especially in light of William Jamison's (44510) lack of testate and Eleanor's very early marriage to Milford in 1780.

44512-2 JOHN JAMISON[James], was born circa 1753, the son of James and Isabel (Kerr) Jamison (44500). Mr. Jamison resided in Rowan and later along the northern region of Mecklenburg co., NC.

Notes:

Mr. Jamison purchased a portion of 133 acres of land sold to him by his brothers, David and William Jamison on April 20, 1786. This land may have been a part of his father's plantation. John Jamison and his brother William Jamison were witnesses to the will of Hugh **Parks** May 16, 1795 in Rowan county. Mr. Jamison and his family resided in the area of Coddle and Sills Creek, Rowan co., NC.

No other records appear for him excepting those records in Mecklenburg co., NC in which the following apply:

1798, listed in Capt. _____ Company, 195 acres, 1 white poll[4]; both John and Samuel Jamerson listed, Samuel having 190 acres and 1 white poll and 1 black poll;

In 1800, probably the John Jimison residing in Iredell co., NC about Coddle Creek where the rest of the Jamisons had settled.

son of William and _____ (Alexander) Jamison (44510). He died November 3, 1846, Rowan co., NC. Mr. Jamison married 1810/11, Rowan co., NC., Elizabeth **Hughes**, born September 20, 1780, and died August 13, 1861, Mooresville, Rowan co., NC. They resided in Mooresville, NC.

Notes:

Mr. Jamison resided in Mooresville, NC. His lands were adjacent to William Hargraves. Mr. Jamison was a witness to the making of the will of Sarah **Braly** on October 27, 1800 *(4). Mr. Jamison along with other commissioner members John **Andrews**, William H. **Kerr**, John M. Jamison, John **Graham** divided the real and personal estate of William **Erwin** Jr. on August 1819. The results of the division were as follows:

Lot #1, Elizabeth B. **Erwin**, 121 acres adjacent John Graham, Israel **Wood**, and Charles **Down**; valued at \$309.60;

Lot #2, 90-1/2 acres on Blythes Creek adjacent James Jamison and Mrs. **Emerson**'s dower, valued at \$372.50;

Lot #3, Margaret L., widow of William Erwin, now the wife of John, **McLean**, 86-1/2 acres adjacent James Jamison, Lot # 2, and Charles Down, valued at \$381.50.

Mr. Jamison was the executor of the will of Hugh **Allen**, dated March 6, 1828 and probated 1831. The will mentions wife, Martha, nephews- David **Foster**, Hugh A. **Masters**; nieces- Martha, Catherine, Elizabeth, and Agnes Foster; Elizabeth **Brown**; witnesses: Jonathan Foster; James F. Jamison.

Mr. Jamison's will was dated November 6, 1846 and proved February 1847. It reads in part....

"Amen I James Jamison of the County of Rowan State of North Carolina being of sound Mind and memory.....

I First it is my will that all my just debts should be paid."

2 I will and bequeath my negro family to my four sons James F. Jamison, John E. Jamison, Gustus W. Jamison and Milas I. Jamison to make their own division so as to allow John E. Jamison something extra for additional services over and above the rest

Also the plantation I now live on to be equally in value divided between my four Sons as Above named.

3 I gave and bequeath to my beloved wife her living of the plantation where I now live and the choice of one negro during her life and at her death to be divided as above named

Also All the household and kitchen furniture crops on hand stock of all kinds waggon and farming tools of every descriptin and at her death to be divided between my four sons as above named.

4 I will to my daughter Isabella Lazar the land I own agoing William Hargrove and others and Each one of my sons as Above named to pay back to my daughter Isabella fifty dollars each

and Lastly I do hereby constitute and Appoint my sone Jas F. Jamison my lawful executor.....”

Mr. and Mrs. Jamison died in Mooresville, Rowan co., NC and were buried at Prospect Presbyterian Church Cemetery in the 82nd year of her life.

- James F. Jamison (44553) died intestate, Letters of Administration granted J. G. **Niel**, May 10, 1894, inventory amounting to sum total of \$8.75 equally divided among the legatees: Sina{Lina} **Smith**, Amanda E. **Neely**, Sinora **Lourance**, and Emma **Torrence**. Amanda E. Jamison married James C. **Neel**{**Neely**} September 24, 1872, Rowan co., NC; Sina Smith was the child of George L. and Margaret (Jamison) Smith who were married December 16, 1868, Rowan co., NC; and Linora or Leonora Adelaide Jamison married David Wilson **Lowrance** {Lourance} February 19, 1879, Rowan co., NC.

44521-3 JOHN M. JAMISON [William, James], was born circa 1773, Rowan co., NC., the son of William and (_____) Alexander Jamison (44510). He died in April of 1860, Rowan co., NC. Mr. Jamison married Rowan co., NC., circa 1800, Margaret **McKnight**, died July 26, 1853, Rowan co., NC., the daughter of William and Sarah McKnight.

Notes:

It appears that Mr. and Mrs. Jamison died without apparent children and left most of their estate to relatives on both sides. Mr. Jamison received the bulk or \$800.00 of his brother, William's, estate in 1842. The 1815 tax list shows he was taxed on 259 acres along Sills Creek in Rowan co., NC. He was one of several commissioners along with his brother, James, who divided and settled the estate of William **Erwin** who died 1819.

Mr. Jamison's will was dated August 18, 1847 and proved May 1860. In it he mentions:

wife, Margaret, deceased; ...

*...to the heirs of John **McKnight**, namely sons-Ezekiel, Thomas, James, & John \$50.00 each;*

to daus-Nancy & Margaret, \$50.00 each;

*to Priscilla E. **Graham** and Mariah L. Graham \$50.00 each;*

*to nephews Hugh M. **Sloan** & James Sloan and nieces Margaret **Bailey** & Elizabeth **Weir** \$50.00 to each;*

*to two daughters of Jane **Hope** \$50.00 each;*

to my nieces Mary A and Sarah H. McKnight \$50.00 each;

to nephew George Q. McKnight, niece Sarah McKnight, Margaret L. McKnight, Mary A. McKnight \$50.00 each;

*to my nieces daughters of Tirza **McKee** \$50.00 each;*

to the heirs of my sister Eleanor Milford, \$1200.00;

to the heirs of my sister Jane Cochran, \$1200.00;

to the heirs of my brother James Jamison, \$1200.00;

to my sister Mary Morton \$200.00 if living, otherwise to other siblings;

balance of estate to be sold real and personal after my death and divided among the legatees;

*I appoint Robert **Cochran** and James F. Jamison as my Executors;*

*witnesses: Hugh **Parks**, John **Beaver**;*

“I, John E. Jamison of the county and state aforesaid being of sound mind and memory but considering the uncertainty of life, do make this my last Will and Testament: - I give devise and bequeath to Amanda, my beloved wife, all my real and personal property so long as she lives, or remains my widow.

“I will and bequeath that at the death, or marriage, of my wife thall all my real and personal property be equally divided between my three sons, James C. Jamison, Winslow S. Jamison, and William M. Jamison.

“I will that at my death my executor, hereinafter named, shall provide for my body a decent and christian burial, suitable to the wishes of my relatives and that he pay any and all of my just debts.

“And I do constitute and appoint James C. Jamison sole executor of this my last Will and Testament.

“In witness whereof, I the said John E. Jamison have hereunto set my hand this 12th day of Nov. 1896.

C. L. Walter J. E. Jamison seal”

June 6, 1800, an inventory and appraisal of the estate was made totaling \$3000.00.

Mr. Jamison was the bondsman for his young daughter ,Sarah J. Jamison; witness, mother, Amanda Jamison; marriage by W. B. **Watts**, Minister of the Gospel. Mr. Jamison and David **Kilpatrick** were witnesses of the will of Hugh **McKnight**, dated December 26, 1846 and proved August 1847; McKnight names wife, Sarah, son Franklin, executor. He was also bondsman for Jane J. Cochran to William B. **McLean**, October 2, 1849, J. S. **Myers**, witness.

- James C. Jamison(44603) was granted Letters of Administration for Mrs. Cora Jamison, wife of William M. Jamison(44601), February 2, 1927, Rowan co., NC. The following amounts were indicated:

Mr. Jamison died intestate and John E. Jamison was granted Letters of Administration January 29, 1873. The estate inventory came to \$450.00 and the legatees were: Sirina A. Jamison; John F. Jamison; Lalou Jamison; Lilly H. Jamison; Minnie Jamison, and one infant child. On December 8, 1874, John E. Jamison vs. John F. Jamison, Willie L. Jamison, Lillie R. H. Jamison, Minnie L., Jamison, and Augustus J. Jamison to appear within 20 days in a complaint brought by plaintiff to “*apply to the court for the relief demanded in the complaint*” said complaint in which John E. Jamison wishes to make sale of the 138 acres of land belonging to Miles S. Jamison, deceased, December 6, 1889. An inventory estimated the estate value at \$1535.00 and that W. L. Jamison, Lulie H. Jamison, Minnie L. Jamison, J. A. Jamison, and James F. Jamison are her heirs.
