# **ROBERT JAMESON OF VIRGINIA**

**53200-1 ROBERT JAMISON**, was born circa 1760, possibly (Botetourt co.?), Virginia. He died January 13, 1826 in Todd co{Logan co}<sup>(1)</sup>., KY. Mr. Jamison married first, September 3, 1778, Ruth Webster,<sup>(2)</sup> born 1761, VA, d. August 10, 1790, Botetourt co., VA[11]. He married second, March 22, 1791, Va, Nancy Agnes Edgar.

#### Notes:

Mr. Jameson{Jamison} came from Botetourt co., VA. According to the Bible Records listed in Ref #11 Robert and his family migrated September 26th, 1786, from Chester co., PA and settled in Botetourt co., VA[11]. The family left Virginia on September 17th, 1798 and settled in Logan co., Ky. He may have had a brother, John Jamison, who was also residing in Botetourt county as well. In Logan county in 1800, there were three men: Andrew Jamison, Robert Jamison, and William Jamison, probably all brothers and all from Botetourt(Rockbridge) county, VA. The Andrew Jamison taxed in 1800 is apparently not the same Andrew Jackson Jamison listed for Robert and Ruth Jamison since he would have been only 13 years old at the time of the 1800 Tax list in which the Andrew Jamison was listed on. Robert Jamison may also have had a brother, John Jamison, residing at the same time in Botetourt co., Va as he. This John Jamison had a son named John Jamison who married Elizabeth **Douglass**<sup>(4)</sup>. These marriage returns are as follows:

Minister Returns shows marriage 15 June 1815, by John Helms."[5] Further information provides the following: "John Jamison and Elizabeth Douglas, 24 Feb. 1807; bondsman-James Lockhart; con-John Douglas, father- 24 Feb 1807; wit. James Lockhart & Charles B. Rhoades, minister D. Blain(Lexington, VA.) 5 Mar 1807."[7] James Lockhart, also of Rockbridge co., VA, was a son of Jacob Lockhart and may be the James Lockhart in Botetourt co., VA. Both appear in Rockbridge county, but one settled in Georgia while his brother, William Jamison, also of Botetourt co, migrated to Woodford and Warren counties, KY. This Robert Jamison{Jemison} married Nancy Kirkham, a daughter of Henry, who resided on the James River near Lexington, Rockbridge co., VA. William married Nancy Kirkham, a grand daughter of Henry Kirkham. The point to all this is to separate some of the Jamisons and to point out that in Belleville, Washington co., MO another "John Jamison, b. Virginia came to Black River before 1830 from Kentucky. Purchased land from the government in 1831; rem, to Searcy co., AR shortly afterward."[8] This John Jamison who stopped in MO before going on to Arkansas, was the one who married Susannah Cape in Cumberland co., KY.

Jamison's will was dated December 12, 1825 and proved February of 1826 in Todd County. Twelve years later a John Jamison, same spelling, had a will proved in 1837, Todd County. In Robert's will mentioned was wife, Nancy; sons-Enos, Sidney, Ephraim, Andrew, Permelia, Presley M., Rose Alinda Ring, and Sarah. Executors, wife & son, Enos; witnesses were Spotsworth Smith, S. W. Varney{Carney}, and Richard Bowlding. In 1814-15, Spottswood Smith of Virginia settled in the section near Spring Creek. Contemporary arrivals were Henry Jetter, Squire William M. Terry, William Willis, Samuel Taliaferro, William King, John Roach, Daniel Hasser, Frank Eddington, John P, Balor and Hock Madison. Hon. D. B. Smith was born January 8, 1827, in Todd County, Ky., he is a son of Spotswood Smith and Martha A. (Terry). The father was born December 14, 1800, in Louisa County, Va.; he came to Kentucky in 1816, and two years later settled in what is now Todd County, and at present living with his son.

A Robert Jamison is listed for Logan co., KY. In his will and probate records are the following people:

Maxamilian, son, Juliana Davidson, daughter, son Robert, Elizabeth and Martha, daughters, unnamed Wife. An additional probate records Mason Jamison as administrator of Estate on the following November. These people may not be related[9,10].

The will of Robert Jamison reads as follows:

In the name of God, Amen I Robert Jamison \_\_\_\_\_ of Montgomery County in the state of Tennessee being very weak in body and considering the mortality of man deem it \_\_\_\_\_ to dispose of my worldely property in the following manner.

Viz Item 1st my will and desire is that my wife Nancy Jamison have at a loan the common use of my tract of land lying in Todd County Commonwealth of Kentucky as per my deed from William Jones sent to me together with all and singular the other and every pieces of property except monies goods and chattles of whatever nature or sort forever to the use of herself and for the use and benefit of my children Enos Jamison, Sidney Jamison, Permelia Jamison, Presly M. Jamison, Ephraiam C. Jamison and Andrew Jackson Jamison to school and maintain the three last named sons in some common useful rules of learning such as is usual with common farmers of the neighborhood the rest or balance of such property to be kept as a common stock for all their common use and benefit until the death or marriage of my wife Nancy Jamison whichever may first happen or take place then at the death or marriage of my wife Nancy Jamison whichever may first happen or take place my desire and will is that the land and all the balance of property be sold at a credit of twelve months and well secured except my wife Nancy's featherbed and furniture which I give to her forever and the money and proceeds of such sales of property or properties may be divide between my above named children Enos Jamison, Permelia Jamison, Presley M. Jamison, Ephraim D. Jamison and A. Jackson Jamison one share each except the sum of eight dollars which I give in the following manner.

Viz Item 2nd I give and bequeath unto my son George Jamison the sum of one dollar and he is not to come in for any other part of my estate

Item 3rd I give and bequeath unto my son Tomas Jamison the sum of one dollar and he is not to come in for any other part of my estate

Item 4th I give and bequeath unto my son Robert Jamison the sum of one dollar and he is not to come in for any other part of my estate

Item 5th I give and bequeath unto my son Isaac Webster Jamison the sum of one dollar and he is not to come in for any other part of my estate

Item 6th I give and bequeath unto my son William Jamison the sum of one dollar and he is not to come in for any other part of my estate

Item 7th I give and bequeath unto my daughter Rose Alinda Ring the sum of one dollar and she is not to come in for any other part of my estate

Item 8th I give and bequeath unto my daughter Rebecca Ireland the sum of one dollar and she is not to come in for any other part of my estate

Item 9th I give and bequeath unto my daughter Sara Ireland the sum of one dollar and she is not to come in for any other part of my estate

Item 10th my will and desire is that my wife Nancy Jamison act as my Executrix and my son Enos Jamison my Executer to this my last will and testament making void all former will or wills by me in any wise made.

Item 11th my further will and desire is that the portion described to be left to the children named in the first item above in case one or any of them should die before they come into the provision of such for a portion or before they marry or have a child in either of said cases the survivors portion so allocated would be belonging to the survivor or survivors of them the first named children after the same for a portion of shares of first mentioned in said first item. I \_\_\_\_\_ in testimony whereof I have here unto set my hand and seal this twelfth day of december in the year of One thousand Eight hundred and twenty five (the words in interline in the fourth line from the bottom of page (of them the first named children) mine in tender before the signing of the same

**53211-2 GEORGE W. JAMISON,** [Robert], was born December 5, 1780, Botetourt co., VA the son of Robert and Ruth (Webster) Jamison(53200). He died March 26th, 1836, Johnson co., AR. Mr. Jamison married March 10, 1808, Christian co., KY, Mary Dickinson Logan, born September 2, 1793, Ky, died May 1, 1834, Johnson co., AR, the daughter of Jonathan and Frances (Thurmond) Logan of Logan co., KY.

# Notes:

Mr. Jamison, according to the Bible records[4] migrated to Breton, Washington co., MO and arrived there May 3rd, 1814. From there they removed to William Hills Saw Mill in Pinery, MO October 21, 1817, but by May 2nd of 1818 they were in their own home on Bate's Creek, Washington co., MO.[4] By March 13, 1820 they moved once again to Mill Creek. But they were still not happy for they moved for the last time on Nov. 7th 1830 from Washington co., MO and finally settled December 22nd of that year at Jonathan Logan, Pope co., AR.[4]

Mrs. Jamison's parents Jonathan and Frances Logan set out from Christian co., Ky to St. Francis River in LA November 27, 1808.[4]

Mr. Jamison married February 16, 1815, Christian co., KY, Mary Edgar, born December 15, 1797, Logan co., KY and died June 1, 1854, Potosi, MO the daughter of John and Permelia (Ewing) Edgar. They resided in Washington co., MO and Pope co., AR.

### Notes:

Mr. Jamison was born in Botetourt co., VA. His parentage had been unknown until recently during this author's research when it was found that he was the son of Robert and Ruth Webster Jamison. Mr. Jamison and his family migrated to Potosi, Washington co., MO some where between 1816-1818 when their first son was born. Mr. Jamison was one of the first "petit jurors" in Washington county, MO. Mrs. Jamison was the administrator of Isaac's estate, both personal and real, on 11/18/1843. Security was given by George Edgar and Mason Frissell. The will left Lots 41, 42, 67, 19, 20, 1, & 2 in Potosi, MO along with additional plots of 142 acres an 32 acres he held.

Francis Jamison and Isaac Jamison Jr were both killed defending the Washington County Courthouse. They enlisted into Capt. Cook's Company E of the 50th Regiment.

The other Jamisons listed in Washington county, MO, Andrew, George(also known as Washington-his middle name), and James Jamison were related to the Jamisons in Harrison co., Ky. These Jamisons descend from George Jameson of Augusta co., VA(see #41311-George Jameson for additional materials).

Mr. Jameson's marriage to Browning may not be his first. Mrs. Jamison was the widow of Isaac Browning of Logan county who left her with three children: Joel, Joshua, & Elizabeth.

Andrew settled in Hopkins county, Ky for a while, but he doesn't appear in the records after 1840.

One recent thought mentioned by another researcher of this family points out that Andrew J. Jamison may have been born more likely around 1810-1826 primarily because his father's will lists Andrew last and one of the ones who needed schooling. If that is the case, then #53282, may have been the son of Robert Jamison which begs the question: Who is the Andrew Jackson Jamison born 1787 and died 1840 in Washington co., MO? In quickly researching this idea, there is in fact an Andrew J. Jamison of Harrison co., Ky who removed to Washington co., MO. This Jamison was born 1787 and died 1840, MO. The Jamisons of Harrison co., Ky were descendants of George Jamison of Augusta co., VA, whose parents, William and Sarah (Collins?) Jameson had settled in northwest Rockbridge co., VA having resided in Philadelphia previously.(See #41300 for further info.) But does this explain the Andrew J. Jamison who married Henrietta Browning in Logan co. in 1813? These two did have children shown above, tho' Andrew J. is listed as speculation.

In a suit filed May 23, 1859 brought by John Henry vs Israel Grable, Seth Howard, etal. John Howell asks the court to give John Henry clear title to land he had bought, the following relationships are given for Howell's family: Mary, widow; Seth son, John b, son; Elizabeth, daughter, wife of Presley Jamison, Nancy, daughter, wife of William Jamison. John Howell was formerly of Logan co and moved to Arkansas and died there. Mr. Howell died about 1842. The 1850 AR census listed Mary Howell as follows: Howel, Mary/60/f-5000-NC-Yell; son, Howel, John B./34/m-farmer-3000-KY-Yell; and Jameson, Mary D./12/f-AR-Yell

Mr. Jamison married October 21, 1845, Washington co., MO, Mary M. Carpenter, born December 18, 1823, Plymouth, VT, died March of 1853, Covington, KY. Mr. Jamison married second, Hannah Louise Burt, born February 16, 1825, Plymouth, VT and died June 8, 1905.

Mr. Jamison was educated as a doctor. In 1849 he went west to California and dug for gold. Returning to Booneville, MO the family removed to Covington, Ky where Marshall worked as a steamboat Captain along the Ohio River. After his wife's death he took his two sons and migrated to Ford, Iowa to be with brothers-in-law, Charles H. Carpenter and James Carpenter. As a millwright he dried his own lumber and designed furniture. Mr. Jamison married again, but there appears to be no children from this marriage. His son, Homer downed in the South River which flowed through the farm. In 1866, he "was seriously injured when loading a log on to a sled pulled by a five ox hitch. He pushed his son George out of the way and received a blow which resulted in his death after several months. (6)"

**53261-3 MINERVA JAMISON,** [Isaac, Robert], was born February 23, 1823, Washington co., MO, the daughter of Isaac and Mary (Edgar) Jamison(53212). She died November of 1900 in Potosi, MO.
