Notes:

One of Mr. Jamieson's ancestors was an heritary land steward for Mary, Queen of Scots. However, he became a Protestant and left the Royal Court. Jamieson's ancestor(unproven) was a descendant of Robert **Bruce**, King of Scotland in 1306. Mrs. Jamieson was from Elderslie, Scotland.

75010-1 REVEREND JOHN H. JAMIESON [Allen], was born 1747, Thorn Hill, Renfrew co., Scotland, the son of Allen and Miss(Wallace) Jamieson (75000). He died March 1821 at Crete, Indiana co., PA. Mr. Jamieson married 1775, Renfrew co., Scot., Agnes Nancy **Gibbs**, born 1750, Paisley, Scot., died 1841, Indiana co., PA., the daughter of John and Miss (**Jackson**) Gibbs of Paisley, Renfrew co., Scotland.

Notes:

Rev. Jamieson was born about 8 miles from Glasgow on a farm known as Thorn Hill, from a family known for its wealth and influence. He graduated at St. Andrew's University at Edinburgh studying Theology with Rev. John **Brown** of Haddington, who formulated the Westminster catechism. Rev. Jamieson was ordained in 1772. His vocation commenced at Bathgate, West Lothian co., Scotland in 1776 just after his marriage and he and his wife resided in Edinburgh for the next seven years. With a need for Ministers and clergy in the colonies, Jamieson emigrated for Philadelphia and arrived in November of 1783, joining the Associate Reformed Church. During the following year, Rev. Jamieson traveled about the Eastern seaboard from Pennsylvania to Georgia, before finally settling down September 22, 1784 at Big Springs, Cumberland co., PA. For the next eight years, he preached to his flock in a log cabin situated in the isolated region of the country. He managed to purchase 600 acres of land at Big Spring and managed the building and production of a grist mill there. In 1792, leaving his son, John Jamieson Jr., and two other children in Big Springs, he resigned his office making his way to Hannahstown, Westmoreland co., PA. He removed to Derry in 1794, organizing the Crete Church, and finally to Altmas's Run in 1796, where he built his log cabin at Conemaugh, now Black Lick, Indiana co., PA. His territory took in all of northern Westmoreland co., and all of southern Indiana co., PA. Tall for his time, six foot three inches, he was an imposing and influential figure in the region. His accomplishments were many some of which were: the contracting for the first county jail; county commissioner 1809-11; and a founding father and trustee of the Indiana Academy, Inc., on March 28, 1814. While an ordained Minister, Rev. Jamieson apparently had some reservations about his beliefs and had joined the First Associated Reformed Church in America in 1783, only to join the Second Associated Reformed Presbytery in PA. This Second Presbytery was formed in 1793 founded by Rev. Jamieson and three others-Henderson, Warwick, and Rankin, and known as the Monongahela, its boundaries from the Alleghenys to the Pacific Ocean. He was suspended on May 27, 1795 for misconstruing the actions of the Synod in referenced to Watt's ⁽¹⁾ psalms.

Rev. William **McKirahan**, whose grandfather fled the religious persecutions of Scotland, and the only one to arrive in northern Ireland of his slain family, emigrated to America settling in Washington co., PA., in 1796. Before moving on to Ohio, John McKirahan was born in PA., the father of William. Mrs. I. L. McKirahan, a daughter of Rev. J. M. **Johnston**, was a relative of Rev. John Jamieson.

Notes:

Mr. Jamieson owned 156 acres of land in Wheatfield, PA. Letters of Administration were granted to his wife, Margaret, April 10, 1813 and to James **Hamilton**. Bond was set at \$500.00 and securities by James **Brady** and Nathan **Williams** in Westmoreland co., PA. He was a farmer and shoemaker in Wheatfield, 1807.

Miss Jamieson married circa 1797, Moses **Thompson**, son of Robert and Mary (**Gordon**) Thompson of Jefferson co., PA.

75022-3 AGNES NANCY JAMIESON [John, Allen], was born circa 1780, Edinburgh, Midlothian co., Scotland, the daughter of John and Agnes (Gibbs) Jamieson (75010). She married **William Thompson**, who died 1817, Indiana co., PA., the son of Robert and Mary (**Gordon**) Thompson.

Notes:

The Thompsons were Scottish, having arrived in America from Ireland in 1716, settling in Franklin co., PA. In the year 1790, about twelve members of the family crossed over the Alleghenys to settled at Altman's Run in Indiana county. Robert Thompson died in 1802 at the age of 70 while wife, Mary, died in 1846 at the ripe age of 95. Robert and Mary Thompson had the following children: **(a)** Ruth(d. 1871, age 93, m. James **Lattimer**,(d. 1824, age 45); they res. in Young, Indiana co., PA.; **(b)** Alexander, in 1816, migrated to to Hanover, IN; **(c)** Moses,(slave owner), m.1) Jane Jamieson(#75020), m.2) Nancy **Coleman**; Adam, and William Thompson.

William Thompson was a man of some wealth and ran a distillery. His son, Judge John J. Thompson was educated in a little cabin on an adjoining farm owned by Adam **Elliott**. He excelled in surveying and civil

engineering and when his father died in 1817, he became a clerk in Blairsville, PA. He removed to Jefferson co., PA. in 1831 and established in the following year the Brookville Gazette, the pioneer newspaper for the county. It was the mouthpiece of the Democratic party and in 1833 Thomas **Reid** purchased a half interest in it. In 1843, Judge Thompson purchased Lot #681 and erected a hotel upon it. He secured a post office to it and named the place Corsica and became the post master in 1844. In 1847, he surveyed and laid out the town of Corsica where he became justice of the peace and served a variety of other positions. The lot became two lots or two blocks in the town and the main business section. In 1856, his hotel burned down. Having no insurance he and his sons rebuilt it, named it the American and then sold it and headed out to Portsmouth, Ohio and engaged in the lumbering business. Mr. and Mrs. John J. Thompson had ten children, one of whom was John Jamieson Thompson Jr.

Alexander **McKnight** was born June 9, 1810, the son of James and Jane (**McNutt**) McKnight. He married Mary Thompson May 10, 1831 and they had three children: Amor Archer, b. May 19, 1832; Nancy Jane; and William James, born May 6, 1836, Brookville, PA. Mr. McKnight died June of 1837 and Mary Thompson McKnight married December 28, 1842, John **Templeton**, Esquire and had three more children: Thomas L., Jesse J., and Oscar J. Mrs. Mary Thompson McKnight Templeton died February 22, 1860, Brookville.

Notes:

Nicholas Coleman was an early settler of Conemaugh, PA. out in Indiana co., PA. He was born in Ireland and emigrated to the colonies settling first in the Conscocheaque Valley and where he married Jane McClellan. In 1769 he settled in Conemaugh after clearing the land and erecting a cabin. But the Indians drove him out and he didn't return until seven years later where he began clearing the area again. In the meantime he returned to the Valley.
