Jamieson married about 1805-06, Scotland, Catharine	, born Scotland and died prior to 1848.

Notes:

The census records place Quinton Jamieson and his family in Scotland. A number in this family were naturalized between 1837 to the late 1800's their native origins listed as Scotland. Mr. Jamieson, himself, was naturalized October 13, 1837.

His will was dated February 19, 1848 and probated in forest co., PA on October 27, 1848. The only witness was Joseph G. **Dole**. In his will he bequeath property to sons John and Gilbert W. Jamieson; to grandsons Quinton and James Jamieson(sons of Casselles) 150 acres each of land; to son, Casselles Jamieson, son, "...all his clothing..."; to Casselle's daughter, "...all their grandmother's and Aunt Jessies clothing..."; to son, John's, daughter, Catherine, "...the red work box belonging to his daughter, Jessie...; and to son, Robert.

Robert Jamieson was residing with his brother, Casselles Jamieson according to the 1850 PA Census. He was listed at age 42, born in Scotland.

78010-2 JOHN JAMIESON, [Quinton], was born circa 1805-06 in Scotland the son of Quinton and Catharine Jamieson(78000). Mr. Jamieson was married and resided in Tionesta, Forest co., PA. where he died 1865.

Notes:

Mr. Jamieson's will was dated 1862 and probated in 1865, Forest co., PA. Letters of Administration were granted to Quinton Jamieson, his brother, who was also the guardian of his other brother's, Casselle's, children-Jennett, Wilbert W., James S., Robert S., and George W. Jamieson- who were heirs-at-law to their uncle John Jamieson. John Jamieson owned a 145 acre plot in Tionesta. He died leaving only one brother, Quinton, and one sister, Catharine B. Huddleson to survive him. Mr. Jamieson was naturalized November 24, in 1836.

78012-2 WILLIAM JAMIESON, [Quinton], was born 1807-8, Scotland, the son of Quinton and Catharine Jamieson(78000). He died some time after 1878, Tionesta, Forest co., PA. He married circa 1828-9, Forest co., PA, Ellen ______. They resided in forest co., PA.

Notes:

Mr. Jamieson was born in Scotland. He may have married Ellen in NY where their first child, Margaret, was born. But it appears William and the family returned to Scotland between the years of 1832-42, and came

back to Forest co. PA some time around 1843-46 where their last child, Syril, was born. Mr. Jamieson was naturalized August 26, 1878 in Forest co., PA. The 1850 census listed, besides himself and family, born David **Noble**, age 58, born in MA and listed as a pauper. Mr. Jamieson died intestate and hwe was the only one of his siblings not listed in his father's will.

78014-2 CASSELLE JAMIESON, [Quinton], was born 1811, Scotland, the son of Quinton and Catharine Jamieson(78000). He died about 1860, Forest co., PA. Mr. Jamieson married September 10, 1855, Jamieson Staion, Forest co., PA, Mary **Shaw**, born 1821 in Pa. They resided in Tionesta, Forest co., PA.

Notes:

Mr. Jamieson was born in Scotland and came over to America around the 1830's. The entire family seems to have settled in Forest co., PA, tho' Casselle's brother, William Jamieson, resided for a brief time in NY. The 1850 PA Census shows the family as follows:

Cassilles Jameson, 39, farmer, b. Scot; Mary S., 29(wife), b. PA; Robert, 42(brother), b. Scot; Catharine, 8, (dau), b. PA; Quinton, 7(son), b. PA; Janet, 2(dau), b. PA; William W., 1 yr, 12 mos(son), b. PA.

Mr. Jamieson was naturalized on October 6, 1856. According to the Docket information he was a native of England. Casselles Jamison, estate of, no letters of Administration issued. George, James, Janette, Robert, and Wilbur Jamieson were adopted by their uncle Quinton Jamieson.

78017-2 GILBERT W. JAMIESON, [Quinton], was born 1819, Scotland, the son of Quinton and Catharine Jamieson(78000). He died September 19, 1894 in Forest co., PA. Mr. Jamieson was married. They resided in Forest & Armstron cos. PA.

Notes:

Mr. Jamieson was listed in his father's will, but not in his brother, John's, will. Curious? He was naturalized in forest co., PA on October 5, 1860. He was also a lawyer. Mr. Sherrat was a widower with three children.

"May 11, 1872, Mr. Fred Sherrat of Oil City, Pa., married Miss Mary McCurdy, step-daughter of Gilbert Jameson, Esquire."

"Died September 18, Kate, daughter of Mr. and Mrs. Gilbert Jamison, age 17 years, 10 months, and 1 day."
